Explanatory Note

- (a) grant permission to drivers of and through passengers on road vehicles to or from the Mainland of China via Lok Ma Chau Boundary Control Point to enter or leave the Frontier Closed Area at any time, subject to the conditions specified in the Notice;
- (b) grant permission to drivers of taxis and public light buses on a scheduled service who enter or leave the Frontier Closed Area for the purpose of carrying the persons entering or leaving Lok Ma Chau Boundary Control Point, to enter or leave the Frontier Closed Area for the period beginning on 0000 hours and ending with 0630 hours each day, subject to the conditions specified in the Notice;
- (c) bring the relevant provisions of the principal Notice into conformity with the status of Hong Kong as a Special Administrative Region of the People's Republic of China; and
