Bills

First Reading

Revenue Bill 2004

The Bill was read the first time and ordered to be set down for Second Reading pursuant to Rule 53(3) of the Rules of Procedure.

Second Reading

Revenue Bill 2004

The Secretary for Financial Services and the Treasury moved the Second Reading and addressed the Council.

Question on the Second Reading proposed. The President stated that in accordance with Rule 54(4) of the Rules of Procedure, the debate was adjourned and the Bill was referred to the House Committee.

Appropriation Bill 2004

Resumption of Second Reading debate

The debate on the Second Reading which had been moved on 10 March 2004 resumed.

The Chief Secretary for Administration, the Secretary for Security, the Secretary for Housing, Planning and Lands, the Secretary for Health, Welfare and Food and the Secretary for Economic Development and Labour spoke on the motion.

The Financial Secretary replied.

Question on the Second Reading put.

Hon LEUNG Yiu-chung claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that 52 Members were present, 43 were in favour of the motion, five against it and three abstained. (Voting record in Appendix I.) Since the question was agreed by a majority of the Members present, she declared that the motion was carried.

Bill read the second time and committed to a Committee of the whole Council.

Committee Stage

The Council went into Committee and considered the Appropriation Bill 2004.

In accordance with Rule 68 of the Rules of Procedure, the Committee first considered the schedule to the Bill.

Question that the sums for heads 22 to 28, 30, 31, 35, 37, 39, 42 to 49, 51, 53, 55, 59, 60, 62, 63, 70, 72, 74, 76, 78, 79, 80, 82, 90, 91, 92, 94, 95, 96, 100, 106, 110, 112, 114, 116, 118, 120, 121, 136, 138, 142, 143, 145, 147, 148, 149, 151, 152, 155, 156, 158, 159, 160, 162, 163, 166, 168, 170, 173, 174, 180, 181, 184, 186, 188, 190 and 194 stand part of the schedule proposed, put and agreed to.

Question that head 21 stand part of the schedule proposed.

Hon CHEUNG Man-kwong moved that head 21 be reduced by \$1,900,000 in respect of subhead 000 and addressed the Committee.

Two Members and the Financial Secretary spoke on the amendment.

Hon CHEUNG Man-kwong spoke again.

Question on the amendment put.

Hon CHEUNG Man-kwong claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 26 were present, five were in favour of the amendment and 21 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 27 were present, 13 were in favour of the amendment and 13 against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Question that the sum for head 21 stand part of the schedule proposed, put and agreed to.

Question that head 122 stand part of the schedule proposed.

Hon James TO moved that head 122 be reduced by \$55,500,000 in respect of subhead 000 and addressed the Committee.

Four Members spoke on the amendment.

Two Members who had spoken spoke again.

Another Member and the Secretary for Security spoke on the amendment.

Hon James TO spoke again.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 26 were present, four were in favour of the amendment and 22 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 27 were present, 13 were in favour of the amendment and 13 against it. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions being claimed in respect of the clauses, the schedule or remaining amendments to the schedule of the Appropriation Bill 2004, the Committee do proceed to each of such divisions immediately after the division bell has rung for one minute.

Question on the motion proposed.

One Member spoke on the motion.

Question on the motion put.

Hon Emily LAU claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 27 were present, 22 were in favour of the motion and five against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 27 were present, 12 were in favour of the motion and 14 against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.

Hon James TO moved that head 122 be reduced by \$80,000,000 in respect of subhead 103 and addressed the Committee.

One Member spoke on the amendment.

Hon James TO elucidated on some points he had made earlier which had been misunderstood.

Another Member and the Secretary for Security spoke on the amendment.

Hon James TO spoke again.

Question on the amendment put.

Hon James TO claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 25 were present, four were in favour of the amendment and 21 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 28 were present, 14 were in favour of the amendment and 13 against it. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Question that the sum for head 122 stand part of the schedule proposed, put and agreed to.

Question that head 144 stand part of the schedule proposed.

Hon CHEUNG Man-kwong moved that head 144 be reduced by \$3,232,000 in respect of subhead 000 and addressed the Committee.

While Hon CHEUNG Man-kwong was addressing the Committee, the Chairman left the chair at 6:05 pm temporarily and the Chairman's Deputy, Hon Miriam LAU, took the chair.

Two Members and Hon Frederick FUNG spoke on the amendment.

At 6:28 pm, while Hon Frederick FUNG was speaking, the Chairman resumed the chair.

Another nine Members and the Secretary for Constitutional Affairs spoke on the amendment.

The Secretary for Justice spoke in response to the remarks made earlier by some Members in their speeches.

Hon CHEUNG Man-kwong spoke again.

Question on the amendment put.

Hon CHEUNG Man-kwong claimed a division. The Chairman then ordered the Committee to divide under Rule 47(1) of the Rules of Procedure.

The Chairman announced that among the Members returned by functional constituencies, 26 were present, three were in favour of the amendment, 22 against it and one abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 27 were present, 14 were in favour of the amendment and 12 against it. (Voting record in Appendix VI.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Question that the sum for head 144 stand part of the schedule proposed, put and agreed to.

Question that the schedule stand part of the Bill put and agreed to.

Question that clauses 1 and 2 stand part of the Bill proposed, put and agreed to.

The Council then resumed.

Third Reading

The Financial Secretary reported that

the Appropriation Bill 2004

had passed through the Committee without amendment. He moved that the Bill be read the third time and do pass.

Question on the Third Reading proposed, put and agreed to.

Bill read the third time and passed.
