1. Hon James TIEN asked Question 1.

The Financial Secretary replied.

Seven Members asked supplementaries and the Financial Secretary replied.

2. Hon Frederick FUNG asked Question 2.

The Secretary for Housing, Planning and Lands replied.

Five Members asked supplementaries and the Secretary for Housing, Planning and Lands replied.

3. Hon LAU Wong-fat asked Question 3.

The Secretary for Education and Manpower replied.

Five Members asked supplementaries and the Secretary for Education and Manpower replied.

4. Hon WONG Sing-chi asked Question 4.

The Secretary for Housing, Planning and Lands replied.

Four Members asked supplementaries and the Secretary for Housing, Planning and Lands replied.

5. Hon Emily LAU asked Question 5.

The Secretary for Constitutional Affairs replied.

One Member asked a supplementary and the Secretary for Constitutional Affairs replied.

Hon NG Leung-sing asked a supplementary.

With the President's permission, Hon Emily LAU clarified a point concerning her bank deposits as mentioned by Hon NG Leung-sing in his supplementary.

Hon James TO raised a point of order on whether, in the light of Hon Emily LAU's clarification, Hon NG Leung-sing should be asked to revise his supplementary.

The President ruled that the point was brought up as an illustration only and did not affect the substance of the supplementary.

With the President's permission, Hon NG Leung-sing clarified that he had learnt of Hon Emily LAU's bank deposits from a media report and he had mentioned it for illustration purpose only.

Hon Emily LAU raised a point of order on whether Hon NG Leung-sing should have mentioned the matter again, in the light of her earlier clarification. Hon James TO asked if Hon NG Leung-sing should provide substantiation with regard to the press report, as Members were required to do so when submitting questions for the President's approval.

The President stated that she had all along permitted Members to quote media reports in asking supplementaries without requiring them to provide substantiation, since time did not allow it. As Hon Emily LAU had already clarified, she regarded that the issue was settled.

Hon Emily LAU asked the President to consider if Hon NG Leung-sing should be directed to withdraw the relevant part of his speech. The President ruled that she would leave it to Hon NG Leung-sing.

Hon NG Leung-sing said that he would abide by the President's ruling.

The Secretary for Constitutional Affairs replied to the supplementary.

Another four Members asked supplementaries and the Secretary for Constitutional Affairs replied.

6. Hon Michael MAK asked Question 6.

The Secretary for Financial Services and the Treasury replied.

Six Members asked supplementaries and the Secretary for Financial Services and the Treasury replied.

Written replies to Questions 7 to 19 were tabled for Members' information.

<u>Motions</u>

Proposed resolution under the Loans Ordinance

The Financial Secretary moved the following motion and addressed the Council:

Resolved, in the exercise of the powers conferred by section 3(1) of the Loans Ordinance, that the Government be authorized to borrow, for the purposes of the Capital Works Reserve Fund established by resolutions passed under section 29 of the Public Finance Ordinance (Cap. 2), a sum or sums not exceeding in total \$20 billion or equivalent.

Question on the motion proposed.

Hon SIN Chung-kai spoke on the motion as Chairman of the Subcommittee on proposed resolution under section 3(1) of the Loans Ordinance, and then in his personal capacity as a Member.

Three Members spoke on the motion.

The Financial Secretary replied.

Question on the motion put and agreed to.

Members' Motions

<u>Anti-gambling</u>

Dr Hon TANG Siu-tong moved the following motion and addressed the Council:

That, as the forthcoming UEFA European Championship finals are likely to attract more people, particularly young people, to participate in football betting, this Council urges that the in addition to strengthening its should, Administration efforts in combating illegal gambling, immediately collaborate with relevant bodies and organizations to step up publicity and education, and formulate other long-term measures to foster an anti-gambling culture and prevent people from indulging in gambling; at the same time, the Administration should also allocate more resources to enhance the counselling and treatment services for problem and pathological gamblers and their families.

While Dr Hon TANG Siu-tong was addressing the Council, the President left the chair at 5:36 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Dr Hon TANG Siu-tong's motion proposed.

The President's Deputy stated that Hon Andrew CHENG and Hon Tommy CHEUNG would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the two amendments would be debated together in a joint debate.

Hon Andrew CHENG and Hon Tommy CHEUNG spoke respectively on the motion and their amendments.

Six Members spoke on the motion and the amendments.

Dr Hon TANG Siu-tong spoke on the amendments.

At 6:44 pm, while Dr Hon TANG Siu-tong was speaking, the President resumed the chair.

The Secretary for Home Affairs spoke on the motion and the amendments.

Hon Andrew CHENG moved the following amendment to Dr Hon TANG Siu-tong's motion:

To add ", including specifying in the Betting Duty Ordinance the types of football matches on which bets may be accepted by the licensed operator and requiring, through administrative measures, that in future any new football betting options may only be introduced after the consent of the Panel on Home Affairs of this Council and the Football Betting and Lotteries Commission has been obtained, so as" after "long-term measures".

Question on Hon Andrew CHENG's amendment to Dr Hon TANG Siutong's motion proposed and put.

Hon Andrew CHENG claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 24 were present, six were in favour of the amendment, 10 against it and eight abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 28 were present, 15 were in favour of the amendment and 12 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion or amendments thereto on Anti-gambling, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

Hon Tommy CHEUNG moved the following amendment to Dr Hon TANG Siu-tong's motion:

To delete "an anti-gambling" after "long-term measures to foster" and substitute with "a"; to add "that is conducive to regulating gambling" after "culture"; to add "review the operation of the Ping Wo Fund, optimize the use of existing resources and" after "the Administration should also"; and to add "as necessary" after "allocate more resources".

Question on Hon Tommy CHEUNG's amendment to Dr Hon TANG Siutong's motion proposed and put.

Hon Tommy CHEUNG claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, nine were in favour of the amendment, 15 against it and one abstained; while amonq the Members returned by qeoqraphical constituencies through direct elections and by the Election Committee, 28 were present, one was in favour of the amendment and 26 against it. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Dr Hon TANG Siu-tong replied.

Question on Dr Hon TANG Siu-tong's motion put.

Hon Mrs Selina CHOW claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, 17 were in favour of the motion and eight abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 29 were present and 28 were in favour of the motion. (Voting record in Appendix III.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion was carried.

<u>Regretting the decision of the Standing Committee of the</u> <u>National People's Congress to rule out universal suffrage in</u> <u>the years 2007 and 2008</u>

Hon Albert HO moved the following motion and addressed the Council:

That, in view of the objection of the people of Hong Kong at large to the decision of the Standing Committee of the

National People's Congress ("NPCSC") to rule out flatly the selection of the Chief Executive by universal suffrage in the year 2007 and the election of all the Members of the Legislative Council ("LegCo") by universal suffrage in the year 2008 in Hong Kong, and to maintain the existing ratio between LegCo Members returned by functional constituencies and Members returned by geographical constituencies through direct elections, as well as the procedures of separate voting on bills and motions introduced by individual Members, this Council considers that the decision of NPCSC completely ignores Hong Kong people's general aspirations for democracy; this Council expresses regret about and dissatisfaction with such decision, and calls upon the people of Hong Kong to continue striving for democracy with all might and never give up.

Question on Hon Albert HO's motion proposed.

The President stated that Hon LEUNG Yiu-chung would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon LEUNG Yiu-chung moved the following amendment to Hon Albert HO's motion and addressed the Council:

To delete "; this Council" after "general aspirations for democracy" and substitute with "and"; and to add "; this Council urges the Chief Executive to request the State Council to propose to NPCSC the withdrawal of the above decision" after "dissatisfaction with such decision".

Question on Hon LEUNG Yiu-chung's amendment to Hon Albert HO's motion proposed.

The Secretary for Justice and 35 Members spoke on the motion and the amendment.

Hon Albert HO spoke on the amendment.

The Secretary for Constitutional Affairs spoke on the motion and the amendment.

While he was speaking, Hon Andrew WONG sought elucidation of a point raised in the Secretary for Constitutional Affairs's speech. The Secretary for Constitutional Affairs elucidated and continued with his speech.

Question on Hon LEUNG Yiu-chung's amendment to Hon Albert HO's motion put.

Hon LEUNG Yiu-chung claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, four were in favour of the amendment and 21 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 29 were present, 17 were in favour of the amendment and 11 against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Albert HO replied.

Question on Hon Albert HO's motion put.

Hon Albert HO claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 25 were present, four were in favour of the motion and 21 against it; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 29 were present, 17 were in favour of the motion and 11 against it. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.
