Motions

<u>Proposed resolution under the Mutual Legal Assistance in Criminal Matters Ordinance</u>

1. Mutual Legal Assistance in Criminal Matters (Ukraine) Order

The Secretary for Security moved the following motion and addressed the Council:

Resolved that the Mutual Legal Assistance in Criminal Matters (Ukraine) Order, made by the Chief Executive in Council on 9 December 2003, be approved.

Question on the motion proposed.

Hon James TO, Chairman of the Subcommittee on Mutual Legal Assistance in Criminal Matters (Ukraine) Order and Mutual Legal Assistance in Criminal Matters (Singapore) Order, spoke on the motion.

Question on the motion put and agreed to.

2. Mutual Legal Assistance in Criminal Matters (Singapore) Order

The Secretary for Security moved the following motion and addressed the Council:

Resolved that the Mutual Legal Assistance in Criminal Matters (Singapore) Order, made by the Chief Executive in Council on 9 December 2003, be approved.

Question on the motion proposed, put and agreed to.

<u>Members' Motions</u>

<u>Urging the Government to defend freedom of the press and freedom of speech</u>

Hon Albert CHAN moved the following motion and addressed the Council:

That, as hosts of personal-view programmes have recently successively told the media that they are under pressure, and individual hosts have even taken themselves off the air, this Council expresses grave concern about this and is worried that freedom of the press and freedom of speech in Hong Kong are at stake; this Council urges the Government to take measures to defend such freedoms.

While Hon Albert CHAN was addressing the Council, the President left the chair at 4:46 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon Albert CHAN's motion proposed.

The President's Deputy stated that Hon LAU Kong-wah would move an amendment to the motion and that Hon Andrew CHENG and Hon Tommy CHEUNG would each move an amendment to Hon LAU Kong-wah's amendment. In accordance with the Rules of Procedure, the motion, the amendment and the amendments to the amendment would be debated together in a joint debate.

Hon LAU Kong-wah moved the following amendment to Hon Albert CHAN's motion and addressed the Council:

To delete "this Council expresses grave concern about this and is" after "individual hosts have even taken themselves off the air," and substitute with "and some members of the public are"; to delete ";" after "at stake" and substitute with ","; to add "expresses grave concern about this and" after "this Council"; to add "expeditiously find out the truth of these incidents and" after "urges the Government to"; and to add "to keep ensuring that members of the media are free from threats of violence, so as" after "take measures".

Question on Hon LAU Kong-wah's amendment to Hon Albert CHAN's motion proposed.

Hon Andrew CHENG and Hon Tommy CHEUNG spoke on the motion and the amendments.

14 Members and Hon Abraham SHEK spoke on the motion and the amendments.

At 6:52 pm, while Hon Abraham SHEK was speaking, the President resumed the chair.

Another five Members spoke on the motion and the amendments.

Hon Albert CHAN spoke on the amendments.

While Hon Albert CHAN was speaking, Hon TSANG Yok-sing pointed out that Hon Albert CHAN had in his speech mentioned Members who had not spoken in the debate, including himself. As such,

he sought the President's permission for him to respond after Mr CHAN had spoken.

The President stated that in line with the normal practice, she would allow Members who had not spoken to speak on any new points raised by other Members, or to respond where their names had been mentioned by other Members.

Hon Albert CHAN continued to speak on the amendments.

Hon TSANG Yok-sing spoke in response to Hon Albert CHAN's speech.

Hon Albert HO, who had not spoken earlier, sought the President's permission for him to speak on some points raised by Hon TSANG Yok-sing.

The President suspended the meeting at 7:40 pm.

The Council resumed at 8:15 pm.

The President stated that in a joint debate on a motion and its amendments, when the mover of the motion was invited to speak on the amendments, it was the practice for him to speak on the contents on the amendments only. However, on this occasion, Hon Albert CHAN, the mover of the motion, had deviated from the practice when speaking on the amendment and had mentioned other Member's name. As such, she had allowed Hon TSANG Yok-sing to respond. Yet Mr TSANG's speech had prompted Hon Albert HO's request to speak. The President ruled that Hon Albert HO might speak this time, as the Rules of Procedure did not prohibit Members from speaking in such However, she urged Members to respect the circumstances. Council's established practice so as to ensure the smooth conduct of debates.

Hon Albert HO spoke in response to Hon TSANG Yok-sing's speech.

Hon CHAN Kam-lam, who had not spoken, spoke in response to Hon Albert HO's speech.

The Secretary for Security and the Secretary for Home Affairs spoke on the motion and the amendments.

Hon Andrew CHENG moved the following amendment to Hon LAU Kong-wah's amendment:

To delete "some members of" after "off the air, and"; to add "at large" after "the public"; to delete "keep ensuring" after "take measures to" and substitute with "ensure"; to add "and their families" after "members of the media"; and to add "harassment and" after "are free from".

Question on Hon Andrew CHENG's amendment to Hon LAU Kong-wah's amendment proposed and put.

Hon Andrew CHENG claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 20 were present, 18 were in favour of the amendment and two abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 26 were present, 17 were in favour of the amendment and eight abstained. (Voting record in the Appendix.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that Hon Andrew CHENG's amendment was agreed.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion or amendments thereto on urging the Government to defend freedom of the press and freedom of speech, the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

The President stated that as Hon Andrew CHENG's amendment had been agreed, she granted leave for Hon Tommy CHEUNG to revise the terms of his amendment and explain them to the Council.

Hon Tommy CHEUNG moved the following revised amendment to Hon LAU Kong-wah's amendment as amended by Hon Andrew CHENG and explained the revised terms of his amendment to the Council:

To add "and to smooth out the public's worries" after "threats of violence".

Question on Hon Tommy CHEUNG's amendment to Hon LAU Kong-wah's amendment as amended by Hon Andrew CHENG proposed, put and agreed to.

Question on Hon LAU Kong-wah's amendment as amended by Hon Andrew CHENG and Hon Tommy CHEUNG to Hon Albert CHAN's motion put and agreed to.

Hon Albert CHAN replied.

With the President's permission, Hon CHAN Kam-lam elucidated on a point he had made earlier which had been misunderstood by Hon Albert CHAN.

Hon CHEUNG Man-kwong sought elucidation on the remarks made by Hon CHAN Kam-lam and Hon CHAN Kam-lam, with the President's permission, elucidated.

Question on Hon Albert CHAN's motion as amended by Hon LAU Kong Wah, Hon Andrew CHENG and Hon Tommy CHEUNG put and agreed to.

<u>Safeguarding the rights and benefits of public servants and staff of outsourced government services</u>

Hon LEUNG Fu-wah moved the following motion and addressed the Council:

That, as the largest employer in Hong Kong, the Government of the Special Administrative Region should set an example of a good employer to ensure that all employees of the Government and subvented organizations as well as contract staff of outsourced government services are under reasonable labour protection; to this end, this Council urges the Government to:

- (a) strictly enforce the requirements of the Basic Law concerning protection of the rights and benefits of public servants;
- (b) safeguard the rights and benefits of public servants newly recruited after 1 June 2000 in accordance with the principles of fair and reasonable treatment;
- (c) draw up a reasonable and appropriate public servants
 establishment;
- (d) enhance the protection for contract staff employed on non-civil service contract terms and staff of subvented organizations in regard to their posts, pay and benefits; and
- (e) strictly monitor government contractors to ensure that they adopt the average wages of similar trades published in the Census and Statistics Department's Quarterly Report of Wages and Payroll Statistics as the standard of minimum allowable wage for non-skilled workers involved in outsourced government services, and fully enforce this requirement.

Question on Hon LEUNG Fu-wah's motion proposed.

The President stated that Hon Andrew CHENG would move an amendment to the motion. In accordance with the Rules of Procedure, the motion and the amendment would be debated together in a joint debate.

Hon Andrew CHENG moved the following amendment to Hon LEUNG Fu-wah's motion and addressed the Council:

To add "and to extend it to the outsourced services contracts of public organizations and public corporations" after "and fully enforce this requirement".

Question on Hon Andrew CHENG's amendment to Hon LEUNG Fu-wah's motion proposed.

Five Members spoke on the motion and the amendment.

Hon Michael MAK declared his interest as an employee of the Hospital Authority and spoke on the motion and the amendment.

Another three Members spoke on the motion and the amendment.

Hon LEUNG Fu-wah spoke on the amendment.

The Secretary for the Civil Service and the Secretary for Financial Services and the Treasury spoke on the motion and the amendment.

Question on Hon Andrew CHENG's amendment to Hon LEUNG Fu-wah's motion put and agreed to.

Hon LEUNG Fu-wah replied.

Question on Hon LEUNG Fu-wah's motion as amended by Hon Andrew CHENG put and agreed to.
