Planning Standards for Public Hospitals

I refer to your letter of 11 May 2004, seeking our comments on a list of follow-up actions. I write to provide information on the planning standards for public hospitals in Hong Kong and those adopted in selected developed countries. Please refer to item 4 "Redevelopment of Caritas Medical Centre, Phase 2" of the list.

The planning standards for public hospitals in Hong Kong and those adopted in the United Kingdom and United States of America, and recommendations by the Centre for Disease Control and Prevention (CDC) and the World Health Organization (WHO) are detailed in the table below:-

| | Area per bed | Spacing between beds |
|--------------------------|------------------------|----------------------|
| Hong Kong | 6.5m ² /bed | 1.2m ~ 1.4m |
| United Kingdom | 8.4m ² /bed | 1.7m ~ 1.9 m |
| United States of America | 9.3m ² /bed | 2.0m ~ 2.2m |
| CDC recommendation | No recommendation | 3 ft. (~0.9m) |
| WHO recommendation | No recommendation | 1m |

The CDC and WHO's recommendations of a minimum bed spacing of 3 feet and 1 metre respectively are based on considerations of reducing the risk of cross-infection by droplet transmission. We understand that the planning standards of other developed countries have taken patient privacy into consideration.
