# List of Follow-up Items Tendering System for Pharmaceutical Products

I am writing to respond to the query raised by the Hon TANG Siutong at the meeting on 19 April 2004 regarding the procurement of Pharmaceutical products by the Government Logistics Department (GLD) on behalf of the Hospital Authority (HA).

2. Under the Pharmacy and Poisons Regulation (Cap 138A), medicines must be registered with the Pharmacy and Poisons Board before they can be supplied for use in Hong Kong. Registration of the drug in Hong Kong is an essential but not the only requirement for purpose of procuring drugs for use in public hospitals. In respect of off-patent drugs, the HA follows the "Drug Purchasing Guidelines of the Public Health Service of Hong Kong on Multisource (Generic) Pharmaceutical Products" drawn up by the Drug Selection Committee of the Department of Health. The Guidelines stipulate among other things that for pharmaceutical products manufactured outside Hong Kong, the tenderer should be required to produce, apart from the Certificate of Drug/Product Registration issued by the Pharmacy and Poisons Board of Hong Kong, the Marketing Authorisation issued by the national control authority of a member country of the International Conference on

Harmonisation of Technical Requirements for Registration of Pharmaceuticals for Human Use, or from the national control authority of the People's Republic of China, Australia or Canada. These guidelines have been built into the terms and conditions of the tender for drug procurement to provide added assurance of the quality, safety and efficacy of the drugs used in public hospitals.
