# I. Election of Chairman and Deputy Chairman for the 2003-2004 session

# Election of Chairman

<u>Mr LAU Chin-shek</u> called for nominations for the chairmanship of the Panel for the 2003-2004 session.

2. Mr LAU Chin-shek was nominated by <u>Mr Andrew CHENG</u> and the nomination was seconded by Ms Cyd HO and Ms LI Fung-ying. <u>Mr LAU</u> <u>Chin-shek</u> accepted the nomination.

3. <u>Ms Cyd HO</u>, the member who had the highest precedence amongst members present, then presided over the election of the Chairman of the Panel. There being no other nomination, <u>Ms Cyd HO</u> declared Mr LAU Chin-shek elected as Chairman of the Panel. Mr LAU Chin-shek then took the chair.

#### Election of Deputy Chairman

4. <u>The Chairman</u> called for nominations for the deputy chairmanship of the Panel for the 2003-2004 session.

5. Mr CHAN Kwok-keung was nominated by Ms LI Fung-ying and seconded by Mr LEUNG Fu-wah. <u>The Chairman</u> informed the meeting that Mr CHAN Kwok-keung was unable to attend the meeting and had already indicated his acceptance of the nomination for the deputy chairmanship. There being no other nomination, <u>the Chairman</u> declared Mr CHAN Kwok-keung elected as Deputy Chairman of the Panel.
