Action

I Election of Chairman

<u>Ms Miriam LAU</u>, Chairman of the Subcommittee in office, invited nominations for the chairmanship. <u>Mr LAU Kong-wah</u> nominated Ms Miriam LAU and the nomination was seconded by <u>Mr TAM Yiu-chung and Mr LEUNG Fu-wah</u>. <u>Ms LAU</u> accepted the nomination.

2. Mr CHAN Kwok-keung, who had the highest precedence amongst Subcommittee members present at the meeting, took over the chair and presided over the election of Chairman. There being no other nominations, <u>Ms Miriam LAU</u> was declared Chairman of the Subcommittee.

At the suggestion of Mr Albert CHAN, <u>members</u> agreed that the Administration and the Kowloon-Canton Railway Corporation should be requested to brief members about the latest position of the West Rail project as well as the arrangements to be made for its commissioning. In this connection, <u>the Chairman</u> reminded members that the Transport Panel would conduct a site visit to WR on Thursday, 30 October 2003.
