Probation of Offenders Ordinance (Chapter 298)

Probation of Offenders (Approved Institution) (Amendment) Order 2004

INTRODUCTION

At the meeting of the Executive Council on 11 May 2004, the Council ADVISED and the Chief Executive ORDERED that the Probation of Offenders (Approved Institution) (Amendment) Order 2004, at Annex A, should be made under section 11 of the Probation of Offenders Ordinance (the Ordinance)(Cap.298) to remove the Kwun Tong Probation Hostel (KTPH) from the list of approved institutions.

JUSTIFICATIONS

Probation of Offenders Ordinance

2. Section 3(1) of the Ordinance provides that a probation order may be made by the Court to require a convicted person to be under the supervision of a probation officer for a period of one to three years. Section 3(3) of the Ordinance further provides that an offender may be required by a probation order to reside in an 'approved institution' for a period of not more than 12 months from the date of the order.

3. Under section 11 of the Ordinance, the Chief Executive may by order approve premises for the reception of persons who may be required to reside therein by a probation order, and 'approved institutions' is defined in section 2 to mean such premises. Three premises are currently designated as approved institutions under the Probation of Offenders (Approved Institution)(Consolidation) Order (the Order) (Cap.298 sub. leg. B). They are KTPH, Fanling Girls' Home and Shatin Boys' Home.

Kwun Tong Probation Hostel

4. KTPH, operated by the Social Welfare Department (SWD) with 21 staff, has a capacity of 60 places for male probationers aged 15 to under 21. It provides residential services to the probationers with daily living care and supervision, employment guidance and emotional support in social rehabilitation. It is an "open" hostel whereby

probationers are allowed to go outside to work or study during the daytime.

5. KTPH has an average enrolment rate of 80% over the past four years¹. The majority of residents are unemployed working youth aged between 16 and 18. Given their young age and lack of work skills or experience, coupled with the recent economic restructuring, the young offenders face much difficulty in securing steady job placements. With a view to assisting their re-integration into the society upon discharge, it is important to give them practical assistance by strengthening their job-related skills and helping them overcome the limitations in starting and maintaining a work life. However, due to physical limitations, it is not feasible to provide more comprehensive services in KTPH for enriching the probationers' job-related skills. SWD is not best placed to secure job opportunities for them either.

6. The percentage of cases which had satisfactorily completed the periods of residential training stipulated by the Court in KTPH were 72%, 67% and 79% respectively for 1999-00, 2000-01 and 2001-02. The rate, however, fell to as low as 58% in 2002-03. Of those who had satisfactorily completed the period of residence, a rising percentage of them (from 3% in 1999-2000 to 17% in 2002-03²) were unable to secure school or job placement upon discharge. The results are less than satisfactory and necessitate a review on the effectiveness of KTPH's services.

Review on the Service Provision of KTPH

7. After a critical review of the effectiveness of KTPH, SWD considers that KTPH's services should be dispersed to the non-governmental sector, which is providing residential services and employment assistance to young offenders similar to those of KTPH. Having carefully assessed the individual merits of all existing non-governmental organizations (NGOs) providing residential services for young male with behavioural or emotional problems, it is considered that Youth Outreach (YO) is best placed to take over the service of KTPH. YO has already in place a series of comprehensive employment programmes to provide employment support and actual job opportunities to the young probationers. It possesses the necessary experience and facilities for service expansion, and they would be able to enhance the services for the relevant probationers.

² The re-integration rate of discharged cases of KTPH (which is defined as the ratio of the discharged residents who are able to secure school placements, training courses or job placements upon discharge to the total number of residents who have completed the training programmes in KTPH) in recent years were :

2001-02	93%
2002-03	83%

8. In the light of the above and having sought the agreement of YO to absorb KTPH's services with net recurrent savings on SWD, we have ceased new admission to KTPH since January 2004 with a view to closing the hostel by end June 2004.

Proposal

9. With the planned closure of KTPH, we would need to introduce legislative amendments to remove it from the list of approved institutions under the Ordinance.

THE ORDER

10. Probation of Offenders (Approved Institution) (Amendment) Order 2004 at Annex A seeks to remove KTPH from the list of approved institutions specified for the purposes of the Ordinance.

11. The current version of the Order is at Annex B.

IMPLICATIONS OF THE PROPOSAL

13. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. It has no economic, productivity or environmental implications. A full sustainability assessment is considered not applicable as the proposed Amendment Order is technical in nature. The proposal would not affect the current binding effect of the Probation of Offenders Ordinance and its subsidiary legislation.

14. The financial and civil service implications of the closure of KTPH are set out at Annex C.

PUBLIC CONSULTATION

15. As the proposal will enhance the services to young probationers, we do not consider it necessary to consult the public on the proposal.

PUBLICITY

16. A press release will be issued on 19 May 2004. A spokesman will also be

available to answer media enquiries.

Annex C

Financial and Civil Service Implications

The closure of KTPH would result in estimated recurrent savings of \$6.86 million, to be offset by an increased annual subvention of \$1.25 million to YO to absorb the services of KTPH. The proposal to remove KTPH from the list of approved institutions under the Probation of Offenders Ordinance would not incur additional expenditure.

2. There is no staff redundancy as all staff originally working in KTPH will be redeployed to other service units to perform other duties as required by the department. Hence, some staff cost savings cannot be realized immediately.
