

L.N. 204 of 2003**PUBLIC HEALTH AND MUNICIPAL SERVICES ORDINANCE
(PUBLIC PLEASURE GROUNDS) (AMENDMENT OF
FOURTH SCHEDULE) (NO. 3) ORDER 2003**

(Made under section 106(1) and (6) of the Public Health
and Municipal Services Ordinance (Cap. 132))

**1. Places set aside for use as
public pleasure grounds**

The places specified in Schedule 1 are set aside for use as public pleasure grounds.

**2. Places ceasing to be set aside for
use as public pleasure grounds**

The places specified in Schedule 2 cease to be set aside for use as public pleasure grounds.

3. Public pleasure grounds

The Fourth Schedule to the Public Health and Municipal Services Ordinance (Cap. 132) is amended—

(a) in the list of public pleasure grounds (other than bathing beaches) under the heading “The New Territories”, by repealing—

“Wai Man Road Rest Garden”

and substituting—

“Sai Kung Waterfront Park”;

(b) to the extent specified in Schedule 3.
