Dear Sir,

Now that I am back in Hong Kong from a trip to a remote part of China, I understand that there were press reports relating to my role in Henderson Land Development Co. Ltd.'s (HLD) bid for the West Kowloon Cultural District (WKCD).

## I would like to point out that:

- A) To the best of my knowledge and to date Henderson Land Development Co. Ltd. (HLD), a publicly-listed company, owns approximately 73.48% of Henderson Investment Ltd. (HI) which is also a publicly-listed company. HI in turn owns to the best of my knowledge and to date around 31.33% of Hong Kong Ferry (Holdings) Co. Ltd (HKF). HKF is therefore not a subsidiary (附屬公司) of HLD. HLD does not hold a majority shareholding interest in HKF and is not the parent company of HKF. I shall be grateful if Honourable Members can note the legal position.
- B) The Government, especially the Chief Secretary, the Hon. Donald Tsang GBS JP, has repeatedly told the Legislative Council and the public that the West Kowloon Cultural District project WKCD is a cultural project. It is a mega project for which, to my knowledge, HLD has employed over 30 local and overseas consultancy firms, each specialising in different areas of work, such as planning, architecture, mechanical/electrical engineering, structural engineering, water design, museum curatorial work, culture and arts, etc.



HKF is just one of these consultants, focusing only on the broad culture and arts aspects.

C) As regards my involvement I would like to refer Honourable Members to the press releases issued by HKF on 9 and 15 November 2004 (copies of which are attached for easy reference). To reiterate, I am an employee of HKF. I work on assignments within the scope of work as approved by the Hong Kong Government in March 2004. In respect of the WKCD project, HKF and I only provide advice on cultural and arts aspects. HKF and I have no involvement, and I shall not have any involvement, in any property-related issues of WKCD whatsoever. In view of and provided that the work conducted by me and HKF is ring-fenced within the parameters of the Government's approval, and in particular, does not relate to land/property matters, the legal advice I was given is that my work falls within Government's approval dated 29 March 2004. As regards cultural work, I left my post of Director of Urban services and was transferred to another Government department in August 1999. In the five years since August 1999 and before my retirement from active Government service in November 2003, I have never (repeat, never) participated in any arts or cultural activities (or work) on behalf of the Government. So the "sanitation period" requirement for me to undertake cultural work has been satisfied more than adequately. The cultural aspects of WKCD is just one of the many work assignments which I have done for HKF, which work includes, travel, hotel, recreational services, batching plants, liaison with District Councils etc.

I should be grateful if you can let Honourable Members know about the exact legal and factual position. If they have other questions, please do not hesitate to let me know.

Ltd. is just one of these consultants, focusing only on the culture and arts aspects.
- (3) Ms. Chung left her post of Director of Urban Services and was transferred to another department in August 1999. In the many years ensuing, she has not participated in any arts or cultural activities on behalf of the Government.
