Our attention has been drawn to a letter dated 7 December 2004 to you from the Construction Industry Training Authority Staff Association.

In paragraph 5 the Association referred to an "unreasonable dismissal of an employee" and said that the Authority had sent a lawyer's letter to the Association to "suppress the reasonable action of the Association" in connection with such dismissal.

This is a misrepresentation of what happened. We should like to put the record straight by sending you a copy of the letter which our solicitors sent to the Staff Association on 28 October 2004.

Please note that the Association had made and publicized defamatory attacks on individuals and that such attacks could not be described as "reasonable action" nor could the Authority's demand for a withdrawal and apology be called an attempt to "suppress" the Association's actions.

The Association had not responded to the Authority's reasonable demand and the matter will be pursued by the Authority.
