I Election of Chairman and Deputy Chairman

Election of Chairman

Dr David LI, the member who had the highest precedence in the Council among all members of the Bills Committee present, presided over the election of the Chairman of the Bills Committee. He invited nominations for the chairmanship of the Bills Committee.

2. Mr Albert CHENG was nominated by Mr SIN Chung-kai and seconded by Ms Audrey EU. Mr Albert CHENG accepted the nomination.
