Administration's response to issues raised at the Meeting of the Bills Committee on Merchant Shipping (Local Vessels and Miscellaneous Amendments) Bill 2005 held on 28 June 2005

We set out below the Administration's response to a number of issues raised at the last Bills Committee meeting.

Number of registered professional engineers (RPE)

2. At the meeting, members of the Bills Committee asked for the number of RPEs qualified for authorization by the Director of Marine (D of M) under section 7 of the Merchant Shipping (Local Vessels) Ordinance (Ordinance). There are about 110 RPEs in the Marine and Naval Architecture discipline under the Engineers Registration Board. They are qualified for obtaining D of M's authorization under section 7 of the Ordinance.

Imposition of conditions of authorization/recognition by D of M

3. In view of Members' concern on how D of M might exercise the powers to authorize RPEs under section 7 of the Ordinance and to recognize government authorities under the proposed new section 7A, we propose to set out in these two sections the relevant factors to be considered by D of M (such as competency and experience) in attaching conditions to the authorization/recognition. The relevant CSAs are under preparation and will be provided to Members for consideration when ready.

Marine accidents involving third party in the past five years

- 4. In response to the letter from Hon Wong Yung-kan of 23 June 2005, the number of accidents and casualties of marine accidents involving death or injuries of persons are set out at **Annex**.
- 5. Since the operators of vessels to which the compulsory third party risk insurance requirement will apply have no obligation to provide the Administration with information on matters relating to claims and compensation, we do not possess such information.
