 - (d) to provide information on the respective numbers of Hong Kong Special Administrative Region (HKSAR) residents serving sentences in MSAR and MSAR residents serving sentences in HKSAR, and the lengths of such sentences;
 - (e) to advise on the time taken for the Central People's Government to reply to a notification from HKSAR of the request for transfer of a sentenced person between HKSAR and other jurisdictions; and
 - (f) to explain the meaning of the term "close ties" in the Bill, whether the term was found in other local legislation and the procedures relating to the establishment of "close ties".
