## **I. Meeting with the Administration**

After discussing the Administration's response to issues raised at the last meeting and completing clause-by-clause examination of the Aviation Security (Amendment) Bill 2005 (the Bill), the Chairman concluded that the Bills Committee had concluded its deliberations on the Bill. The meeting originally scheduled for 14 June 2005 would be cancelled.
3. The Administration indicated its intention to resume the Second Reading debate on the Bill at the Council meeting on 29 June 2005.
4. The Bills Committee noted that a written report would be made to the House Committee on 10 June 2005. If the Second Reading debate on the Bill was to resume on 29 June 2005, the deadline for giving notice of Committee Stage amendments to the Bill would be 20 June 2005.
