I. Confirmation of minutes

[LC Paper Nos. CB(2)630/05-06 and CB(2)631/05-06]

The minutes of the meetings held on 10 and 17 November 2005 were confirmed.

II. Meeting with the Administration

[LC Paper Nos. CB(2)2017/04-05(02) and CB(2)657/05-06(01)]

- 2. The Bills Committee deliberated issues relating to the incorporation of owners of house developments (Index of proceedings at **Annex**).
- 3. On the Administration's position that any committee to be formed which would have the right to manage and maintain the common parts of some house developments which were owned by the developer might amount to interference of property rights and was not legally viable, the Chairman pointed out that the Administration had previously introduced legislative measures to interfere with the rights of minority owners such as the mechanism for termination of appointment of the building manager by a resolution of owners of not less than 50% of the shares. The Administration was requested to explain the difference in nature between the two and the legal consequences the Government would bear if proposed committee was allowed to be formed in law.
- 4. On the need for a basis for calculating the shares among owners of house developments for the formation of the proposed committee, the Administration was requested to consider resorting to the concept of "notional attribution of shares" in working out a basis of shares to resolve the

problem of lack of undivided shares. <u>The Administration</u> was also requested to consult owners of Hong Lok Yuen and Fairview Garden on the proper basis of shares and revert to the Bills Committee accordingly.

5. On the application of the Building Management Ordinance to house developments, Assistant Legal Adviser 4 pointed out that the extended meaning of the word "building" (in section 2 of the Ordinance) covered "any other land (if any) which is in common ownership with that building or land; or in relation to the appointment of a management committee under Part II or any application in respect thereof, is owned or held by any person for the common use, enjoyment and benefit (whether exclusively or otherwise) of the owners and occupiers of the flats in that building". The Administration was requested to consider whether the common parts of house developments could fall within the scope of this extended meaning even if they were owned by the developer.

6. <u>The Administration</u> was also requested to confirm whether there were "common parts" between the residential blocks in Fontana Gardens in Wan Chai.
