I. Meeting with deputations and the Administration

(LC Paper Nos. CB(2)1817/04-05(01) to (02) and CB(2)1818/04-05(01) to (02))

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Bills Committee received its views from the following organisations on the Bill
 - (a) The Chinese Manufacturers' Association of Hong Kong;
 - (b) Federation of Hong Kong Industries;
 - (c) The Chinese General Chamber of Commerce;
 - (d) Hong Kong General Chamber of Commerce;
 - (e) Hong Kong Small and Medium Enterprises Association;
 - (f) The Society of Trust and Estate Practitioners (Hong Kong) Limited (STEP);
 - (g) The Hong Kong Shipowners Association Ltd;
 - (h) The Hong Kong Exporters' Association;
 - (i) The Law Society of Hong Kong;
 - (j) Citigroup Private Bank;
 - (k) Morgan Stanley; and
 - (1) UBS AG.
- 3. The Bills Committee noted that the Law Society of Hong Kong took a neutral position on the policy of abolishing estate duty. Citigroup Private Bank considered that estate duty should be abolished progressively in Hong Kong. STEP opposed the abolition of estate duty, while the other nine organizations expressed support for abolishing estate duty.
- 4. The Bills Committee requested the Administration
 - (a) to provide information on practices in overseas jurisdictions which did not have estate duty, in particular whether a schedule of property was required;
 - (b) to advise whether the Administration had consulted relevant parties (the Judiciary, Department of Justice, Law Society of Hong Kong, banks, etc.) on the new application procedures for grant of representation;
 - (c) to explain the court procedures in respect of application for grant of representation after the abolition of estate duty; and
 - (d) to provide information on the increase in asset management business and investment professionals in the asset management industry in Hong Kong and Singapore in the past three years.

(*Post-meeting note*: The Administration's responses were issued to members vide LC Paper Nos. CB(2)1872/04-05(01) and 1875/04-05(02) on 8 June and 9 June 2005 respectively.)

5. The Bills Committee agreed that academics of tertiary institutions be requested to provide past research studies on the impact of abolition of estate duty on the economy, if available.

(Post-meeting note: Letters were sent to six tertiary institutions on 7 June 2005)
