I. Meeting with the Administration

<u>The Bills Committee</u> deliberated (index of proceedings attached at **Annex**).

- 2. <u>The Bills Committee</u> requested the Administration to provide a response in writing to the following requests raised by members at the meeting -
 - (a) to reconsider the proposed Committee Stage amendment (CSA) to the definition of "manager", having regard to the concern that the identity of the "manager" might not always be spelt out in the Deed of Mutual Covenant or other legal document(s) dealing with management of common part matters of a private building or the "manager", though could be identified but could not be traced about his/her whereabout;
 - (b) to ascertain whether ferry vessels, regardless of whether they operated as public transport carriers, were still subject to the smoking ban if they

were sometimes hired out for private functions or operated as feecharging public tour boats;

- (c) to make those part(s) of the domestic premises functioning as a workplace at certain hours of the day and were visited by patrons or clients, such as a self-employed person providing private tuition to his/her students, subject to the smoking ban; and
- (d) to review the drafting of the proposed CSA to the definition of "domestic premises" to ensure that it fully reflected the policy intent.
- 3. In view of the good progress made in the scrutiny of the papers provided by the Administration, <u>members</u> agreed to hold the next meeting on 4 May 2006 from 8:30 am to 12:30 pm. The next meeting originally scheduled for 25 April 2006 from 8:30 am to 12:30 pm was therefore cancelled.
