I. Meeting with the Administration
(LC Paper Nos. CB(2)448/05-06(01) and (02))

The Bills Committee deliberated (index of proceedings attached at **Annex**).

2. With regard to the Administration's response to the implementation of total smoking ban on betting premises in overseas jurisdictions (paragraphs 3 to 12 of LC Paper No. CB(2)448/05-06(01)), the Bills Committee requested clarification in writing on the following -

- (a) what were the meanings of "most bars" and "(when a bingo game is in progress)" in paragraph 4;

- (b) what was the meaning of “enclosed places of employment” in paragraph 6;
- (c) whether the “separate place for smoking” in paragraph 8 was a self-service area;
- (d) what was the meaning of “premium gaming rooms in casinos” in paragraph 9;
- (e) what was the meaning of “declared smoking area” in paragraph 10; and
- (f) what was the legislative intent and development of the smoke-free legislation in indoor workplaces implemented by the overseas jurisdictions concerned.

The Administration also undertook to provide the provision(s) on protecting employees from second-hand smoke under the Occupational Health and Safety Regulation in British Columbia, Canada, referred to in paragraph 8 of the same paper.

3. The Bills Committee also requested the Administration to provide a response in writing on -

- (a) the proposed establishment and working hours of the Tobacco Control Office of the Department of Health and details of how it would enforce the total smoking ban in hospitality premises such as bars, karaoke establishments, pubs and nightclubs; and
- (b) the question asked by Mr WONG Ting-kwong in his letter to the Administration dated 27 June 2005 on whether employees who suffered bodily harm outside their workplaces for their action in asking clients not to smoke in statutory no smoking areas would be entitled to monetary compensation under the existing labour legislation.

II. Any other business

Visits to hospitality premises

4. Ms Emily LAU said that it would be useful if representatives of the Administration could join the Bills Committee’s visits to hospitality premises on 25 and 28 November 2005. The Administration agreed to consider.

Businesses for the next meeting

5. Members noted that the next meeting originally scheduled for 6 December 2005 at 10:45 am had been changed to 9 December 2005 immediately after the meeting of the House Committee on the same day.

6. Members agreed to invite the following for the next meeting -

- (a) Research & Library Services Division of the Legislative Council Secretariat to make a presentation on its research study entitled “Smoke-free Workplace Legislation in Selected Places” prepared for the Panel on Health Services (RP10/04-05 issued vide LC Paper No. CB(2)2404/04-05 on 1 August 2005);
- (b) members of the delegation of the Panel on Health Services to make a presentation on the report of their visits to Bangkok (Thailand), Oslo (Norway) and Dublin (Ireland) in August 2005 to study the experience of these countries in the implementation of anti-smoking measures, if finalised; and
- (c) representatives of Japan Tobacco Inc. to make a oral representation on its research report entitled ““Mild Seven” Brand Name and On-Pack Notation Consumer Study: Hong Kong”.
