I. Meeting with the Administration

The Bills Committee deliberated (index of proceedings attached at **Annex**).

- 2. The Bills Committee requested the Administration
 - (a) to explain whether the deeming provision referred to in section 10(2) of the Employee's Compensation Ordinance regarding the certification of a period of absence from duty as a period of total temporary incapacity was rebuttable;
 - (b) to provide information on the guidelines in the Mainland on the assessment of an employee's loss of permanent capacity; and
 - (c) to consider providing in the Bill that an employee who had terminated his employment contract upon being certified by a registered medical practitioner or a registered Chinese medicine practitioner as being permanently unfit for his work should be allowed to resume duty, if the certification was rebutted.
- 3. The Bills Committee agreed that the issue of assisting listed Chinese Medicine Practitioners (CMPs) to become registered CMPs would be referred to the Panel on Health Services for follow-up.

The Bills Committee asked the Clerk to write to the Secretary for Health, Welfare and Food, copied to the Secretary for Economic Development and Labour, conveying members' view that the Administration should give an undertaking during the resumption of Second Reading debate on the Bill that the Administration would study the issue of assisting listed CMPs to become registered CMPs and provide a paper in about six months' time to the Panel on Health Services for follow-up.
