

Accreditation of Academic and Vocational Qualifications Bill

Consultation on the Qualifications Framework and its associated Quality Assurance Mechanism

At the meeting of the Bills Committee on the Accreditation of Academic and Vocational Qualifications Bill (the Bill) held on 10 October 2005, the Education and Manpower Bureau (EMB) was requested to provide information on the consultation on the Qualifications Framework (QF) and the contents of the Bill.

Consultation and Pilot Studies on the Proposed establishment of a QF and its associated Quality Assurance Mechanism

2. In November 2002, the EMB launched a three-month public consultation on the proposed establishment of a QF and its associated quality assurance mechanism in Hong Kong. The Legislative Council (LegCo) Panel on Manpower was also consulted. During the public consultation period, we received a total of 59 written submissions and organised more than 20 meetings and consultation sessions with various educational institutions, employers' associations, trade organisations, professional bodies and trade unions (see Annex A). While there was general support for the establishment of a QF and its associated quality assurance mechanism, some respondents considered that the QF was too academically-oriented and might overlook the skills and experience of people with low educational attainment. Some suggested that there should be more levels of qualifications and some expressed concern about the accreditation procedures and criteria of assessment under the quality assurance mechanism.

3. Having carefully considered the views from various sectors, we briefed the Manpower Development Committee (MDC) on the results of the public consultation in February 2003. In order to test the applicability of the proposed QF in different industry settings and to examine the feasibility of developing competency standards, we conducted pilot studies in 2003 in six industries, namely Accountancy, Chinese Catering, Electrical & Mechanical Services, Information Technology, Retail, and Watch & Clock industries. All the key

stakeholders, including the employers, employees, professional bodies, education and training providers, and accrediting body, were actively involved in the pilot studies. The results of the studies confirmed that the proposed QF was a suitable framework for different industries and it was feasible to develop competency standards for industries in Hong Kong. In October 2003, the results of the pilot studies and the proposed way forward to establish the QF were reported to the MDC.

4. In June 2003, we organised two seminars for the industries, employers' associations, trade unions, professional bodies, Hong Kong Council for Academic Accreditation (HKCAA), education and training providers with a view to enhancing the stakeholders' understanding of the QF. The seminars attracted a total of 150 participants. We also organised workshops in the same month to give an account of the concept and development process of the Specifications for Competency Standards (SCSs). A total of 55 people, mainly staff members from education and training providers, participated in the workshops.

5. In order to alleviate the concerns of trade unions, we arranged a visit for representatives of the Hong Kong Confederation of Trade Unions, Federation of Hong Kong and Kowloon Labour Unions, and Hong Kong Federation of Trade Unions to Australia in November 2003. The delegation met representatives of local trade unions, training organisations, Industry Training Advisory Boards, professional bodies and government departments. The visit enabled them to gain a better understanding of the implementation of the QF in Australia.

6. The LegCo Panel on Manpower was briefed in January 2004 and the members generally supported the setting up of a QF. However, some members expressed concern that the proposal might have an adverse impact on the employment of workers with low educational attainment as their skills, knowledge and working experience might not be recognised under the QF.

7. The Executive Council approved the establishment of the QF and its associated quality assurance mechanism in February 2004. In March 2004, we briefed the LegCo Panel on Manpower on the way forward to implement the QF. In July 2004, the LegCo held a motion debate on the implementation of the QF. The SEM elaborated on the

objectives and the major areas of work of implementing the QF in his response. A progress report on the implementation of the QF was submitted to the LegCo in September 2004.

Consultation on the Implementation of the QF

8. There is a greater and more imminent need to implement the QF in the vocational sector, so that more progression pathways may emerge for young people who do not have the aptitude or interest to pursue academic studies. We have been visiting major employers' associations, trade organisations and labour unions to promote the QF and clarify any possible misunderstanding and concern that they might have. We have also organised a series of consultation sessions with stakeholders in the industries, encouraging them to participate in the work of the relevant Industry Training Advisory Committee (ITACs). A list of the organisations that we consulted is at Annex B.

9. So far, ITACs have been formed for eight industries, namely Printing & Publishing, Watch & Clock, Chinese Catering, Hairdressing, Property Management, Electrical & Mechanical Services, Jewellery, and Information & Communications Technology. Separately, we invited some 80 representatives of the Hong Kong Federation of Trade Unions, Hong Kong Confederation of Trade Unions and Federation of Hong Kong and Kowloon Labour Unions (see Annex C) to attend a sharing session in August this year to further exchange views on the implementation of the QF.

10. Meanwhile, the HKCAA conducted three briefing sessions in January 2005 for over 100 training providers under the Skills Upgrading Scheme to explain its new role and the new quality assurance procedures under the QF. Between January and July this year, the HKCAA met with over 100 providers and explored how their programmes should be quality assured under the QF. These providers included the training providers offering programmes under the Continuing Education Fund, Skills Upgrading Scheme and employees retraining programmes; Construction Industry Training Authority; Clothing Industry Training Authority; Employees Retraining Board; Hong Kong Productivity Council; and Hong Kong Management Association.

11. In March 2005, the HKCAA conducted a Demand Forecast Study and interviewed over 80 training providers (see Annex D) to gather their views on the quality assurance mechanism underpinning the QF. The training providers generally supported the quality assurance mechanism and considered recognition of the QF brandname as a key motivation for pursuing quality assurance services.

12. The EMB and the HKCAA jointly held two briefing sessions in March and April 2005 to introduce the operational arrangements of the Qualifications Register (QR) to universities and their continuing education arms, as well as the community colleges. The QR will be a web-based database of information on qualifications, courses and providers that are recognised under the QF. The HKCAA also introduced the operational arrangements of the QR to some 220 training providers between May and September 2005.

13. In February this year, the MDC was consulted and endorsed the proposed quality assurance mechanism and the legislative amendments to the HKCAA Ordinance. The LegCo Panel on Manpower was consulted in March 2005 and generally supported the proposals.

14. Over the past nine months, the first four ITACs that have drafted their SCSs (i.e. Chinese Catering, Watch & Clock, Hairdressing, and Printing & Publishing ITACs) discussed the proposal to appoint assessment agencies under the Recognition of Prior Learning Mechanism. The ITACs agreed to the appointment of assessment agencies which recognise individuals' skills, knowledge and experience so that practitioners do not need to start from scratch or to repeat training.

15. The MDC has been regularly briefed on the progress of the implementation of the QF. We also reported the progress to the LegCo Panel on Manpower in January and October this year. We shall continue to report to the MDC and the LegCo Panel on Manpower on the latest development.
