

# A BILL

## To

Apply a sum not exceeding \$214,655,519,000 to the services of the Government in the financial year ending on 31 March 2006.

Enacted by the Legislative Council.

**1. Short title**

This Ordinance may be cited as the Appropriation Ordinance 2005.

**2. Authorization of appropriation**

The appropriation in the manner expressed in the Schedule of a sum not exceeding \$214,655,519,000 from the general revenue for the services of the Government in the financial year commencing on 1 April 2005, and ending on 31 March 2006, is authorized.

**Explanatory Memorandum**
