Motions

Proposed resolution under the Dutiable Commodities Ordinance

The Secretary for Financial Services and the Treasury moved the following motion and addressed the Council:

Resolved that Schedule 1 to the Dutiable Commodities Ordinance be amended, in paragraph 1A of Part III -

- (a) in subparagraph (a), by repealing "31 December 2004" and substituting "31 December 2005";
- (b) in subparagraph (b), by repealing "1 January 2005" and substituting "1 January 2006".

Question on the motion proposed.

Hon CHAN Kam-lam spoke on the motion as Chairman of the Subcommittee on the proposed resolution under section 4(2) of the Dutiable Commodities Ordinance (Cap. 109), and then in his personal capacity as a Member.

Seven Members spoke on the motion.

The Secretary for Financial Services and the Treasury replied.

Question on the motion put and agreed to.

Members' Motions

Proposed resolution under the Interpretation and General Clauses Ordinance

Hon CHOY So-yuk moved the following motion and addressed the Council:

Resolved that in relation to the -

- (a) Waste Disposal (Designated Waste Disposal Facility) (Amendment) Regulation 2004, published in the Gazette as Legal Notice No. 165 of 2004; and
- (b) Waste Disposal (Charges for Disposal of Construction Waste) Regulation, published in the Gazette as Legal Notice No. 166 of 2004,

and laid on the table of the Legislative Council on 3 November 2004, the period for amending subsidiary legislation referred to in section 34(2) of the Interpretation and General Clauses Ordinance (Cap. 1) be extended under section 34(4) of that Ordinance to the meeting of 5 January 2005.

Question on the motion proposed, put and agreed to.

That the Council do now adjourn

Hon Albert Jinghan CHENG moved the following motion and addressed the Council:

That this Council do now adjourn for the purpose of enabling Members, having regard to the Administration's and the Housing Authority's disregard for the motion passed by the Panel on Housing of this Council at its special meeting on 22 November this year that the Housing Authority should put the listing arrangements for The Real Estate Investment Trust ("The Link REIT") on hold until a consensus has been reached between The Link Management and the commercial tenants, to debate and express opinions on the listing and public offering arrangements, evaluation of assets and all matters relating to the divestment of retail and car-parking facilities in public rental housing estates in respect of The Link REIT.

Question on the motion proposed.

The Secretary for Housing, Planning and Lands and three Members spoke on the motion.

Hon Tommy CHEUNG declared his interest as a member of Hong Kong Housing Authority and spoke on the motion.

A Member and Hon Ronny TONG Ka-wah spoke on the motion.

While Hon Ronny TONG Ka-wah was speaking, the President left the chair at 6:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another three Members spoke on the motion.

Hon Albert Jinghan CHENG drew the attention of the President's Deputy to the absence of a quorum. The President's Deputy directed the Clerk to summon Members to the meeting. A quorum was then present.

One more Member and Hon LEUNG Kwok-hung spoke on the motion.

At 7:53 pm, while Hon LEUNG Kwok-hung was speaking, the President resumed the chair.

Three other Members and Hon LEUNG Yiu-chung spoke on the motion.

While Hon LEUNG Yiu-chung was speaking, Hon CHIM Pui-chung drew the attention of the President to the absence of a quorum. The President directed the Clerk to summon Members to the meeting. A quorum was then present and Hon LEUNG Yiu-chung continued to speak.

Seven more Members spoke on the motion. After declaring his interest as a member of Hong Kong Housing Authority, Hon SIN Chung-kai spoke on the motion.

One more Member and the Secretary for Housing, Planning and Lands spoke on the motion.

Hon Albert Jinghan CHENG replied.

Question on the motion put and negatived.

The President suspended the meeting at 11:13 pm.

The Council resumed at 2:30 pm on 2 December 2004.

Members' Motions

Implementing small class teaching

Hon Audrey EU moved the following motion and addressed the Council:

That this Council urges the Government to progressively implement small class teaching in primary schools, and then in secondary schools, to enable teachers to tailor their teaching to students' varied abilities, so as to realize and achieve the goal of quality education, promote education reform and fulfil the expectations of parents, teachers and students.

Question on Hon Audrey EU's motion proposed.

The President stated that Hon Mrs Selina CHOW would move an amendment to the motion and that Hon CHEUNG Man-kwong would also move an amendment to Hon Mrs Selina CHOW's amendment. In accordance with the Rules of Procedure, the motion, the amendment, and the amendment to the amendment would be debated together in a joint debate.

Hon Mrs Selina CHOW moved the following amendment to Hon Audrey EU's motion and addressed the Council:

To add "prudently assess the additional resources required for implementing small class teaching, weigh the commitments of both the Government and parents and, by ensuring that complementing training for teachers is available," after "urges the Government to"; and to delete ", and then in secondary schools," after "primary schools".

Question on Hon Mrs Selina CHOW's amendment to Hon Audrey EU's motion proposed.

Hon CHEUNG Man-kwong moved the following amendment to Hon Mrs Selina CHOW's amendment and addressed the Council:

To delete "prudently assess" after "the Government to" and substitute with "make optimal use of"; to delete "additional" before "resources"; to delete "required for implementing" after "resources" and substitute with "saved due to the drop in the primary and secondary school student population to provide training for teachers on"; to delete ", weigh the commitments of both the Government and parents and, by ensuring that complementing training for teachers is available" before ", progressively implement small class teaching" and substitute with "and, through a 'by district and by grade' mode of transition"; to delete "in" after "progressively implement small class teaching" and substitute with ", starting with"; and to add "and junior secondary forms," after "primary schools".

Question on Hon CHEUNG Man-kwong's amendment to Hon Mrs Selina CHOW's amendment proposed.

24 Members spoke on the motion and the amendments.

Hon Audrey EU spoke on the amendments.

The Secretary for Education and Manpower spoke on the motion and the amendments.

Question on Hon CHEUNG Man-kwong's amendment to Hon Mrs Selina CHOW's amendment put.

Hon Mrs Selina CHOW claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 12 were in favour of the amendment, seven against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 17 were in favour of the amendment, two against it and five abstained. (Voting record in Appendix I.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Question on Hon Mrs Selina CHOW's amendment to Hon Audrey EU's motion as amended by Hon CHEUNG Man-kwong put.

Hon James TIEN claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 13 were in favour of the amendment, one against it and seven abstained; while among the Members returned by geographical constituencies through direct elections, 25 were present, 16 were in favour of the amendment, one against it and seven abstained. (Voting record in Appendix II.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon Audrey EU replied.

Question on Hon Audrey EU's motion as amended by Hon Mrs Selina CHOW and Hon CHEUNG Man-kwong put and agreed to.

Overall development of Chinese medicine practitioners

Hon LI Kwok-ying moved the following motion and addressed the Council:

That, whereas the professional status of Chinese medicine practitioners ("CMPs") has been established for quite a long time, the development of CMPs has been handicapped because the Government does not have a long-term development strategy for Chinese medicine, is not adequately involved in this regard, and fails to establish avenues for CMPs to receive professional training, this Council urges the Government to formulate a long-term policy on the development of CMPs, which should include:

- (a) expediting the expansion of the scope of services provided by CMPs in the public medical system, implementing the outstanding plan to set up 15 public Chinese medicine out-patient clinics, establishing a mechanism for public hospitals whereby their in-patients can seek joint consultation and treatment by CMPs, setting up a Chinese medicine in-patient department in public hospitals, and studying the establishment of a Chinese medicine hospital;
- (b) establishing a committee on the development of Chinese medicine, and formulating strategies and policies to facilitate the development of Chinese medicine, such as giving statutory status to the sick leave certificates issued by CMPs, and reviewing the medical equipment that CMPs are allowed to use; and
- (c) formulating a mechanism and avenues for CMPs to receive professional training.

While Hon LI Kwok-ying was addressing the Council, the President left the chair at 6:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon LI Kwok-ying's motion proposed.

The President's Deputy stated that Hon LEUNG Yiu-chung, Hon Andrew CHENG and Hon Dr Hon KWOK Ka-ki would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Hon LEUNG Yiu-chung, Hon Andrew CHENG and Hon Dr Hon KWOK Ka-ki respectively spoke on the motion and their amendments. The Secretary for Health, Welfare and Food spoke on the motion and the amendments.

While the Secretary for Health, Welfare and Food was speaking, Hon James TIEN drew the attention of the President's Deputy to the absence of a quorum. The President's Deputy directed the Clerk to summon Members to the meeting.

At 7:20 pm, the President resumed the chair.

A quorum was then present and the Secretary for Health, Welfare and Food continued to speak.

A Member spoke on the motion and the amendments.

After declaring his interest as the Honorary Consultant of Hong Kong Acupuncture and Moxibustion Association, Ir Dr Hon HO Chung-tai spoke on the motion and the amendments.

Another eight Members spoke on the motion and the amendments.

Hon LI Kwok-ying spoke on the amendments.

The Secretary for Health, Welfare and Food spoke on the motion and the amendments.

Hon LEUNG Yiu-chung moved the following amendment to Hon LI Kwok-ying's motion:

To add "or provide proper registration avenues that cater for the CMPs' tradition of acquiring practice skills through apprenticeship or family succession, resulting in some 3 000 listed CMPs still not being able to become registered CMPs" after "to establish avenues for CMPs to receive professional training"; to delete "and" after "CMPs are allowed to use;"; and to add "; (d) having regard to the unique circumstances of CMPs and bone-setters who acquire their practice skills through apprenticeship or family succession, devising a more suitable examination system and syllabus for them, and arranging for the listed CMPs concerned to receive training before taking the examination, in order to enable them to become registered CMPs smoothly; and (e) reforming the compositions of the Chinese Medicine Council of Hong Kong and its various boards and committees, and enhancing their transparency and the representativeness of their members, so as to enable them to reflect a wide spectrum of opinions in

the sector" after "(c) formulating a mechanism and avenues for CMPs to receive professional training".

Question on Hon LEUNG Yiu-chung's amendment to Hon LI Kwok-ying's motion proposed and put.

Hon Miriam LAU claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

After the division bell had stopped ringing, the Clerk drew the President's attention to the absence of a quorum. The President then directed the Clerk to summon Members to the meeting. A quorum was then present and the Council proceeded to a division.

The President announced that among the Members returned by functional constituencies, 14 were present, nine were in favour of the amendment and five against it; while among the Members returned by geographical constituencies through direct elections, 16 were present, 14 were in favour of the amendment and one against it. (Voting record in Appendix III.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion or amendments thereto on "Overall development of Chinese medicine practitioners", the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

The President stated that Dr Hon KWOK Ka-ki had indicated that he would withdraw his amendment if Hon LEUNG Yiu-chung's amendment was agreed. Dr Hon KWOK Ka-ki had therefore withdrawn his amendment.

The President stated that as Hon LEUNG Yiu-chung's amendment had been agreed, she granted leave for Hon Andrew CHENG to revise the terms of his amendment and explain them to the Council.

Hon Andrew CHENG moved the following further amendment to Hon LI Kwok-ying motion as amended by Hon LEUNG Yiu-chung and explained the revised terms of his amendment to the Council:
To delete "and" after "become registered CMPs smoothly;"; and to add "; (f) reviewing the levels of fees as well as the fee subsidy and waiver systems in respect of public Chinese medicine out-patient clinics, and considering subsidizing elderly recipients of Comprehensive Social Security Assistance payments who use the services of non-public Chinese medicine out-patient clinics; and (g) giving statutory status to the insurance claim forms, receipts and other documents issued by CMPs, and reviewing CMPs' rights and responsibilities in the referral of patients" after "opinions in the sector".

Question on Hon Andrew CHENG's amendment to Hon LI Kwok-ying's motion as amended by Hon LEUNG Yiu-chung proposed, put and agreed to.

Hon LI Kwok-ying replied.

Question on Hon LI Kwok-ying's motion as amended by Hon LEUNG Yiu-chung and Hon Andrew CHENG put and agreed to.

Next Meeting

The President declared that the next meeting of the Council would be held on 8 December 2004 at 2:30 pm.

The Council was adjourned at 9:11 pm.
