### Follow-up to the meeting held on 15 July 2002

At the Finance Committee meeting on 15 July 2002 when members considered paper FCR(2002-03)33 on the one-off grant to encourage the early replacement of diesel public light buses with environmentally cleaner models running on liquefied petroleum gas or electricity, the Administration undertook to provide an update on the light bus models available in Hong Kong after the introduction of the incentive scheme. ## Information For Members of Finance Committee On Light Bus Models Available in Hong Kong

At the meeting of the Finance Committee on 15 July 2002, Members approved the creation of a new commitment for an incentive scheme to encourage the early replacement of diesel public light buses (PLBs) with environmentally cleaner models running on liquefied petroleum gas (LPG) or electricity (FC Paper FCR(2002-03)33). A Member requested the Administration to provide the Committee with an update on the light bus models available in Hong Kong after the introduction of the incentive scheme.

### Light Bus Models Available in Hong Kong

2. To encourage the supply of more light bus models to Hong Kong, we have approached the Motor Traders Association of Hong Kong and major light bus manufacturers overseas. In addition, the Administration relaxed the maximum permissible gross weight in 2004 for light buses to facilitate the supply of more models. Models currently available in the market are listed in the Annex for Members' information.

### **Progress of the Incentive Scheme**

3. The incentive scheme was launched in August 2002. Under the

scheme, a vehicle owner replacing his existing diesel PLB with an LPG

or electricity model is eligible for a one-off grant of \$60,000 or \$80,000

respectively. To be eligible for the grant, vehicle owners have to replace

their diesel PLBs aged 10 or above by end-2004 and their younger diesel

PLBs by end-2005. Replacement is entirely voluntary. Diesel PLB

owners who do not wish to use LPG or electric PLBs can continue to use

diesel PLBs.

4. The incentive scheme is well received by the trade. Over 80%

of the newly registered PLBs are LPG models. There are now over

1,720 LPG PLBs in operation, making up 40% of the PLB fleet (of 4,350).

We expect more diesel light buses will be replaced by LPG models before

the completion of the scheme.
