The CPs provide a cost-effective service to the community. The average cost, including the accommodation cost, of a CP conducting prosecutions is about \$2,622 per court day in 2004 (\$3,079 in 2003). This compares favourably with the fees for counsel prosecuting on general fiat which is \$5,430 per day. These calculations do not include those CP grade officers who are on administration and supervisory duties (the officers involved in these duties include the two Chief Court Prosecutors, all Senior Court Prosecutor I and some of the Senior Court Prosecutor II). This is because even if prosecution work is briefed out, there is still a need for senior officers in the CP grade to manage the cases in relation to both charges and summonses, to provide instructions to counsel, to liaise with police and departmental prosecutors and to manage the day-to-day deployment of manpower at the magistracies.

Whilst a number of Government Departments and authorities undertake their own prosecutions, the court prosecutors do, from time to time, prosecute cases on behalf of the following departments and authorities:
