(6) 劉皇發議員 (書面答覆)

The Chief Executive indicated in the 2004 Policy Address that the Government would review the function and composition of District Councils ("DCs") at a suitable time. It is the hope of DC members that the Government will conduct the review as soon as possible to further strengthen the role of DCs in district affairs. - (a) the time for commencement of the review by the Administration, as well as the anticipated timetable of the review exercise;
- (b) the scope of the review; and
- (c) the ways to consult the public on the review?
