Action

- I Recommendation report of the Consultative Committee on the Core Arts and Cultural Facilities of the West Kowloon Cultural District**
(Paper No. WKCD-398 -- Paper on "Recommendation Report of the Consultative Committee on the Core Arts and Cultural Facilities of the West Kowloon Cultural District" provided by the Administration)

The Subcommittee noted the following papers tabled at the meeting –

- (a) Letter dated 2 October 2007 from Hon LEE Wing-tat setting out a list of questions for the Administration's written response (Paper No. WKCD-407); and
- (b) Comparison between the recommendations in the Phase I and

Phase II Study Reports of the Subcommittee and the recommendations of the Consultative Committee prepared by the Legislative Council Secretariat (Paper No. WKCD-408).

(Post-meeting note: The above papers were circulated to members vide LC Paper No. CB(1)26/07-08 on 10 October 2007.)

2. The Subcommittee deliberated (Index of proceedings attached at the **Appendix**).

3. The Chairman remarked that pursuant to members' request at the previous meeting on 12 September 2007, this meeting was held for the Subcommittee to continue to discuss with the Administration the Recommendation Report of the Consultative Committee on the Core Arts and Cultural Facilities of the West Kowloon Cultural District (the Recommendation Report).

Funding arrangements

4. Mr LEE Wing-tat highlighted the importance of proper monitoring of the WKCD Authority by the public and the Legislative Council (LegCo). Instead of an upfront endowment of \$19 billion to finance the capital costs of the West Kowloon Cultural District (WKCD) project, Mr LEE suggested that the endowment could be appropriated by LegCo in phases to ensure accountability of the Authority. This view was shared by Ms Margaret NG and Prof Patrick LAU. While Mr Abraham SHEK agreed that the Authority should be accountable to both the public and LegCo for its work, he was of the view that an upfront endowment approved in one-go would enable the WKCD Authority to carry out long-term planning with the assurance of sufficient funds for the capital costs of the WKCD project.

5. The Secretary for Home Affairs (SHA) advised members that after the enactment of the enabling legislation for the WKCD Authority, the Administration would seek the necessary funding appropriation from LegCo. Members would have ample opportunities to discuss details of the funding arrangements when the application was submitted to the Finance Committee.

WKCD Authority

6. Members supported early establishment of the WKCD Authority but cautioned that sufficient time should be provided for Members to scrutinize the relevant Bill. Given the important functions of the WKCD Authority, members expressed concern about the composition of the Authority and how its members were to be selected from the relevant sectors. In this connection, Mr Albert HO suggested that consideration could be given to having some members of the Authority nominated by the relevant arts and cultural sectors with reference to the Hong Kong Arts Development Council (HKADC) or selected from the

representatives of the public.

7. Ms Margaret NG suggested that the Administration should introduce a White Bill for the WKCD Authority to facilitate public consultation and discussion by LegCo. In the meantime, a provisional body could be established to take up the necessary preparatory work. In response, SHA said that the Administration intended to introduce the enabling legislation for the WKCD Authority upon completion of the current public engagement exercise if there was a public consensus on the way forward for the project. If the relevant bill was not passed before the end of the current LegCo term, the Administration would consider the option of setting up a provisional WKCD body.

Software development

8. Members expressed concern that the cultural software development in Hong Kong could not be kept in pace with the hardware development in WKCD. Dr KWOK Ka-ki stressed the importance that part of the WKCD Authority's annual budget should be devoted to software development.

9. In reply, the Deputy Secretary for Home Affairs (3) (DS/HA(3)) advised that the Administration had implemented a series of measures on software development through various department/organizations, such as the Leisure and Cultural Services Department, HKADC and the Hong Kong Academy for Performing Arts, at an annual provision of around \$2.5 billion. The Administration would consider allocating additional resources in this area to complement the WKCD project.

10. In reply to Mrs Selina CHOW's enquiry on the appropriate forum for LegCo to follow up on software development and the recommendations to revamp the management of existing public arts and cultural facilities, SHA suggested that the Administration would brief the Panel on Home Affairs on the updated progress of the matters.

Museum Plus

11. Members expressed different views on the **Museum Plus (M+)**. While Prof Patrick LAU supported the concept, Mr LEE Wing-tat and Dr KWOK Ka-ki were concerned whether the four proposed themes could meet the needs of the public and its long term viability given its huge capital costs and low cost recovery rate. DS/HA(3) said that M+ was proposed by the Museum Advisory Group after extensive public consultation. M+ was an innovative idea emphasizing active community participation and required detailed planning for its successful implementation. The concept was fluid and the themes should continue to be re-examined during the course of development, based on the professional expertise of the curators, prevailing international trends and feedback from visitors and experts.

Questions raised and information requested for the Administration's written response

Admin 12. The Administration was requested to provide written response on the following:

- (a) A timetable setting out the Administration's schedule for the various aspects of work to implement the WKCD project, in particular the work on the enactment of legislation to establish the WKCD Authority and the town planning work.
- (b) The Administration indicated at the meeting that it had no plan to set up a high-level body vested with the responsibility for arts and cultural development in Hong Kong. The Administration was requested to explain how the long-term arts and cultural vision to make Hong Kong a cultural metropolis could be achieved without such an institutional setup for strategic planning and co-ordination of the work of various bureaux/departments and relevant organizations on arts and cultural development.
- (c) The Administration indicated at the meeting that funding for nurturing of art talents, community art education, training of management and marketing professionals for art and cultural facilities etc. to complement the WKCD project had not been taken into account in the proposed financial arrangements for the WKCD project, but the funding requirements for these purposes would be taken into account in the Government's normal budgeting process. The Administration was requested to provide details on the current and future budgeting arrangements.
- (d) There were rich art and heritage collections held by private bodies and individuals in the community. The Administration was requested to consider measures to mobilize these resources to promote the appreciation of art and heritage in the community during the lead time before the WKCD project commenced.
- (e) Information on the funding modes for arts and cultural development in other places. How far reference could be drawn from these places in formulating the Government's funding policy for local arts and cultural organizations and the financial arrangements for WKCD.
- (f) What measures the Government would take or would the Government allow the WKCD Authority to take if the Authority ran into financial difficulty in developing/operating the arts and cultural facilities in WKCD.

- (g) Details of the town planning process for WKCD, in particular when and how the master layout plan would be drawn up and at what stages the public would have opportunities to participate in the planning process.
- (h) How the Government would fully integrate the arts and cultural facilities in WKCD as well as its overall planning with its neighbouring areas, so as to cultivate an appropriate cultural ambience in the district and its immediate vicinity.
- (i) Detailed information on the survey conducted by the Education Bureau on the efficacy of arts education in primary and secondary schools and how the survey results compared with the situation of other comparable places.
- (j) Why the Consultative Committee and the Government had not adopted the Subcommittee's recommendation to set up consultation panels to conduct structured public consultation for the Public Engagement exercise being undertaken and for the future implementation and operation of the WKCD.

(Post-meeting note: The above list, which had been amended to include other information requested by members subsequent to the meeting, was forwarded to the Administration for written response on 8 October 2007. The confirmed full list (Paper No. WKCD-409) was circulated to members vide LC Paper No. CB(1)26/07-08 on 10 October 2007.)

13. Members noted that the next two Subcommittee meetings scheduled for 9 and 23 October 2007 would be devoted to receiving views from the public on the Recommendation Report.
