## Consultative Forums

As agreed at the last PATAG meeting on 24 April 2006, two open consultative forums would be held to solicit public views, particularly those from arts, cultural, entertainment and tourism sectors on the core performing arts and cultural facilities in West Kowloon Cultural District (WKCD). The open consultative forums will be arranged by the Secretariat with participation from Advisory Group Members. Members of the Consultative Committee (CC) and other Advisory Groups will also be invited to attend these forums. The topics to facilitate the discussion at the forums will be discussed separately (please see paper PATAG/11/2006).
