Subcommittee to Study the Subject of Combating Poverty

Paper prepared by Legislative Council Secretariat

Work plan for 2006-07 session

Purpose

This paper provides a brief on the work in progress and invites members' suggestions on further study areas for 2006-07 session.

Background

2. In February 2005, a list of possible study areas and discussion topics was drawn up for the Subcommittee's consideration (**Appendix I**). Research studies were conducted on the definitions of poverty, causes/situation of poverty in Hong Kong, benchmarks for granting subsidies or financial assistance to people in need in Hong Kong, poverty combating strategies in selected overseas countries, and social security system for retirement protection in selected overseas countries. Background briefs and information papers were also prepared on past discussions by Members on the subjects on poverty. These research reports and information papers were discussed by the Subcommittee in 2005 and 2006. The list of research studies and information papers discussed is in **Appendix II**.

3. The Subcommittee had also met with non-government organisations, academics, business sectors and other interested parties to gauge their views on the situation of poverty in Hong Kong and the various measures required to alleviate the problems faced by different groups of people in poverty.

4. At its internal meeting on 12 July 2005, the Subcommittee agreed to accord priority to the study of two topics, i.e. working poverty and women in poverty. The Report on Working Poverty and the Report on Women in Poverty were presented to the Legislative Council (LegCo) and debates were held on these reports on 15 February and 5 July 2006 respectively.

Follow-up on the Subcommittee's two reports

Report on Working Poverty

5. The Subcommittee is following up with the Commission on Poverty (CoP) and relevant bureaux/departments the implementation of the recommendations in the Report on Working Poverty which was tabled in Council on 15 February 2006. At the meeting on 22 June 2006, the following recommendations in the Report were discussed –

- (a) developing the economy and creating employment opportunities;
- (b) providing community support and developing local economies;
and
- (c) reviewing the contracting-out arrangements for Government services.

6. The Subcommittee will continue to discuss with CoP the other recommendations in the Report at the meetings scheduled for 18 July and 5 October 2006. These other recommendations are –

- (a) safeguarding employees' benefits;
- (b) enhancing the competitiveness of the working poor through education and training;
- (c) providing financial assistance to the working-poor households (including the provision of transport subsidy);
- (d) providing support services for working-poor households; and
- (e) enabling community participation and empowerment of the working poor in formulating strategies to reduce working poverty.

Report on Women in Poverty

7. The Report was tabled in Council on 5 July 2006. The Subcommittee will follow up with the Administration the implementation of recommendations in the Report. As the Report contains 21 recommendations which involve various bureaux and organisations, it is envisaged that two or three meetings may have to be scheduled to discuss these recommendations. The first of these meetings is scheduled for 5 October 2006.

Study on the elderly in poverty

8. The Subcommittee agreed at its meeting on 22 June 2006 that it would start the study on the elderly in poverty in September/October 2006. The Subcommittee has requested the LegCo Secretariat to provide a background paper on the past discussions by Members on the subject. The paper will be ready for the Subcommittee's consideration by September/October 2006.

9. Depending on the scope of the proposed study and the additional research or information requested by members, it is expected that the study will take about three months to complete.

Monitoring of the work of the Commission on Poverty

10. The Subcommittee will continue to hold meetings in 2006-07 with CoP to monitor its progress of work, and to exchange views with CoP on its initiatives and work programmes.

Remaining issues on the list of possible study areas/discussion topics

11. Most of the issues on the list of possible study areas and discussion topics prepared in February 2005 (Appendix I refers) have been discussed by the Subcommittee. For some of these issues, research reports and information papers have been prepared and considered by the Subcommittee (Appendix II refers). Various committees of the LegCo have also discussed issues on the list.

12. A summary of discussions by the Subcommittee and other committees of LegCo is in **Appendix III**.

13. The three study areas (i.e. working poverty, women in poverty and elderly in poverty) selected for study by the Subcommittee are targeted at specified sectors of the population.

14. There are three other sectors of population on the list, i.e. children and youth, new immigrants and people with disabilities.

15. On children and youth, CoP has set up a task force to take forward the work relating to reducing the risks of intergenerational poverty. The Administration has briefed the Subcommittee on some initiatives announced in the Policy Address of the Chief Executive, such as the Head Start Programme and the School-based After-school Learning and Support Programme. The

Subcommittee on Review of the CSSA Scheme formed under the Panel on Welfare Services has also discussed the basic needs of children with welfare organisations and the Administration.

16. On new immigrants, their characteristics and problems have been covered in the studies on working poverty and women in poverty. Apart from the general recommendation in the Report on Working Poverty that more support should be provided to new immigrants to assist them in finding employment and integrating into the community, a specific recommendation is made in the Report on Women in Poverty that the seven-year residence requirement for public housing and CSSA payments should be relaxed. A Taskforce was set up in 2003 under the Chief Secretary for Administration to study the changes in demographic structure and the policies to respond to such changes. It is expected that a report will be released by the Task Force this year.

17. As regards people with disabilities, a subcommittee was formed under the House Committee in November 2005 to study the transport needs of and the provision of concessionary public transport fares for persons with disabilities. The Panel on Welfare Services is also discussing with the Administration the provision of residential care services and financial assistance for the disabled, and measures to enhance the employment of the disabled.

Suggestions on new topics for study

18. The LegCo Secretariat has not received suggestions from members on new topics for study by the Subcommittee.

Advice sought

19. Members are invited to give views on the work plan of the Subcommittee in 2006-07 session.

- (l) partnership with the business sector and non-government organisations;
and
- (m) setting up of trust fund(s) to assist those in need by the commercial sector;
- (n) community efforts; and
- (o) review of the taxation system.
