**Residential respite service for persons with disabilities aged under 15**

Thank you for your letter of 5 December 2007 conveying the views and suggestions of the Subcommittee Members on the provision of residential respite service for persons with disabilities (PWD) below the age of 15.


In response to the Subcommittee's letters of 28 February and 31 May 2007 on the same subject, the Administration had thoroughly considered the orientation of the residential respite service for PWD aged under 15, the jurisdictions and core areas of the education and welfare policies as well as the views of the Subcommittee Members. In our reply of 12 June 2007 to the Subcommittee, we pointed out that the provision of residential respite service for PWD aged under 15 is by nature a social service. In the

absence of new circumstances, I do not see justifications to depart from that view. Having said that, the contingency arrangement for special schools with unfilled boarding places to provide residential respite service for their students in genuine needs on voluntary and self-financing basis will continue.

Since the Administration's letter of 12 June 2007 to you, the Secretary for Labour and Welfare has carefully examined the possibility of extending the existing residential respite service provided by the Social Welfare Department (SWD) through non-government organizations (NGOs) to children aged 15 or below. As reported at the last Subcommittee meeting held on 30 November 2007, SWD had met with parents associations to understand the needs of their children and discussed with NGOs the provision of the service. So far, SWD has made good progress on the preparation for rolling out the new service with the intention of launching it in 2008/09.

Please rest assured that the Administration will continue to work closely with parents and NGOs to cater for the needs of parents and children for residential respite service.
