The Subcommittee deliberated on the International Organizations (Privileges and Immunities) (World Trade Organization) Order (the WTO Order) (Index of proceedings attached at **Appendix**).

Clause-by-clause examination

2. The Chairman requested <u>Assistant Legal Adviser 2</u> to scrutinize the Chinese version of the WTO Order and where necessary, draw the Subcommittee's attention to relevant drafting issues.

Follow-up action

- 3. <u>Members</u> noted that as currently drafted, those provisions of the 1947 United Nations Convention on the Privileges and Immunities of the Specialized Agencies which would be implemented in Hong Kong were reproduced in the Schedule to the Order and shall have the force of law in Hong Kong subject to section 3(2) and (3) of the Order which set out how certain expressions in these provisions should be construed. <u>Mr Martin LEE</u> expressed concern about the drafting approach adopted for the WTO Order which, in his view, was cumbersome and not reader-friendly.
- 4. After discussion, <u>members</u> agreed that the Panel on Administration of Justice and Legal Services should be invited to follow up the subject of the drafting approaches for preparing local legislation to implement provisions of international agreements in Hong Kong. <u>The Administration</u> noted members' concern and agreed to also look into its drafting practice.

The way forward

5. <u>Members</u> agreed that it was necessary to enact the WTO Order. Both the Administration and the Subcommittee would not propose any amendment to the Order. As the Subcommittee had concluded its deliberations, <u>members</u> agreed that the Subcommittee would report to the House Committee on 27 May 2005.

(*Post-meeting note:* After further consultation and as decided by Mr SIN Chung-kai, Subcommittee Chairman, the report on the Subcommittee's deliberations will be submitted to the House Committee on 3 June 2005.)
