

**Panel on Administration of Justice and Legal Services
Meeting on 14th December 2004 at 4:30 p.m.
Solicitor Corporation Rules**

I refer to the agenda of the meeting of the Panel on Tuesday next 14th December. The draft Solicitor Corporation Rules are not yet available for perusal by the Panel. I have had a very lengthy discussion with the Law Draftsman who has been helpful in providing a number of amendments largely of style to the original draft. There are several loose-ends which have to be resolved and I am confident that this will be done very shortly. However, in view of the fact that the draft rules are not yet available and will not be ready by 14th December, you may wish to consider whether any useful purpose is served by including this item on the agenda for that meeting. I would respectfully suggest that this item should be postponed until the January meeting by which time I would anticipate that the draft rules will be available.
