LegCo Subcommittee to Study the Streamlining of Food Business Licensing

Number of Food Business Licence Applications and Time Taken for Processing Applications

Purpose

This paper informs Members of the number of restaurant and non-restaurant licences processed by the Food and Environmental Hygiene Department (FEHD) in 2002, 2003 and 2004 and the time taken to process these applications.

Background

2. FEHD issues two main categories of food business licences, namely the restaurant licence and non-restaurant licence. Restaurant licences cover general restaurant, marine restaurant and light refreshment restaurant. FEHD has not issued any marine restaurant licence in the past three years. Non-restaurant licences cover food factory, fresh provision shop, factory canteen, siu mei and lo mei shop, bakery, cold store, frozen confection factory and milk factory.

3. All applications of food business licences are processed by three Licensing Offices of FEHD in Hong Kong, Kowloon and the New Territories respectively. FEHD issues both full and provisional licences for all types of food business licences. For application of a provisional licence, an applicant must apply for a full licence at the same time.

Number of Applications and Processing Time

4. Details on the number of restaurant and non-restaurant

licences processed by FEHD in 2002, 2003 and 2004 and the time taken to process these applications are set out at **Appendix I** and **Appendix II**.

- 5. Members will note that:
 - (a) The average time taken to process a full restaurant licence application made in 2002, 2003 and 2004 was 185, 185 and 164 working days respectively and that for a full non-restaurant licence, was 133, 130 and 107 working days respectively;
 - (b) For a provisional licence, the average time taken to process a restaurant licence application made in 2002, 2003 and 2004 was 48, 49 and 44 working days respectively, and that for a non-restaurant licence application was 54, 48 and 43 working days respectively.

6. The above analysis excludes figures on withdrawn cases. FEHD will conduct a separate analysis and submit the findings to the Subcommittee at a later stage.
