Re: Submission to Legco Home Affairs Panel regarding the conservation of Central Police Station Heritage Complex

In view of the heightened community concerns over the conservation of the Central heritage buildings comprising the Central Police Station, former Central Magistracy and Victoria Prison ("CPSH"), we are pleased to submit to you on behalf of the *Central Police Station Heritage Taskforce* our proposal for a Citizen-Envisioned Participatory Assessment Model ("CEPAM") as an alternative selection process for the development of CPSH (see attached). This proposal is an outcome of a public engagement exercise carried out by the Taskforce over the past two months.

CEPAM is developed on the basis of two guiding principles: the "heritage first" principle and the "China principles". If adopted, **CEPAM will be a pioneer attempt by Hong Kong to implement a local heritage project in line with international best practice**.

Although a longer time span and more public resource may be required compared with the traditional tender process, the Taskforce is confident that the outcome of CEPAM will be much more widely acceptable to the public. This will likely lead to smoother implementation of the project and make up for any extra time spent in the selection process. This will also be essential to avoid any social friction such as that experienced in the harbour reclamation saga.

Due to the rising awareness of the general public on strategic projects such as CPSH, broad-based public participation in the entire life cycle of the project is of utmost importance. We sincerely hope that Legco members may give full support to the principles of CEPAM and urge relevant government authorities to work out the detailed mechanisms and engage the public as a matter of urgency.

Citizen-Envisioned Participatory Assessment Model ("CEPAM") for the Beneficial use of Central Police Station Heritage Complex

1. Introduction

This proposal is prepared by the Central Police Station Heritage Taskforce (the "Taskforce") which comprises a broad spectrum of professional bodies, environmental groups and community groups (see appendix 1) concerned with the development of the Central Police Station Heritage Complex (the Central Police Station, Victoria Prison and former Central Magistracy, collectively termed "CPSH").

The essence of this proposal does not only represent the views of the Taskforce, but is also the outcome of a community engagement exercise which includes a public opinion survey and a roundtable forum of community leaders held on 25 September 2004. The report of the roundtable forum and the results of the public opinion survey are attached in appendix 2 and 3 respectively.

2. Guiding Principles

There is strong support by the community that the development of CPSH should be subject to the following two guiding principles:

a) "Heritage First" Principle

When contemplating the future of CPSH, we should, first and foremost, put heritage conservation and the enhancement of heritage value in the centre of any development considerations. Whilst this "Heritage First" principle should not prevent the future development from benefiting the community in a multi-faceted manner, such as potential social, economic and tourism gains, it does require that the planning, design and operation of any development project should not be geared towards the maximisation of these corollary benefits at the expense of heritage conservation or opportunities for heritage value enhancement.

b) The China Principles

In 2000 the State Administration of Cultural Heritage of the Chinese Central Government approved the *Principles for the Conservation of Heritage Sites in China* (commonly known as the "China Principles") as an integrated and methodological approach to the conservation and management of historical sites in China. These principles were developed through an international cooperative effort. They are developed on the

basis of the Venice Charter (1964) and the Burra Charter of Australia ICOMOS (1979, revised 1999). As such, the China Principles are consistent with international best practice. It is only appropriate that the development of CPSH should conform to the China Principles.

3. Citizen-Envisioned Participatory Assessment Model

As an alternative selection process to the tender process used by the SAR Government in the development of the Tsim Sha Tsui Marine Police Headquarters, the Citizen-Envisioned Participatory Assessment Model ("CEPAM") is developed in accordance with the "Heritage First" principle and the China Principles.

CEPAM will involve a two-stage open invitation to developers, non-governmental organisations and charity trusts to submit relevant proposals for the development and operation of CPSH. The successful bidder will enter into a 30-year concession contract with the government along the model of public-private partnership ("PPP"). Compared with a 50-year land lease, this concession model will allow the government tighter control and more authority to intervene on behalf of the public should unexpected circumstances arise during the concession period. To reap full benefits of this PPP model, the government will need to establish a clear authority, such as a heritage trust, to take up a regulatory role over the concession period.

In order to encourage innovative proposals by potentially resource-poor parties (which, if successful in the first stage, may well receive financial backing from other parties), the process will be divided into two stages. Separate assessment criteria will be used at each stage and they will be fully transparent to potential bidders prior to bidding.

CEPAM Stage 1 – Pre-qualification

Interested parties will be invited to submit conceptual proposals which will be assessed on the basis of the following two criteria:

a) Minimum preservation requirements

The proposal must satisfy all the heritage preservation requirements for CPSH as set out by the Antiquities Advisory Board, including initial restoration works and on-going maintenance.

b) Financial sustainability

The proposal must be able to demonstrate that the project can, under all reasonable business scenario, be self-financing without relying on any long-term public funding support.

Only proposals that satisfy both criteria will be qualified to enter into the next stage.

CEPAM Stage 2 – Invited tender

Qualified bidders will be invited to submit detailed proposals either on their own or in partnership with one or more supporting partners. The detailed proposals must be based on and developed from the conceptual proposals qualified in Stage 1.

The following assessment criteria will be adopted:

- a) Heritage concept and value enhancement (30%)
 - Quality of **heritage setting** and enhancement of heritage characteristics to reflect the cultural and historical significance of the site (10%)
 - On-going **management plan** to ensure the enhancement of heritage value over the long term (10%)
 - Expertise, transparency and independence of **organisational structure** to oversee the planning, design and implementation of heritage conservation plan (10%)
- b) Design merits, competence and technical issues (20%)
 - **Design merits and creativity** of development concept (10%)
 - Experience, expertise and track record in managing heritage projects (5%)
 - **Technical issues** including compliance with traffic, environmental and planning requirements (5%)
- c) Economic and tourism benefits (20%)
 - **Economic benefits** to community (including payments to government) under most probable scenario (10%)
 - Ability to establish heritage site as **Hong Kong's landmark** to attract international tourists (10%)
- d) Social and community benefits (30%)
 - **Benefits to community** in strengthening social cohesion, sense of history and local identity (10%)
 - Level of **public enjoyment** in terms of both quantity (degree of openness to the public) and quality (depth of involvement) (10%)

• Degree of **public participation** in project planning, design and management (10%)

In order to obtain a balanced assessment by both professionals and members of the public, two different assessment methods will be adopted for the first three criteria from (a) to (c) and for the last criterion (d). Citizen inputs will however be evident in both assessment methods.

For the first three criteria, an expert assessment panel will be formed with representatives from three groups of stakeholders: government, professional bodies and community groups. Members of the public can provide their inputs through representatives of various community groups.

For the last criterion related to "social and community benefits", the most competent judges are members of the public who are concerned about the development. Public assessment can be conducted through a specially designed "informed participatory process" so as to ensure, on one hand, that the process is fully open to all, and on the other hand, only citizens who are committed to understanding the proposals in detail (e.g. after going through public exhibitions, briefing sessions and facilitated workshops) will be entitled to give marks to the proposals. The public resource to be devoted to this informed participatory process will be justifiable for not only helping to select the best proposal, but also for its value in public education and improved governance.

4. Public engagement and institution building

Due to the cultural and historical significance of CPSH, it is important that the public will be given a chance to develop an ownership of the project. This can only be achieved through broad-based public engagement in all stages of the project. The following mechanisms should be considered to enhance public participation:

- At the planning stage an opportunity for the public to tour the site (e.g. an open day or open week) and envision the future and preferred usage of the site. Open charettes facilitated by professional planners, architects and community workers will be a useful mechanism. The outcome of the envisioning process will be valuable reference for potential bidders in preparing their proposals.
- At the assessment stage an opportunity for the public to assess the merits of each proposal through an informed participatory process (as described above) as an integral part of the assessment.
- At the operational stage an opportunity to build an ongoing institution (e.g. a heritage trust) so that representatives of the public can oversee the management of the site and offer ongoing advice in the spirit of public-private partnership.

Although a longer time span and more public resource may be required compared with the traditional tender process, the Taskforce is confident that the outcome of CEPAM will be much more widely acceptable to the public. This will likely lead to smoother implementation of the project and make up for any extra time spent in the selection process. Lessons learnt from the harbour reclamation saga can serve as good reference.

Due to the rising awareness of the general public on strategic projects such as CPSH, broad-based public participation in the entire life cycle of the project is of utmost importance. Should the government decide to adopt the principles of CEPAM, members of the Taskforce are ready to work in partnership with relevant government authorities to work out the detailed mechanisms and engage the public in due course.





Interested parties will be invited to submit conceptual proposals which will be assessed on the basis of the following two criteria:

a) Minimum preservation requirements

The proposal must satisfy all the heritage preservation requirements for CPSH as set out by the Antiquities Advisory Board, including initial restoration works and ongoing maintenance.

b) Financial sustainability

The proposal must be able to demonstrate that the project can, under all reasonable business scenario, be self-financing without relying on any long-term public funding support.

Only proposals that satisfy both criteria will be qualified to enter into the next stage.

CEPAM Stage 2 – Invited tender

1

Qualified bidders will be invited to submit detailed proposals either on their own or in partnership with one or more supporting partners. The detailed proposals must be based on and developed from the conceptual proposals qualified in Stage 1.

The following assessment criteria will be adopted:

- a) Heritage concept and value enhancement (30%)
 - Quality of **heritage setting** and enhancement of heritage characteristics to reflect the cultural and historical significance of the site (10%)
 - On-going management plan to ensure the enhancement of heritage value over the long term (10%)
 - Expertise, transparency and independence of organisational structure to oversee the planning, design and implementation of heritage conservation plan (10%)
- b) Design merits, competence and technical issues (20%)
 - **Design merits and creativity** of development concept (10%)
 - Experience, expertise and track record in managing heritage projects (5%)
 - Technical issues including compliance with traffic, environmental and planning requirements (5%)
- c) Economic and tourism benefits (20%)
 - Economic benefits to community (including payments to government) under most probable scenario (10%)
 - Ability to establish heritage site as **Hong Kong's landmark** to attract international tourists (10%)
- d) Social and community benefits (30%)
 - Benefits to community in strengthening social cohesion, sense of history and local identity (10%)
 - Level of **public enjoyment** in terms of both quantity (degree of openness to the public) and quality (depth of involvement) (10%)
 - Degree of **public participation** in project planning, design and management (10%)

In order to obtain a balanced assessment by both professionals and members of the public, two different assessment methods will be adopted for the first three criteria from

(a) to (c) and for the last criterion (d). Citizen inputs will however be evident in both assessment methods.

For the first three criteria, an expert assessment panel will be formed with representatives from three groups of stakeholders: government, professional bodies and community groups. Members of the public can provide their inputs through representatives of various community groups.

For the last criterion related to "social and community benefits", the most competent judges are members of the public who are concerned about the development. Public assessment can be conducted through a specially designed "informed participatory process" so as to ensure, on one hand, that the process is fully open to all, and on the other hand, only citizens who are committed to understanding the proposals in detail (e.g. after going through public exhibitions, briefing sessions and facilitated workshops) will be entitled to give marks to the proposals. The public resource to be devoted to this informed participatory process will be justifiable for not only helping to select the best proposal, but also for its value in public education and improved governance.

4. Public engagement and institution building

Due to the cultural and historical significance of CPSH, it is important that the public will be given a chance to develop an ownership of the project. This can only be achieved through broad-based public engagement in all stages of the project. The following mechanisms should be considered to enhance public participation:

- At the planning stage an opportunity for the public to tour the site (e.g. an open day or open week) and envision the future and preferred usage of the site. Open charettes facilitated by professional planners, architects and community workers will be a useful mechanism. The outcome of the envisioning process will be valuable reference for potential bidders in preparing their proposals.
- At the assessment stage an opportunity for the public to assess the merits of each proposal through an informed participatory process (as described above) as an integral part of the assessment.
- At the operational stage an opportunity to build an ongoing institution (e.g. a heritage trust) so that representatives of the public can oversee the management of the site and offer ongoing advice in the spirit of public-private partnership.

5. The way forward

The CEPAM proposed above is an outcome of the public engagement exercise during the past month and is also based on two guiding principles: the "Heritage First" principle and the China principles. If adopted, CEPAM will be a pioneer attempt by Hong Kong to implement a local heritage project in line with international best practice. Although a longer time span and more public resource may be required compared with the traditional tender process, the Taskforce is confident that the outcome of CEPAM will be much more widely acceptable to the public. This will likely lead to smoother implementation of the project and make up for any extra time spent in the selection process. Lessons learnt from the harbour reclamation saga can serve as good reference.

Due to the rising awareness of the general public on strategic projects such as CPSH, broad-based public participation in the entire life cycle of the project is of utmost importance. Should the government decide to adopt the principles of CEPAM, members of the Taskforce are ready to work in partnership with relevant government authorities to work out the detailed mechanisms and engage the public in due course.

5.1 The Media Coverage of Central Police Station

1. Background

- 1.1 With Tourism Commission's announcement that Central Police Station, Victoria Prison and the Former Central Magistracy (hereafter collectively called Central Police Station) will be put as a single site into a tender, worries were raised in the society and among the professionals whether the tender process would really secure a proponent or developer' proposal to the satisfaction and aspiration of the whole society in terms of the following aspects:
 - (1) Heritage Conservation: As the declared monuments in Hong Kong receiving legal protection, can the conservation of Central Police Station receive sufficient attention in the tender and assessment process?
 - (2) Public Engagement: Can the public be involved in the tender, assessment and monitoring processes?
 - (3) Tender Process: Can the tender process encourage appropriate and fair assessment criteria and proposals to serve the best public interest?
 - (4) Institutional Mechanism: Can the public vote for their visions and interests? Can the public participate in monitoring progress and compliance?
- 1.2 The facts under the current tender mechanism, however, are that Central Tender Board has already devised a detailed marking scheme that land premium has a prevailing relative weighting while remaining weighting will be for non-premium aspects shared by heritage conservation, economic / tourism revenues, environment and transport etc. In addition, the tender assessment panel will comprise representatives of concerned bureaux and departments, representatives from the Antiquities Advisory Board and Hong Kong Tourism Board. The whole process is not transparent nor open to public to participate.

2. The Setup of Central Police Station Heritage Taskforce

- 2.1 In view of the above, Central Police Station Heritage Taskforce was set up and allied by Hong Kong Institute of Architects, Conservancy Association, Hong Kong People's Council for Sustainable Council, LIVE.Architecture Programme, Department of Architecture of The Chinese University of Hong Kong, Central and Western District Development Concern Association, The American Institute of Architects (Hong Kong Chapter), Action Group for the Protection of Central Police Station Historical Compound and other parties/individuals.
- 2.2 The Taskforce aimed at collaborating to advocate for an open and participatory tendering, assessment and monitoring process for Central Police Station Project, which should be considered for heritage conservation as priority rather than tourism development.
- 2.3 In achieving so, the Taskforce issued letters to the Chief Executive and The Secretary for Economic Development and Labour regarding our position in the above issues (Appendices 4 & 5 refer). In addition, we organised a public survey

and a Round Table Forum in September to let the public have a better understanding of the current tender and assessment mechanism and solicit their opinions and comments. The public opinions and comments are recorded in this Supplementary Report for due consideration by the Government before deciding to proceed with the tendering.

3. Public Survey

3.1 Introduction

- 3.1.1 This is a survey, which was published on local newspapers and websites of the Taskforce organizations on 20 September 2004, open to the public to express their views on the following statements (Appendix 3 refers):
 - (1) Comprehensive and long-term heritage conservation should be an overriding principle in the beneficial use of the Central Police Station Complex.
 - (2) Provided that long-term government subsidy is not required, seeking maximum land premium should not be an objective of the Government in the beneficial use of heritage sites.
 - (3) Having satisfied the criteria of heritage conservation and financial selfreliance, the proposal which offers maximum social and community benefits should be selected in a competitive process.
- 3.2 Results of the Survey
- 3.2.1 Within one week and up to 4 p.m. on 28 September 2004, the Taskforce received a total of 328 replies. The table below shows the results of the Survey up to this point :

3.2.2 The results demonstrated the **predominant** public opinions that they agreed that Central Police Station should receive the absolute respect and attention for conservation in the tendering. In addition, while maximum financial benefits should not be the factors that we should pursue, social and community benefits are more preferred to carry important weights in the tendering.

4. Round Table Forum

4.1 Introduction

- 4.1.1 The Taskforce organized a Round Table Forum on 25 September 2004 at Hong Kong Design Centre, 28 Kennedy Road, in order to provide an opportunity for different sectors to discuss and explore the principles and ideas on how should the tender and assessment mechanism should be for the Central Police Station under a participatory process. Appendix 6 shows the photo records of the Round Table Meeting.
- 4.1.2 As a result of the invitation exercise, more than 40 people from different backgrounds attended the Round Table Forum, including:
 - (1) Legislative and district councillors;
 - (2) Cultural and artistic organizations representatives;
 - (3) Government Department representatives;
 - (4) Professionals;
 - (5) Civic societies representatives; and
 - (6) Developers, etc.
- 4.1.3 They were divided into two groups to discuss the following four main issues and concerns:
 - (1) Heritage Conservation: Has it received sufficient attention?
 - (2) Public Engagement: Is it enough to reflect public interest?
 - (3) Tender Process: Will it encourage innovative proposals to serve the best public interest?
 - (4) Institutional Mechanism: Who makes decision? Who monitors progress and compliance?
- 4.2 Suggestions from Participants
- 4.2.1 Heritage Conservation
 - (1) Heritage conservation was considered to be very important in this case that it is necessary to get the Central Police Station Project right and proper in conservation terms. Nonetheless, there is at present no comprehensive conservation or preservation policy in Hong Kong.
 - (2) Suggestions on the overall conservation policy:
 - The declared heritage buildings on Central Police Station site should be regarded as a totality in terms of conservation.
 - When the original usage of these heritage buildings is no longer feasible, alternative uses should be considered.

1 - X - A

- Mixed use for the heritage buildings is proposed and a balance between cultural and commercial uses should be struck. An arts centre would be a good idea as there should be an education component.
- Some participants agreed that the heritage buildings should embrace and endorse a "heritage and tourism" theme, with older buildings converted to new uses whilst retaining the character, features and material decoration of the existing buildings.
- Some participants felt that heritage conservation, tourism and commercial benefits are not mutually exclusive. A strong "identity" to the area could generate widespread interest from visitors and tourists and that there would be considerable long-term benefits to Hong Kong. In addition, successful heritage conservation would also bring indirect benefits to the whole community. Hence, tourism success could follow from a successful "heritage conservation project" while it may not be necessarily successful as a tourism project.
- It is necessary to ensure that adequate funding would be available to properly repair and restore buildings in poor conditions.
- There could be a scope for non-heritage buildings to be replaced to allow additional GFA provided that the additional GFA is well integrated with the conservation approach above.
- (3) The need for Government's re-conceptualisation:
 - The Government should re-conceptualize that heritage conservation, as opposed to tourism development, should be put at a predominant priority.
 - A fundamental objective is that the Central Police Station Project should be for sustainability to the area and not for maximum profit making.
 - The local community should be benefited from heritage conservation. Therefore, it should be a community project as well.

4.2.2 Public Engagement

- (1) Setting down principles relating to the public's ownership of the project:
 - The community should be involved in the whole process. It is considered important that the public at large should be given opportunity to express their views and ideas.
 - A conservation plan is of high educational value to the general public. It should be regarded as public and cultural knowledge but not treated as commercial secrets or tender confidential materials.
 - Heritage buildings are community assets. Any projects when completed should be accessible by the general public.
- (2) The engagement of the public:
 - The community should be involved in the formulation of the design brief and the tender assessment.
 - Government should follow up with the results and suggestions raised from the previous public consultation.

- There is a need for an objective system for the public to express their views and ideas and the process needs to be simple. This might for example involve an open day at the Central Police Station with an exhibition to explain ideas and facilitate comments.
- Public views and comments need to be carefully orchestrated so that the community reference or key concerns can be included as genuine parameters or criteria to be considered in the tender exercise and evaluated accordingly.
- An objective to strive to a diversity and variety of uses with a dynamic mix of different and compatible elements would promote dialogues with the community.
- Engagement of the public should be a facilitated exercise rather than an open-ended one. Views could for example be structured around specific aspects relating to community uses and open space; pedestrian access and circulation; culture and heritage; integration with wider district; and special features.

4.2.3 Tender Process

(1) Problems of the existing proposed tender process:

- The former Marine Police Headquarters tender has not been handled well, and there is experience to be gained from this in terms of the overall approach, the establishment of proper site development and design parameters, assessment of historical and cultural significance as well as the means of ensuring compliance with development conditions that have been set.
- The tender mechanism, as set out at present, is too simplistic, offering only a marginally different approach from standard land tenders with little or no design control and too great an emphasis on financial return to the Government for what are existing public assets.
- The existing tender mechanism is too crude. Government should ensure the process should be operated in a hurry manner.
- A 60:40 weighting in the tender decision making process, almost inevitably means that a strong financial bid will win over heritage conservation, environmental, community and tourism benefits.
- It is felt that the tender should be put on hold until these aspects are addressed.

(2) Suggestions on tender and assessment criteria:

- Heritage conservation should have much higher weighting in assessment and even be considered in every part of the assessment.
- Land premium should not be part of the consideration. The approach should nil premium through or similar to, a Private Treaty Grant.
- The financial component will not be material to the tender assessment process and the financial bid accompanying the successful design would only be opened upon selection of the best planning and design tender. It

would however be necessary to ensure that sufficient funding was in place to carry out the scheme and to meet all prevailing conditions.

- While "heritage" should be regarded as an overriding issue, income for the development must be sufficient to account for outgoings related to implementation, management and maintenance.
- "Non-profit" bodies should be encouraged to submit tenders and not feel excluded because of a financial imperative. However there is equally a view that commercial management and responsibility is important in ensuring a strong image, wide visitor use and tourist "recognition".
- The tender should encourage innovative ideas.
- The conversion of groups of listed buildings and integration of new urban spaces, access and circulation must be responsive to public use and enjoyment with a strong sense of communality within a strong spatial and organization concept, focusing on the civic potential of the area.
- There should be sufficient guiding principles or urban design criteria which can both guide tenderers in preparation of submissions, and also help in the assessment. These criteria in form of an articulate set of pointers should be identified and agreed.
- Professional groups could help to set out the most important parameters. In addition to conservation, heritage and functional use factors, the urban design factors could include the introduction of elements that define the identity and image of the place; the creation of memorable landmarks and focal points; ease of circulation, permeability and legibility; positive links with adjoining streets and spaces, etc.
- Public voting at public exhibitions should carry some weight in the tender assessment.
- The tender document should clearly state the detail GFA of public facilities.

(3) Suggestions on tender process:

- The tender process should be transparent, fair and equitable.
- More communication between different Government Departments prior to tendering.
- During tender preparation stage, the community and experts should be allowed to visit and inspect the heritage buildings.
- A design, layout, heritage conservation and operational plan should be submitted to a "Jury".
- Tenders will be carefully evaluated against all criteria and parameters.
- Pre-assessment and Pass-assessment should be made.
- Pass-assessment should be set at zero and any scheme failing to meet minimum standard should immediately be rejected. Marks should only be given for the scheme exceeding the standard.
- Tender proposals should be exhibited to the public.

4.2.4 Institutional Mechanism

- (1)Problems of the existing institutional mechanisms:
 - There is at present no obvious organizational mechanism in the Government to effectively handle such complicated schemes. There is no single Bureau or Minister particularly responsible which results into the simplicity of the tender mechanism.

(2) Suggestions on institutional mechanisms:

- The tender assessment panel should comprise local representatives, professionals and public. Government officers should not be the only members in the panel.
- "A Jury" would be appointed in a no dissimilar way to a competition jury with officials and experts covering all aspects of the tender.
- Independent Monitoring Committee composed of professionals, public and government officials should be set up to monitor the development and running of the heritage complex. Provisions should be made for the establishment of the Committee.
- The stakeholders / concerned parties can continue to monitor the tender arrangement through the legislative / district councilors.
- Creation of a heritage trust is proposed to conserve the heritage in Hong Kong and manage the Central Police Station Project in a sustainable way.

4.2.5 Examples of Successful Heritage Conservation Projects

At the Round Table Meeting, some participants suggested some successful examples, which can be made reference to Central Police Station Project. The commercial, cultural and community success of these examples are worth learning for the generation of assessment criteria and evaluation principles for Central Police Station. These successful examples include:

- (1) Fringe Club in Central, Hong Kong
- (2) Fulton Market in New York, USA
- (3) Faneuil Hall Marketplace in Boston, USA
- (4) Covent Garden in London, United Kingdom
- (5) Conversion of old educational buildings in Christchurch, New Zealand
- (6) Conversion of industrial buildings in Sydney, Australia

Convent Garden in London was established under public participation efforts. It now becomes an icon for London and helps revitalize the area in the close proximity. Learning from this example, Hong Kong should aim at making the Police Station an icon project for Hong Kong as well.

5. Media Reports

5.1 The Media Coverage of Central Police Station Project

Further to the Government's announcement that Central Police Station will be put for tender, quite a lot of reports on TV, radio and newspaper companies, namely Ming Pao, Sing Tao Daily, Sing Pao, Ta Kung Pao, Wen Wei Po, Hong Kong Commercial Daily News, Apple Daily, Oriental Daily etc. have been made. Central Police Station Site Views / Suggestions for reflection to Government

- 1. Noting that the Central Police Station, Victoria Prison and the Former Central Magistracy form together a site composing of adjoining buildings as declared monuments, the future use of the compound as an integrated entity should be considered as a totality and development options should be considered and compared through an open and transparent decision-making system and with the full involvement of the Antiquities Advisory Board to ensure the integrity of the original historic building and settings, including trees, paths and associated features. Irreversible damages to the declared monuments and their settings must be avoided and demonstrated prior to issuing tenders. There should have been indicative feasible conceptual schemes accepted by the society/ public prior to invitation for tender; and should not be over-relied on proponents'/developers' proposals in order to strike the appropriate balance.
- 2. More public forums / seminars should be held to brief the public on the fundamentals of the project and option studies, and to get the public's views on the important issues prior to tender.
- 3. Whilst it is supported to tap the non-government/ private sector resources and innovative ideas for projects with commercial potential, the option of having a charitable Trust to develop/ run commercial and/ or non-commercial uses in the compound should also be carefully considered and compared, and if viable, should also be open to acceptance. The process should not over-emphasize too much on the financial feasibility/ commercial benefits of involving the developers.
- 4. The Government is urged to engage the community public and professionals more in the whole tendering process, including pre-tender brief formulation/ broad options evaluation as well as post-tender public exhibitions, public hearings and presentations in order to have a more transparent, fair and open process with public participation. The composition of the Assessment Panel should include public representatives, academics, business, district leaders as well as government officials.
- 5. The Government should make known to and seek opinions from the public about the criteria for assessing the future proposals, including the weighting basis in order to reflect the community aspirations for the future of the heritage buildings prior to tendering. Important factors such as
 - the compatibility to the institutional background of the compound/ surrounding context;
 - accessibility to the public and tourists to the compound;
 - design merit of harmonious relationship with the original historic buildings and setting with minimum disruption/ demolition

should be included and given significant proper weighting in the assessment criteria.

In view of the heightened community concerns over the conservation of the Central heritage buildings comprising the Central Police Station, former Central Magistracy and Victoria Prison, we are pleased to advise that a "Central Police Station Heritage Taskforce" has been established with the following organisations as founding members:

- The Hong Kong Institute of Architects
- The Conservancy Association
- Hong Kong People's Council for Sustainable Development
- Department of Architecture, The Chinese University of Hong Kong
- Other Civil Societies

The objectives of the Taskforce are to encourage public participation in the envisioning, planning and monitoring of the project, and to advocate a heritage-focused tendering process so as to ensure long-term conservation of the complex. Whilst we do not have any preference to any particular development proposal, we believe that the current process is unable to encourage innovative proposals that may lead to long-term conservation of the complex. It is therefore important that a public engagement process be instigated to ascertain what are the public aspirations and public interest at stake in this project.

As a first step to the much-needed public engagement exercise, we shall organise a Roundtable discussion on September 25. A number of newly-elected Legco councillors and community leaders from the district, professional bodies, business representatives and NGOs will be present. They will examine the many issues and concerns of the current tender system as well as make recommendations on the way forward.







中區警署倡招標前開放 民間圓桌會議 促政府增公衆參與

【明報專訊】中區警署古蹟關注組昨舉行圓桌會議,逾40名社會人士出席,包括前布政司鍾逸傑、候任 立法會議員、政府官員及民間團體代表。歷時3小時的會議,與會者一致要求政府增加公衆參與程度,讓 公衆參與制訂古蹟群的概念和招標評審過程。中區警署今日起陸續停止運作,關注組建議政府開放市民參 觀,讓公衆親身感受古蹟群的保留價值。

由建築師學會、長春社、中西區發展開注社 等組成的中區警署古蹟關注組,昨舉行三小時圓 桌會議,參加者包括富商何東後人何猷忠等逾四 十人。關注組發言人吳永順會後説,大會認為當 局改建中區警署時,應視保存文化為先,不應該 過份重視土地售價等經濟效益:「政府搞數碼 港、文化設施,最後都會變成地產項目!」

讓市民認識本地文化

中大建築系教授林雲峯説,當局應將已經停 用的中區警署,開放給市民參觀:「等市民可以 了解同認識本地文化,感受吓應唔應該保留呢個 地方。」

【本報訊】(記者 伍敏婷)中區警署古蹟關注 組昨日舉行會議,邀請各界專業人士就中區警署 的發展表達意見。關注組促請政府重新檢討中區 警署的招標及審批方式,包括減低以地價作為招 標評分的比率,並建議政府以保育文物作為「凌 駕性」原則。政府表示十分關注事件,已把招標 日期押後,並廣泛諮詢外界意見。

由建築界及環保關體組成的中區警署關注組與旅遊事務署 官員會面,討論中區警署古廣群的未來發展規劃。香港建築 師學會候任主席吳永順表示,中區**警署一帶是香港唯一一個** 大型的文物建築群,當中的17座建築物極具歷史價值,他反 對政府將古跡文物與商業利益掛帥。「現行計劃中,土地收 益佔招標評分40%,保育文物環節只佔20%,這恐怕文物保育 會變成地產發展項目,數碼港如是,現在文物保護又如是。] 關注組認為,政府應全面檢討中區警署的招標及評審方式, 並建議政府把「古龍增值用途」及「社會及社區效益」等因 素包括在內(**詳見下表**)。

政府稱須考慮經濟回報

關注組引述旅遊事務署代表Mr Duncan Pescod說,政府對事 件持開放態度,若大眾認為應重新檢討評審方式,當局亦願 意配台。但他強調,政府亦需顧及項目發展的經濟回報,以 及能否提供就業機會。吳永願說:「政府並非堅決維持原有 方案,亦非與民間意見對立,這從他們願意押後招標日期可 見。」

香港可持續發展公民議會主席黎廣德建議,政府在進行正 式的招標方式前,要認真考慮此為旅遊發展項目還是古蹟文 物保育用途。他又認為,古蹟的使用應以不需公帑長期補貼 為原則,並且邀請公眾發表意見。

中大建築系教授林雲峰表示,政府應將中區營署開放給市 民参觀,並举行工作坊,應取他們意見後才決定招標內容。
