I. Election of Chairman and Deputy Chairman

Election of Chairman

Mrs Selina CHOW LIANG Shuk-yee, the member who had the highest precedence in the Council amongst those who had joined the Panel, presided at the election of the Chairman of the Panel for the 2004-05 session. Mrs CHOW invited nominations for the chairmanship.

 - (c) Interim Housing Policy.
- 10. <u>Members</u> also agreed that the following items should be included in the Panel's list of outstanding items for discussion
 - (a) Procurement of cleansing services for public rental housing estates (to be discussed at the December meeting); and
 - (b) Disposal of surplus Home Ownership Scheme and Private Sector Participation Scheme (PSPS) flats, especially those of the Hunghom Peninsula PSPS project.
- 11. <u>Members</u> further agreed that to facilitate the preparation of relevant information papers, the Administration should be made aware of the Panel's intention to discuss the above two items shortly.
