**Joint meeting on 28 February 2005**

**Proposed procedures for handling the motion on  
Development of heliport facilities in Hong Kong**

- (a) The Chairman invites Mr Howard YOUNG to move his motion;
- (b) The Chairman calls on Mr Albert CHAN, Dr Raymond HO, Mr CHAN Kam-lam and Miss CHOY So-yuk to speak, if required;  
  
[Through application of Rule 34(5) of the Rules of Procedure, the Chairman ruled that Mr Albert CHAN be called to move his amendment first, to be followed by Dr Raymond HO and Mr CHAN Kam-lam];
- (c) The Chairman calls on other members and the Administration to speak on the motion and the proposed amendments, if required;
- (d) The Chairman invites Mr Albert CHAN to move his amendment to the motion, and forthwith proposes and puts to vote the question on Mr Albert CHAN's amendment;
- (e) After Mr Albert CHAN's amendment has been voted upon, the Chairman deals with the remaining amendments;
  - (i) if Mr Albert CHAN's amendment is carried, the Chairman invites Dr Raymond HO to move his revised amendment, and forthwith proposes and puts to vote the question on Dr Raymond HO's revised amendment;
  - (ii) if Mr Albert CHAN's amendment is negated, the Chairman invites Dr Raymond HO to move his original amendment, and forthwith proposes and puts to vote the question on Dr Raymond HO's original amendment;
- (f) After Dr Raymond HO's amendment (original or revised) has been voted upon, the Chairman deals with Mr CHAN Kam-lam's amendment to the motion and Miss CHOY So-yuk's amendment to Mr CHAN Kam-lam's amendment;
  - (i) if Dr Raymond HO's amendment (original or revised) is carried, Mr CHAN Kam-lam may not move his amendment;

and the Chairman then puts to vote the question on Mr YOUNG's motion as amended by Mr Albert CHAN and/or Dr Raymond HO, as the case may be;

(Mr CHAN Kam-lam has indicated that if Dr Raymond HO's amendment is carried, he will not propose any revised amendment.)

- (ii) if Dr Raymond HO's *original amendment* is negated, the Chairman invites Mr CHAN Kam-lam to move his amendment and Miss CHOY So-yuk to move her amendment to Mr CHAN Kam-lam's amendment, and forthwith proposes and puts to vote the question on Miss CHOY So-yuk's amendment. After Miss CHOY So-yuk's amendment to Mr CHAN Kam-lam's amendment has been voted upon, the Chairman deals with Mr CHAN Kam-lam's amendment or revised amendment to the motion;
  - (iii) if Dr Raymond HO's *revised amendment* is negated, (since in that case, Mr Albert CHAN's amendment must have been carried) Mr CHAN Kam-lam may not move his amendment and will not propose any revised amendment;
- (g) After all amendments have been dealt with, the Chairman then puts to vote the question on Mr YOUNG's motion or his motion as amended by other member(s), as the case may be.
