Proposed discontinuation of the West Rail second 10% discount	26.11.04	At the meeting, the Panel passed two motions objecting to KCRC's decision to cancel the West Rail's second 10% discount upon its expiry in mid December 2004 and urging the Government to request KCRC to make it permanent the various existing fare concessionary schemes pending a review to be conducted after the commissioning of the Kowloon Southern Link.	Supplementary information paper provided by the Administration on West Rail's second 10% discount and other fare concessions was issued vide LC Paper No. CB(1)542/04-05(01).
3. Measures to enhance road safety and safety of public light bus operations	14.12.04	At the meeting, the Panel passed a motion urging the Administration to adopt all possible and practical measures to improve the design of road junctions and the display of traffic light signals to ensure the effective detection of deliberate red-light jumpers before considering raising the driving offence points against such offences.	Progress report from the Administration awaited.
4. Ma On Shan Rail (MOSR) fares and environmental impacts arising from the railway's operation	17.12.04	At the meeting, KCRC agreed to provide, after one month of the commissioning of the MOSR, a written report on all the measures it had taken to mitigate the noise and other environment impacts of the MOSR. KCRC should also provide the design of the additional noise barriers to be installed at the Shatinpark section when such was available.	Progress report from KCRC awaited. The Subcommittee on matters relating to railways will discuss the operational issues of Ma On Shan Rail on 4 March 2005.

Proposed introduction of the probationary driving licence scheme to private cars and light goods vehicles</p>	<p>17.12.04</p>	<p>At the meeting, the Administration agreed to provide the following information-</p> <ul style="list-style-type: none"> (a) the accident involvement rates of private cars and light goods vehicles (LGV) expressed in terms of vehicles; (b) a breakdown of the accident involvement rates of LGVs by different durations of driving experience; (c) a breakdown of the accident involvement rates by different types of LGVs in terms of the weight of the vehicles (i.e. light goods vans, goods vehicles of about 3.3 tonnes and goods vehicles of about 5.5 tonnes); (d) relevant overseas practices regarding restrictions imposed on new drivers of various types of vehicles, in particular the requirement to carry "P" plates; (e) explanation on why the accident involvement rates of first-year private car drivers in the past five years were much higher than those of first-year LGV drivers. <p>The Administration was also requested to make a comprehensive assessment on the impact of the "P" plate requirement on the employment of novice LGV drivers. The assessment should cover both existing novice LGV drivers and future new entrants to the trade.</p> <p>The Panel agreed that it would further discuss the subject upon receipt of the above information</p>	<p>Information from the Administration awaited.</p>

Review of measures to combat inappropriate driving behaviour	17.12.04	<p>The Administration was requested to provide relevant overseas legislation on tailgating and the related prosecution statistics including the successful rate of prosecution.</p> <p>In connection with the information on “Penalties imposed on drink-driving in overseas countries” provided in the Administration’s paper, the Administration was requested to confirm whether there were differences in the sanction between drink-driving without resulting in personal injury and drink-driving resulting in personal injury and/or death, and if so, to provide the relevant details.</p>	Information from the Administration awaited.
7. Highways Department’s Directorate Staffing Proposals	17.12.04	The Administration had undertaken to provide supplementary information to address members’ concerns and to review the need for the conversion of the supernumerary Chief Engineer/Technical Services post to a permanent post.
