# FIXED PENALTY (PUBLIC CLEANLINESS OFFENCES) ORDINANCE (AMENDMENT OF SCHEDULE 2) ORDER 2005

## **INTRODUCTION**

At the meeting of the Executive Council on 22 February 2005, the Council ADVISED and the Chief Executive ORDERED that:-

- (a) under section 135 of the Magistrates Ordinance, the MagistratesOrdinance (Amendment of Fourth Schedule) Order 2005, at Annex A;and
- (b) under section 19 of the Fixed Penalty (Public Cleanliness Offences)
  Ordinance, the Fixed Penalty (Public Cleanliness Offences) Ordinance
  (Amendment of Schedule 2) Order 2005, at Annex B,

should be made to specify the ranks of public officers of Leisure and Cultural Services Department (LCSD) in the respective schedules under these Ordinances to maintain consistency and to remove certain references to obsolete ranks from these Schedules.

## JUSTIFICATIONS

2. It is the legislative intention that all ranks of the LCSD grades listed in the Schedules have the related law enforcement power and responsibilities. It is however noted that some departments, such as Food and Environmental Hygiene Department and Housing Department, etc., have specified the ranks of the public officers in the Schedules instead of listing out the grades. In order to remove ambiguity, it is advisable for LCSD to specify the ranks of Amenities Officer, Amenities Assistant, Leisure Services Manager, Recreation and Sport Officer, Curator, Cultural Services Manager and Librarian grades in the Schedules.

3. With the merger of the Amenities Officer grade and the Recreation and Sport Officer grade into the Leisure Services Manager grade in September 2002, there remains only a few officers staying at the obsolescent ranks of Amenities Officer I, Amenities Officer II and Assistant Recreation and Sport Officer II that are required to be included in the Schedules.

4. Since there is no more Senior Foreman or Foreman in LCSD, opportunity is taken to delete them from the Schedules.

#### THE ORDERS

#### **Magistrates Ordinance (Amendment of Fourth Schedule) Order 2005**

5. The Magistrates Ordinance empowers a public officer specified in the Fourth Schedule to the Ordinance to serve on a person who is suspected of having committed an offence specified in that Schedule personally a notice requiring him to appear before a magistrate. Section 135 of the Ordinance empowers the Chief Executive in Council to amend the Fourth Schedule by order published in the Gazette. The Order repeals and substitutes the entry relating to LCSD in order to bring up to date the list of public officers in LCSD who are empowered to serve the notice under the Ordinance. The existing Schedule being amended is at Annex C.

# Fixed Penalty (Public Cleanliness Offences) Ordinance (Amendment of Schedule 2) Order 2005

6. The Fixed Penalty (Public Cleanliness Offences) Ordinance empowers a public officer specified in Schedule 2 to the Ordinance to give a person, whom he has reason to believe is committing or has committed an offence described in Schedule 1, in person a notice, offering that person an opportunity to discharge the liability to conviction for that offence by payment of a fixed penalty. Section 19 of the Fixed Penalty (Public Cleanliness Offences) Ordinance provides that the Chief Executive in Council may, by order published in the Gazette, amend Schedule 2 thereto. The Order updates the list of public officers in LCSD who are empowered to give the notice under the Ordinance. The existing Schedule being amended is at Annex D.

## **IMPLICATIONS OF THE PROPOSAL**

7. As the proposal aims to clarify the law enforcement powers and responsibilities conferred to designated public officers in LCSD, it has no financial and civil service implications. The proposal is in conformity with the Basic Law, including the provisions concerning human rights. It has no productivity, environmental, economic or sustainability implications. The proposal does not affect the binding effect of the Magistrates Ordinance and the Fixed Penalty (Public Cleanliness Offences) Ordinance.

### **PUBLIC CONSULTATION**

8. The proposed amendments are technical in nature and are meant to clarify the legislative intention of empowering the listed public officers with the

relevant responsibilities. Public consultation is not considered necessary.

# PUBLICITY

9. The Orders will be published in the Gazette on 4 March 2005 and tabled at the Legislative Council for negative vetting on 9 March 2005. A spokesman will be available to answer media enquiries.
