Why a review? 爲何要檢討?

■ Last DC Review in 2001 上一次區議會檢討: 2001年

■ Current review initiated in 2004 Policy Address 這次檢討於2004年施政報告中首次提出

2005-06 Policy Address - CE announced District Councils (DCs) would assume responsibility for management of some district facilities and implementation details will be worked out in the on-going DC review

於2005-06年施政報告中,行政長官宣布會讓區議會參與管理一些地區設施,並會在已展開的區議會檢討中落實

Parameters for the Review 進行檢討時,須以下列各點爲依據:

- Existing legal provisions relating to DCs 有關區議會的現行法律條文:
 - ➤ Article 97 of Basic Law which provides that DCs shall not be organs of political power 《基本法》第97條規定區議會不得爲政權性組織
 - ➤ Section 61 of the District Councils Ordinance which sets out the functions of DCs 《區議會條例》第61條列明區議會的職能

 Existing powers and responsibilities of the relevant statutory authorities responsible for the delivery of district services, e.g. the Public Health and Municipal Services Ordinance

The need for a prudent and gradual approach to ensure no disruption to the delivery of public services at the district level

Enhancing Work in Districts

- Aim to enhance communication between the Admin & DCs and institutionalise support for DOs and DMCs
 - 目的:加強政府和區議會的溝通,並爲民政事務專員及地區管理委員會的工作提供有組織和有效的支援
- Set up a Steering Committee on District Administration chaired by SHA/PSHA with direct access to Policy Committee to resolve cross-departmental issues 設立由民政事務局局長/常任秘書長出任主席的地方行政督導委員會,並可把跨部門問題呈交政策委員會處理
- Designated Heads of Departments to take turns attending DC meetings
 - 指定部門首長輪流出席區議會會議
- CE to host an annual District Administration Summit 行政長官主持周年地方行政高峯會

Enhancing Work in Districts through Partnership 透過伙伴關係加強地區工作

Aim – to enhance work in districts and foster harmony in society

- encourage DCs to partner with other sectors, e.g. NGOs, voluntary and business organisations 鼓勵區議會與各界別(如非政府機構、志願及商界團體)合作
- Worthy programmes already implemented in some districts: create employment, highlight district features 部份地區已在實施一些有意義的計劃,例如創造就業機會或強調地區色彩的計劃
- DCs to draw up collaboration proposals with district characteristics

Financial and Staffing Implications 對財政及人力資源的影響

- A dedicated capital works block vote for district minor works with annual provision of \$300 million (and operational expenses of \$10 to \$15 million for managing and maintaining new/improved district facilities)
 - 設立每年3億元的基本工程整體撥款,以推行地區小型工程 (另會撥款 1,000至1,500萬元作營運開支,以支付有關工程的管理和維修)
- An annual provision of \$300 million for DC Funds to undertake programmes/activities in district and community involvement projects
 - 增加區議會撥款至每年3億元以便區議會於地區設施內舉辦活動及推行社區參與計劃
- Additional expenditure estimated at \$48.9 million per year and \$41 million per (4-year) term to improve the DC members'remuneration package
 - 爲改善區議會的薪津,每年的額外開支約爲4,890萬元及每一屆的額 外開支爲4,100萬元
- Some additional staff in LCSD/HAD to support DCs 康文署/民政署需增加一些人手以支援區議會

Advantages of the Dedicated Capital Works Block Vote for District Minor Works

以專用的基本工程撥款推行地區小工程的好處

- One single funding source replacing three different funding sources each with its own process of planning and implementation (namely, Urban Minor Works, DC Funds and central vote under ArchSD)
 - 以單一撥款取代現時各有不同計劃及推行機制的撥款方式(包括市區小工程、區議會撥款及建築署的中央整體撥款)
- Funding certainty for DCs to plan and undertake district works 為區議會策劃及推行地區工程提供穩定的財政來源
- Scope to cover district facilities and district works throughout the territory up to \$15 million per project 可在全港推行一千五百萬或以下的地區設施及工程計劃

Composition of DCs

On the basis that there should continue to be appointed and ex-officio seats for DCs for the term commencing in 2008, we invite the public to offer views on the future composition of DCs having regard to the following considerations:

在2008年開始的新一屆區議會應繼續有委任和當然 議席的前提之下,我們歡迎公眾人士基於以下的考 慮對日後區議會的組成提供意見:

- (a) DCs' role in ensuring efficient delivery of services at district level 區議會在確保有效提供地區層面的服務方面擔當的角色
- (b) Appointed members have made constructive and useful contribution to the work of DCs over the years

DC Election-related Matters 與區議會選舉相關的事宜

- To schedule the polling day in December instead of November in future DC elections in order to shorten the suspension period and minimize the impact of suspension on the discharge of DC duties 將投票日安排在12月而非11月舉行,以縮短區議會的暫停運作期,從而盡量減少暫停運作對區議員履行職務所造成的影響
- To introduce a financial assistance scheme for DC election candidates at the rate of \$10 per vote 推行區議會選舉候選人財政資助計劃, 資助額爲每票十元
