

隧道截查 悍匪發難

兩警中槍命危

發

生開槍事件現場位於柯士甸道港景峯對開一條通往柯士甸道西的行人隧道內。現場初步消息稱，事發時兩名軍裝警員在行人隧道入口發現一名可疑男子，兩警員上前截查時，男子突然反抗發難及搶奪警槍，糾纏間發出多響槍聲，兩名軍裝警員分別頭部及腳部中槍，疑人亦身體中槍，各人傷勢嚴重，分別由兩輛救護車急送伊利沙伯醫院搶救，其中中槍疑人送院途中已無呼吸脈搏，抵達急症室診治後證實不治。

查有否目擊者

大批警員今晨在現場一帶搜索有否其他在逃可疑人及證物。由於事件涉及警員中槍及懷疑搶奪警槍，警方事後派出約一百名軍便裝警員到場封鎖行人隧道及現場附近一帶路面，及進行地毯式搜索，並向附近市民店舖職員查詢有否目擊案發經過。中槍送院兩名軍裝警員均頭部染有鮮血，送院時需要氧氣罩

幫助呼吸，大批警員事後趕赴醫院了解事件經過。

中槍兩名警員的親人及同袍今晨亦趕抵醫院了解情況，各人表現悲傷。

案件暫交回西九龍總區重案組接手調查，但有組織罪案及三合會調查科高級警司蘇錦成今晨二時亦親自帶隊到場視察現場環境。

疑犯中槍死亡

案發時一名最快趕抵現場的警長，目睹兩名下屬同僚分別中槍浴血倒地，一度落淚，表現悲痛。

警方事後在現場帶走兩名可能目擊案發經過的巴基斯坦籍男子返署助查。

由於現場曾傳出多響槍聲及三人身中多槍重傷，警方不排除中槍死亡疑人身上當時懷有槍械。

其中一名中槍警員冼嘉強，另一人編號五一六×六。而中槍身亡可疑男子年約三十歲，警方正全力偵查死者身份。

襲警兩兇徒逍遙法外

記憶猶新

尖沙咀兩名警員被兇徒搶槍後中槍重傷案，是去年七月警員朱振國在長沙灣街頭被可疑男子以生果刀插頸重傷以來，最嚴重的一宗警員遇襲案；至於零一年三月警員梁成恩墮入兇徒的圈套，被人搶去佩槍，近距離被連轟五槍斃命，則令人記憶猶新。上述兩單案件至今尚未偵破，兇徒仍逍遙法外。

朱振國遇襲八月仍留醫

○一年三月十四日，隸屬梨木樹警署的廿五歲警員梁成恩，前往荃灣石圍角邨石桃樓五樓處理一宗噪音投訴時，誤中兇徒布下的「死亡圈套」，梁上樓後被人偷襲及搶去佩槍，

跟着近距離被連轟五槍斃命，他的警槍、快速入彈器及六發後備子彈亦同時失去。案發後，警方對案件極度關注，即時懸紅一百萬元緝兇，惟事隔四年多，兇徒仍逍遙法外。

去年七月十九日，一名行「單叻」巡邏的軍裝警員朱振國，在長沙灣保安道單對單截查一名可疑男子的證件時遇襲，遭歹徒以一把七吋長的生果刀插頸，男子行兇後逃去，警員負傷窮追四十米終不支倒地。

由於頸部動脈被戳穿，血如泉湧，醫生立即搶救，將警員大動脈孔洞縫合及輸入三包血液後送院。案發時三十歲的朱振國接受治療多月後，目前仍然在醫院留醫。

「案中案」遭轟斃 一支失槍四條命 警殺同袍涉梁成恩血案



五年前慘被奪槍轟殺的警員梁成恩，在死忌的第三天，再爆發慘烈槍戰。兩名「孖必」巡警，昨晨尖沙嘴一行人隧道「簽簿」時，遭冷血殺手伏擊，殺手閃電開槍轟斃一警後，再與另一警駁火，該警中槍命危，悍匪則死於亂槍下。警方事後揭發，殺手是現役警員，而他所使用的，竟是梁成恩之佩槍，懸案雖露曙光，但卻再有兩警身亡。

本報突發組

尖沙嘴警匪槍戰駁火十響，疑涉槍殺梁成恩奪槍的疑匪被轟斃。疑匪本身亦是警員，疑有人因「懷才不遇」，不甘升職落空致滿腔怨憤，加上炒樓欠債鋌而走險，○一年涉嫌布局殺警奪槍，打劫銀行槍殺護衛，昨不排除重施故技，戴假髮易容，企圖殺警奪槍再打劫，但在駁火中死於警槍下。

疑易容圖奪槍再行劫

喪生疑匪徐步高（三十五歲），駐守大嶼山竹篙灣警崗，曾與梁成恩

同隸屬梨木樹警署，與梁認識，昨晨槍戰後，警方發現他使用的生鏽左輪警槍，疑是梁的失槍，槍支編號雖被磨花，但可認出三個號碼相同，加上警隊只有一枝警槍未尋回，懷疑他與○一年槍殺梁成恩及荃灣麗城花園恒生銀行被劫，槍殺護衛員案有關。

殉職警眉心中槍亡

殉職警員曾國恆（三十三歲），眉心中一槍，子彈貫穿頭部死亡，他在案中未發一槍，慘被悍匪先開槍擊斃。與匪駁火中槍重傷警員冼家強

（二十八歲），面部及腿部各中一槍，情況由危殆轉為嚴重，他在槍戰中共開六槍，其中四槍命中疑匪。

徐步高在槍戰中共開四槍，其中三槍命中兩警員，而他頭部中一槍，身中三槍，而梁成恩當日被奪去佩槍及十二發子彈，兇手用其佩槍殺他及其打劫銀行殺護衛合共用了八發子彈，餘下四發子彈疑昨在槍戰耗盡。

殺警槍戰案現場是尖沙嘴廣東道與柯士甸道交界的行人隧道，日間行人眾多，夜後變得僻靜，雖非罪惡黑點，仍設警員簽到簿，附近尖沙嘴警署警員多在出更或回警署小休時，順道往該處簽簿。

隧道簽簿突遭射擊

昨晨零時許，有人將客貨車停泊官涌街，背着斜頂袋步行往現場行人隧道徘徊，戴上假髮。至凌晨一時許，兩名巡邏警員吃完小食，往現場隧道簽簿，突被人開槍射擊，警員曾國恆慘被一槍擊中眉心，同行警員冼家強拔槍還擊，與槍客近距離駁火。

槍客與冼皆將槍內子全部發射，亦同告中彈浴血，冼在昏迷前拉動對講機緊急掣，大批警員趕至，將三人急送伊利沙伯醫院，但其中兩人抵院時證實不治，冼重傷留醫。

現場檢獲三枝手槍，其中槍客的左輪疑是梁成恩的失槍，警方並檢獲疑匪的警員委任證，警察俱樂部會員證及另一個假髮，並證實他是現役警員徐步高，警務處長親自到場了解。

警搜疑兇家 飛虎戒備

至昨晨十時許，「O記」探員及「飛虎隊」人員，掩至大嶼山裕東苑，搜查疑匪住所，「飛虎隊」員手持MP5輕機槍及盾牌戒備，死者妻子其後由男女探員陪同往認屍。

探員在屋內檢走死者一台電腦及兩大袋證物，以及檢走過去一周的大廈閉路電視錄影帶，至中午十二時許，探員將死者妻子送回住所，男女探員留守屋內看顧死者妻子，至昨晚十時許，警方尋回疑匪的留在官涌街的客貨車。相關新聞詳刊A4、A6版

藏兇槍五年警隊竟不知

曾蔭權承諾徹查真相

【本報訊】昨凌晨尖沙嘴發生的槍擊殺警案轟動全港，行政長官曾蔭權昨午在警務處長李明達陪同下到醫院探望中槍姓冼警員，曾蔭權讚揚案中殉職及重傷警員很勇敢，承諾警方會徹查真相。曾蔭權對案件感到痛心及震驚，但他鼓勵兩名死傷警員家屬振作，並祝福受傷警員早日痊癒。

警員指通訊系統存盲點

立法會保安事務委員會主席涂謹申昨表示，對槍擊案疑兇疑涉警員梁成恩被殺失槍案高度關注，他呼籲警方留意兩個重點：一、加強案件跟進工作，特別是追查案中兇槍過去數年是否涉及其他嚴重罪案；二、疑兇藏有梁成恩的遺失佩槍，竟可潛藏警隊內部多年而一直不為人察覺，警方應加強警隊內部操守及行為監察守則，避免同類事件再次發生。

槍擊案發生後，警務處長李明達在凌晨舉行的記者會上傷感表示「今次事件對警隊係一個好大概打擊，大家都好傷心！」但他強調警隊上下都會肩負保護市民財產安全工作。

昨日有前線警員致電電台節目反映事發隧道隱蔽，警員接到

薄更設於隧道管道內，隱藏危險，該警員更指現時使用的警察第三代通訊系統存在收發盲點，希望警隊正視。

警察員佐級協會副主席鍾錦華指，自梁成恩五年前遇害後，警隊更新軍裝警員巡邏制度，中更下半更及夜更警員需二人一起巡邏，即俗稱「行孖嘢」，而因應去年長沙灣一名警員單獨巡邏遭疑人刺傷，各警區可因應個別高危地方安排軍裝警員孖嘢巡邏。

廖潔明：既震驚又傷心

本地督察協會主席廖潔明傷感表示：「事出突然，既震驚又傷心，心情是欲哭無淚。」他解釋傷心是有同袍執勤時殉職，震驚則是疑兇竟是現役警員，他形容昨日是他擔任督察協會主席十一年來最傷感一天，百感交集。

特首：盡快破案

【新報訊】行政長官曾蔭權昨日到醫院探望在尖沙嘴槍擊案中受傷的警員，他對事件感到震驚及難過，警方正積極調查案件，醫院方面亦會全面救治傷者。警務處處長李明達、保安局局長李少光及公務員事務局局長俞宗怡，亦對有警員在槍擊案中殉職表示難過，並向家屬致以深切的慰問，又期望另一名受傷警員早日康復。

醫院探望重傷警員

行政長官曾蔭權在昨午五時許，在保安局局長李少光、警務處處長李明達、以及警管局主席胡定旭的陪同下，前往伊利沙伯醫院深切治療部，探望在槍擊案中受傷危殆的警員冼家強。

曾蔭權對今次的槍擊案感到震驚及難過，並指警務處長已向他承諾，會積極調查今次案件，希望可以盡快破案，向公眾交代真相。

俞宗怡致深切慰問

曾蔭權亦形容，冼家強及另一位在槍擊案中不幸殉職的警員曾國恒勇敢，雖然現時冼家強已甦醒，但情況仍然危殆，他相信醫院上下會盡力救治，並期望冼家強能早日康復，亦寄

語傷者家人要振作。

保安局長李少光亦對今次槍擊案感到震驚和難過，他希望受傷的警員可以早日康復，並對殉職警員的家屬致以深切慰問。而警務處處長李明達更形容事件對警隊是重大打擊，又對有警員殉職感到傷心，警方福利官已聯絡他們的家人，盡量提供協助。

公務員事務局局長俞宗怡亦對事件感到非常難過，並代表公務員隊伍，向殉職警員曾國恒的家屬致以最深切的慰問，她亦向另一名受傷警員冼家強送上花籃，並衷心希望他能夠早日康復。她亦表示，公務員事務局已與警務處聯絡，將盡力協助兩位死傷警員的家人，度過這悲哀及艱難的時刻。

涂謹申指孖嘢恰當

立法會保安事務委員會主席涂謹申形容，槍擊案導致有警員殉職是不幸和悲痛。他指現時最重要是進行後續調查，包括偵查事件中是否有同案人在逃，以及有人深夜持槍的動機，是否企圖犯案。他亦表示，警方應加強前線警員的警覺性，但認為目前兩名警員巡邏的安排恰當，警方日常的訓練亦足夠，毋須因今次事件而增加巡邏小隊的警員人數。

殉職警轟5槍 佩槍離奇插槍袋

疑兇犯案前突請半日假

轟動全城的警員互轟火案，在狹窄隧道相遇的3警爆發槍戰，釀成2死1傷，表面推測是巡警偶遇懷槍同袍而起，但探員追查下，發現疑點重重，恐怕別有內情。警方消息透露，殉職警員曾國恒的佩槍曾發射過5發子彈，但他被發現時頭部中彈昏迷跌坐樓梯，佩槍竟是插在槍袋之中，警方對此不尋常發現大惑不解。

疑突收通知往「赴會」

警方消息透露，疑兇徐步高在案發前一晚（3月16日）要當值返「中更」（下午3時至11時），但他當值期間突然向上司表示要請半日假，並於當晚8時離開東涌警署。有探員懷疑徐有可能是突然收到通知要前往「赴會」，才走得這麼急。「如果是早有預謀行動，不需要返工後再請假，可以計劃周詳些！」那麼徐約了什麼人，為什麼要戴假髮易容赴會？案發時是否有其他人在場？他們有否涉及槍擊案等，都是警方急欲解開的謎團。

查3警是否認識 有否同黨

消息又指，警方初步調查後，證實槍戰中3人共開了10槍，其中徐步高用梁成恩的手槍開了3槍，受重傷的冼家強的佩槍則開了2槍，而殉職的曾國恒則開了5槍。率先到場的警

員發現頭部中槍的曾國恒時，他已無法動彈，最奇怪的是，其佩槍卻已被放回槍袋內。「如果是開槍放火，受重傷後還會這樣「好手尾」嗎？但又如何解釋開了5槍後再放回槍袋的舉動？」為了尋找真相，警方不放過追查任何可能性，包括是否有其他人在場，疑兇有否同黨，案中3警是否認識等。據知探員正追查3人過往數年的電話及通訊紀錄，了解他們有否有連繫。

簽到4分鐘爆槍戰 疑伏擊

另一個令探員疑惑的「巧合」，出現在案發時間上。根據行人隧道內的「簽到簿」記錄，兩名巡警在簽到後4分鐘，即與徐步高爆發槍戰，有同袍不禁懷疑，有人是明知有巡警會到該處簽到而在場守候，是有預謀的伏擊而非巧合。

有消息指徐步高患有抑鬱症，並

需要定期服藥。○記探員追查時，發現在警隊的檔案資料內並沒有徐患病的紀錄，但亦不排除有人患病後沒有呈報。據知，警方正向醫管局求助，希望找到徐的病歷資料。

「鬼槍」12子彈全尋回

據了解，梁成恩被搶的手槍連快速上彈器原有12發子彈，而3宗涉及該槍案件中，梁成恩遇害時身中5槍，荃灣恒生銀行的巴籍護衛亦中3槍，前日凌晨槍戰疑兇又開了3槍，這把被警隊中人稱為「鬼槍」的失槍總發射了11發子彈，還有1發子彈在那裏？是否涉及其他案件？警方消息透露，原來「失蹤」的一發子彈，早在梁成恩遇襲當日已發射過，只不過沒有命中，警方事後在現場地上找回，而「鬼槍」的12發子彈全部已被尋回，徐步高槍戰中亦是發射了最後3發子彈，確有可能是子彈用光而被擊斃。

被通緝綿羊仔屬疑兇同儕

另外，案發後不久，有一輛綿羊仔電單車在案發現場附近出現，警方即日已發出通緝令，探員根據車牌追查，再有驚人發現，該車的姓張車主，原來亦是警務人員，更與疑兇徐步高同駐守大嶼北警區迪士尼警崗，由於警方找不到人及車下落，一度大為緊張，要求全港警區加強追捕人車。警方昨午已找到姓張車主及電單車，張表示早前將車售給徐，但未辦轉名手續，經調查後初步相信他與案無關。

有探員透露，事件雖然疑點重重，但警方最想了解的是疑兇是否有同黨，有否漏網之魚，警方全方位從各方面蒐證，相信真相會很快水落石出。據了解，警方昨日已與中槍受傷的警員冼家強錄取口供。

Officers shot with stolen police gun



TST shooter, an off-duty policeman, fired weapon used to kill constable five years ago

An off-duty policeman shot two uniformed constables, killing one of them, with a gun stolen from and used to kill an officer five years ago, police sources said yesterday.

The off-duty constable, Tsui Po-ko, 35, was also killed in the shootout in Tsim Sha Tsui in the early hours of yesterday.

Police sources said evidence at the scene suggested that Tsui fired the first shots using the service revolver taken from constable Leung Shing-yan, who was murdered in 2001 after he answered a bogus noise complaint in Tsuen Wan.

The gun was found in the blood-spattered underpass where Tsui died along with Constable Tsang Kwok-hang, 33. Tsang's partner, Sin Ka-keung, 28, remained in a serious condition in the intensive-care unit of Queen Elizabeth Hospital last night.

Investigators were having difficulty piecing together exactly what

happened, because Constable Sin, the only witness, had not been able to talk to them.

But the gunfight is believed to have broken out after the constables, attached to Patrol Sub-Unit One of Tsim Sha Tsui police station, tried to stop Tsui for a search.

Police Commissioner Dick Lee Ming-kwai said preliminary investigations indicated that 10 shots were fired.

A police source said seven were fired by the two patrol constables and another three from Tsui's gun.

"We all commended the will-power of the two officers who managed to return fire and gun down the suspect before they collapsed," the source said.

It is understood that the injured Constable Sin pressed the emergency button on his walkie-talkie to alert police to a shooting case before he fell.

He was found lying semi-conscious next to Tsui, while Tsang was just a few steps away, one in-

vestigator said. The three revolvers were on the floor beside them and blood was sprayed on the walls, floor and staircase of the subway, near the junction of Canton and Austin roads.

The men were taken to Queen Elizabeth Hospital, where doctors declared Tsang and Tsui dead.

Checks by the Forensic Firearms Examination Bureau revealed that the handgun carried by Tsui was the police revolver sto-

len from Leung in 2001, another source said, adding the serial number had been removed.

Organised Crime and Triad Bureau detectives yesterday approached officers who worked with Tsui for information about his daily life and were understood to be tracking his telephone records to see whom he had been in contact with recently.

Last night, detectives were also trying to establish whether others

may have been involved in the incident. Police found a grey van in Kwun Chung Street, Jordan, which could be opened by a key found on Tsui's body. Tsui was attached to the police post at Disneyland.

Police went to Tsui's home in Yu Tung Court, Tung Chung, early yesterday and took away evidence and his wife for questioning.

After the gunfight, the scene - about 300 metres from the Tsim Sha Tsui police station - was cor-

doned off as forensic experts combed the area for evidence.

Constable Tsang, who joined the force more than 10 years ago, was transferred to the patrol sub-unit of Tsim Sha Tsui police station about two weeks ago.

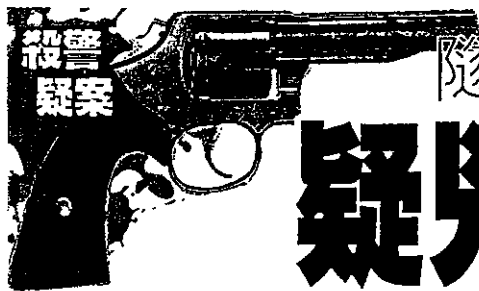
At about 1.30pm, distraught relatives, including his wife and mother, burned ritual paper offerings and joss sticks near the entrance to the underpass where Tsang died.

"I miss you, Kwok-hang," his sobbing mother screamed.

Chief Executive Donald Tsang Yam-kuen, who visited Constable Sin yesterday, said he hoped the full details of the shooting would be established soon. "We hope the families of the police officers will stay strong," he said.

Mr Lee described the incident as a "heavy blow" to the force.

隧道魚眼鏡移位 警推論有預謀 疑兇埋伏殺警圖奪槍

3名警員駁火2死1傷案，中槍大難不死的警員可以簡單點頭回答問題，案發經過有望漸見明朗。警方消息指出，根據目前所得資料推斷，警方初步傾向相信案中休班警員徐步高，是有預謀地在行人隧道轉角處持槍伏擊兩名同僚，目的估計是搶奪警槍，至於搶槍目的則仍有待深入追查。【相關新聞刊A4】

料伏轉角 近距轟曾國恒頭

消息指出，警方傾向這個推論的基礎有兩點：其一，警方調查發現，案發位置原本有兩組供行人視察隧道出入口兩邊情況的「魚眼鏡」（凸面反光鏡），但案發後，發現有魚眼鏡曾經被人移動過，不排除有人為方便埋伏而作準備；其二，據悉兩名巡警在簽簿後步出隧道，在轉角處便與疑兇相遇，對方一言不發即對準曾國恒的頭部，在距離3呎位置開一槍。

消息亦指出，曾國恒頭部中槍後，沒有即時倒下，而是拔出佩槍還火，當中1槍擊中疑兇的腹部大動脈，亦即致命一槍。之後在旁的警員冼家強與疑兇糾纏起來，雙方隨即近距離駁火。這個伏擊的推論在時間上亦吻合（中槍警是在簽簿後4分鐘向上峰求救）。

至於曾國恒開槍後何以佩槍會放回槍袋？消息人士暗示這點已找到解釋。據推測，這可能是警員基於長久訓練的下意識。據調查所知，駁火後首先到場的兩名警員是數分鐘之後，當時曾仍有掙扎，顯示他頭部雖中槍，但同僚趕至前仍有知覺，故可能仍有能力將槍放回槍袋。此推測目前仍有待其他證據支持，例如曾手槍上有無他人指模等。

冼家強可憑點頭答問題

據了解，面部及小腿中槍的警員冼家強仍未能錄取詳細口供，但已能對調查

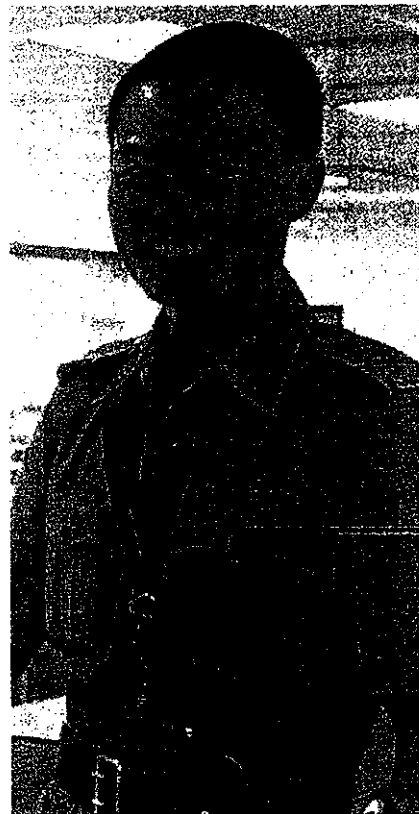
同僚的幾個重要問題以點頭方式回答。由於案件仍有很多重要疑點需要釐清（例如案中3人是否認識、疑兇何以突然請半天假等），警方暫不能作出結論，仍有大量蒐證及調查工作要進行。如推論成立，則表示案發時沒有第4人在場，這點一直都是警方最關心的。不過，現場以外會否涉及第4者，則仍有待追查。

警方目前傾向相信，疑兇伏擊同僚是為了搶奪警槍。由於他所持屬於警員梁成恩的佩槍只遺下3發子彈，故可能想多搶一柄槍以達到其他目的，可能是再犯案，亦有可能是單純基於挑戰警方的心理。從疑兇一開始就對準曾國恒頭部開槍所看，其目的可能是先「解決」其中一人，好讓自己易於對付另一個，這顯示疑兇對自己的能力充滿自信。

徐步高梁成恩非同期共事

有報道指，警方懷疑疑兇與外圍賭波集團有關連，警方亦在其銀行戶口中發現一筆可觀存款，但此兩點昨日未能獲得進一步證實。據與梁成恩認識的人指，早前報道指梁成恩與徐步高同期在梨木樹警署駐守的說法並不正確，兩人雖曾在該警署服役，但不是同期，故相信兩人並未在工作上認識。

昨日下午3時許，有組織罪案及三合會調查科（O記）警司吳炳權聯同法醫官及軍械專家等一行十多人，重返案發行人隧道調查，軍裝警員預先封鎖出入

口，記者未能察看調查情況。據悉探員是回到現場嘗試重組槍戰經過，並由法醫及軍械專家提供意見，各人亦曾檢查隧道內兩組魚眼鏡。眾人逗留約45分鐘後離開。

至昨午5時，4名O記探員帶同兩名警方重點及搜索隊人員再回現場調查，只見該隊專長搜索證物的人員，爬上梯子，利用特別儀器，對隧道內的魚眼鏡進行仔細探測，逗留近2小時才離開，未見帶走任何證物。

Source says off-duty officer who shot colleagues was connected to underground betting syndicate

Shooter linked to soccer gambling

The off-duty police officer who shot dead one of his colleagues and critically wounded another had long-standing connections to an underground soccer gambling syndicate, a police source has told the *Sunday Morning Post*.

Since the shooting in Tsim Sha Tsui early on Friday morning, it has been discovered that Constable Tsui Po-ko had a "substantial amount" of unexplained money in his bank account, the source said.

Tsui, 35, gunned down constables Tsang Kwok-hang, 33, and Sin Ka-keung, 28, during a shootout in an underpass between Canton Road and Austin Road.

Tsui - who was killed when his colleagues returned fire - is believed to have had an excellent shooting record. All three shots he fired hit their targets, the source said. Tsang, who was shot in the head, died from his injuries and Constable Sin remains in a serious

condition in Queen Elizabeth Hospital. Ten shots were fired - three by Tsui and seven by the two on-duty officers.

Police chiefs confirmed the .38 revolver Tsui used was the gun stolen from Constable Leung Shing-yan, 23, who was shot dead answering a bogus noise complaint in Tsuen Wan in March 2001. It was also used to kill Zafar Iqbal Khan, 31, a security guard, during a bank robbery in Castle Peak Road nine months later.

Tsui had reportedly worked with Leung at the Lei Muk Shue police station.

Police said the police-issue firearm was identified from its serial number, which

had been partly removed.

"This guy [Tsui] was known to the police and he had long-term connections to a soccer gambling syndicate in which other officers participated," said the police source. "Obviously, something has gone badly wrong here and it is not only a big blow to the force but also

a major embarrassment, given the circumstances."

Last night police said the investigation was continuing and would not comment on specific allegations. Detectives from the Organised Crime and Triad Bureau were continuing their inquiries and, with officers from the Police Tactical Unit, they searched Tsui's home in Tung Chung.

The detectives also questioned some of Tsui's former colleagues, another police source said. The source denied media speculation that a large sum of cash had been found in a locker at the Disneyland police station, where Tsui was stationed. But he did say that hoods and wigs were found in the locker.

Civil Service Secretary Denise

Yue Chung-ye yesterday visited Constable Sin in Queen Elizabeth Hospital, where he remains in a serious condition.

Meanwhile, police have said they will urge the government to allow Tsang to be buried in Gallant Garden, the cemetery near Tai Po reserved for civil servants who die in the line of duty.

"Obviously, they are very sad about the incident. I was here to offer our condolences and the police welfare officers will follow up any needs of the family as well as funeral matters," police chief Dick Lee Ming-kwai said after visiting Tsang's parents in Tsim Sha Tsui.

About 40 former colleagues of Tsang held a traditional ritual for him at the scene of the shooting.

魔警與殉職警九年前結怨

【本報訊】「魔鬼警察」徐步高槍殺同袍曾國恒的案件中，警方調查有新的發展，原來徐、曾二人早已認識，並在九年前一宗案件結怨，不排除徐步高懷恨在心，從此種下殺機；另外，警方亦發現有一名神秘男子在案發當晚查看尖沙嘴槍房的出更表，警方調查相信他並非徐步高，但與案件有關，極可能是要掌握曾國恒的當更路線，與徐步高串謀殺警。記者：江寶龍徐雲庭吳國威

曾國恒當差十多年，兩周前從九龍城警署調來尖沙嘴警署，但他在九八年駐守旺角警署擔任雜項調查工作時，已與徐步高認識，不過，兩人並非因一起駐守同一間警署，也不是合作破案，而是因為徐步高涉及一宗滋擾案，被曾國恒調查。

警方調查發現，徐步高於九八年結婚，他在旺角金都商場一間婚紗店租婚紗，婚禮完後將婚紗交還店舖，有店員指婚紗損毀要他作出賠償，他則指婚紗店為黑店，當時並表露警察身份拒絕作出賠償，婚紗店最後沒有追究，但懷疑徐步高心有不甘，多次向婚紗店滋擾。

在一次徐向婚紗店騷擾後，負責人向警方報案，當時到場調查案件的正是曾國恒，徐被帶返警署亦由曾替他錄口供，警方在調查之後，由於案件證據不足沒有向他作出起訴。徐雖然免受刑責可以保留警員的工作，但據知情人士指出，由於徐步高行為不檢，行為簿已被「劃花」，難有機會升級。

在〇〇年的升級試，徐的筆試成績在二千多名考生中名列第二，面試時候因被指「性格缺陷」，所以不獲晉升為警長，其中滋擾婚紗店的事件，是指他「性格缺陷」的重要佐證。警方消息指，未獲升級對徐做成重大打擊，從此視曾國恒為仇人，今次很可能是針對曾國恒所作出的報復行動。

徐亦自視甚高，相信他向高難度挑戰，〇一年被槍殺的梁成恩、今次被殺的曾國恒及受傷的冼家強都是身材高大的警員。調查案件的〇記探員，除翻查尖沙嘴警署的出更表外，並特別會晤身材高大的警員，從中尋找線索。

神秘人駕鐵馬

出入警署查更表

徐步高當年殺害梁成恩並搶走其佩槍，其後至少涉及行劫荃灣恒生銀行及槍殺巴籍護衛案件，警方調查兇徒是否有同黨。在今次案件後，警方追緝一部綿羊仔電單車，一名神秘人於案發當晚，在尖沙嘴警署將電單車駛走，該名男子在案中相當關鍵，警方不排除他是徐步高的同黨，但現在仍未尋獲該部電單車下落。

有消息指出，徐步高於案發當晚乘東涌線地鐵在九龍站下車，而在晚上十一時前，尖沙嘴警署槍房的警員目睹一名身穿便服，但並非該警署警員的男子，在槍房外觀看夜更警員出更行必表，該更表有每名警員巡邏的路線，稍後該男子乘電單車離開。事後〇記探員替槍房

警員錄取口供，據稱，該名男子身材較矮，相信並非徐步高。

兩名警員曾國恒及冼家強，上周五凌晨一時十二分，在柯士甸道與廣東道交界的行人隧道簽到，凌晨一時十六分警方收到他們求救，在四分鐘內他們遭受槍擊。據警方調查發現，當晚兩名警員與徐步高相遇後，徐首先發難向冼家強開兩槍將他打傷，而冼亦拔槍開了兩槍還擊，但未有命中對方。徐步高槍傷冼家強後，再迅速向警員曾國恒頭部開槍一響，將他射至重傷倒地。□

消息續稱，曾國恒中槍倒地即拔出佩槍發射了五響，五粒子彈全部命中徐步高身上，曾然後才將佩槍放回槍套內向上級呼救。

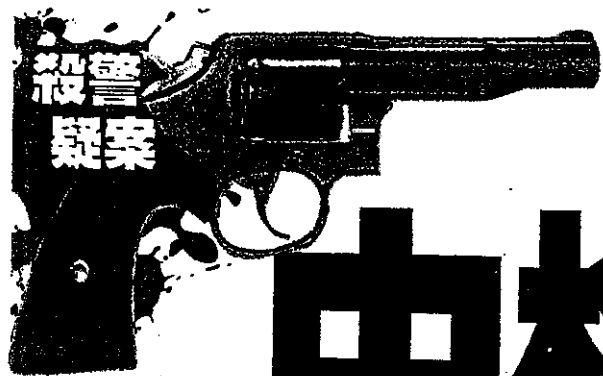

勇抗襲警搶槍

中槍曾國恒 五發五中殺匪

轟動全城的3警駁火案，案情明朗化，警方相信是一宗有預謀的襲警搶槍案，並排除有「第四者」在場。警方並證實案中殉職警員曾國恒，在臉部中槍後忍着劇痛，在垂危之際以神準槍法「五發五中」，將欲搶警槍的「亦警亦匪」疑犯徐步高擊斃，不但拯救了受傷同袍冼家強，更以一人之力挽回整個警隊的尊嚴與聲譽。

激戰過後，曾國恒將佩槍收好在槍袋內，以無線電向上峰報告後不支倒地，送院後終因呼吸道被血液阻塞，窒息而亡。警隊上下對此悲痛萬分，正爭取將曾國恒的遺體安葬在浩園，以悼念這名英勇殺敵的神槍手。

徐步高隧道埋伏 槍槍想奪命

駁火案在5天前發生，警方經連日蒐證調查後，昨日召開記者會，由警務處助理處長（刑事）李家超、有組織及三合會調查科（○記）總警司蔡建祥及警司吳炳權交代調查進展。李家超證實，被轟斃的疑犯徐步高，案發時所持的左輪手槍及槍內的3發子彈，正是2001年警員梁成恩在石圍角郵遞襲身亡時失去的佩槍及子彈。身為現役警員的徐步高，於上周五凌晨時分，獨自埋伏在尖沙嘴柯士甸道及廣東道行人隧道內，計劃搶奪兩名巡警的佩槍及子彈。

冼家強還擊兩槍射失

當時，警員曾國恒與同僚冼家強正巡經該隧道，埋伏的徐步高二話不說即向兩警連開兩槍

，分別擊中曾國恒的面部及冼家強的臉部，顯然是想置兩人於死地。體型健碩的冼家強雖然負傷，仍立即撲前圖將徐制服，卻遭對方發射槍內最後一發子彈擊中大腿；冼開兩槍還擊，但均告射失。差不多同一時間，曾國恒中槍後鮮血直冒，但他仍忍着劇痛，短短數秒間連轟5槍還擊，結果全數命中目標，其中致命的一槍更傷及對方的肺部和心臟。

未定出殯日 爭取葬浩園

消息指出，曾國恒在激戰過後，因傷勢嚴重不支倒地，但他仍將佩槍收好在槍袋，並透過無線電向上峰求救。救護車接報到場將3人送院，曾國恒終因失血過多，呼吸道被血液封閉，最後窒息死亡。

曾國恒在負傷下，仍能以神準槍法擊斃悍匪

，避免了另一宗「槍槍無頭公案」，最後英勇殉職，警隊上下均表難過痛心，警方正與其家屬商討其後事安排，出殯日期雖未確定，但據知警方正爭取將他的遺體安葬在浩園。

冼情況穩定 轉私家病房

至於身中兩槍、傷勢一度危殆的冼家強（綽號「加菲」），留醫多天後情況已由嚴重轉為穩定，昨日並已由深切治療病房轉到私家病房留醫，但未知何時才能康復出院。昨日續有同僚到醫院探望「加菲」，祝願他早日康復，返回前線與同袍並肩作戰；香港警察警司協會亦向他致送了花籃。

雖然案情已有眉目，警方仍不敢怠慢，昨日一直派員在病房留守，而多名○記探員也到醫院向冼家強錄取口供。【相關新聞刊A4、A5】

梁成恩案 O記歸納兇徒特徵

10警1受查

徐步高漏網

警方強調3警駁火案中，疑兇徐步高是「有預謀」、「有部署」及「有計劃」地犯案，準備在案發現場伏擊巡警，再搶去他們的配槍和子彈，正調查其動機，以及搶槍後下一步行動。警方證實，徐在案中使用的槍，正是5年前梁成恩案中的失槍，而該槍亦涉及同年的荃灣麗城花園銀行劫殺案，兩案發生後，O記將兇徒資料和特徵歸納，並調查過警隊的十分之一（逾2000名警員），但徐竟不在受查之列。警方指徐與一死一傷警員，以及梁成恩並不相識，正調查徐生前的心理狀況。

「有預謀有部署有計劃犯案」

警務處助理處長（刑事）李家超昨在記者會上指出，由於近日傳媒對上周3警駁火案有多番揣測，因此主動向傳媒澄清，一來減少市民對案件的揣測，二來對涉案人士及其家人更為公道。警方經連日調查，根據證人口供及專家報告顯示，認為徐是有預謀、有部署、有計劃地犯案，相信他在案發當日，獨自持槍埋伏在行人隧道內，伺機搶去2名警員的配槍及子彈，正調查其動機，以及搶槍後行動。

疑兇與梁成恩曾國恒不相識

警方指無證據顯示徐與案中死者曾國恒、傷者冼家強，及梁成恩相識，殺曾傷冼唯一目的是奪槍。而徐及梁成恩並非同期駐守梨木樹警署，故無證據顯示2人相識，但仍會對此繼續調查。

李家超亦證實，徐於3警駁火案中所用的槍械，乃警員梁成恩生前的佩槍及快速上彈器共12發子彈，而所有子彈亦在3次案件中悉數發出，

包括在槍殺梁成恩的6發，麗城花園劫殺案的3發，以及尖沙嘴殺警案最後3發。除此之外，李還指出一輛報失的輕型貨車及一部徐曾使用的電單車，均為此案重要證物，警方已要求將涉案證物進行優先安排化驗。不過李表示事件仍在調查中，暫未得出任何結論。

李續稱，O記於2001年警員梁成恩被槍殺案及麗城花園劫殺案後，根據鎖定的疑兇特徵，曾邀請3000多人協助調查，當中包括2000多名警員，佔整個警隊十分之一，以研究當中是否有人合乎特徵。不過，徐步高卻未在被調查之列。李表示，警方仍對上述兩宗案件進行調查，暫時仍未搜出麗城劫殺案的贓款。

李續稱，在槍擊案過後，警方即時邀請東涌警署所有探員協助調查，以便了解同事們對徐的認識，以及徐的活動範圍是否在警方搜索範圍內。

警方事後已為該區的警員進行心理輔導。警方亦強調重視上司下屬間的溝通，並希望探討對方的問題，警方有需要會為其提供適當的支援及心理輔導。

Attacker escaped probe into constable's murder

Officer with stolen gun had never been a suspect in earlier shooting, say police

The off-duty policeman believed to have gunned down two constables with a stolen police revolver last week had never been a suspect in the theft of the gun and murder of its holder, a top officer said yesterday.

About 2,000 officers – one in every 13 – were investigated over the killing of Constable Leung Shing-yan five years ago but Tsui Po-ko, killed along with another officer in a shootout in Tsim Sha Tsui early on Friday, was not among them, the head of the force's crime section, John Lee Ka-chiu, said.

The assistant commissioner also confirmed that the weapon taken from Leung in 2001 was used to kill a security guard later the same year.

He said Tsui was killed by five shots from the pistol of Tsang Kwok-hang, who died after being shot once in the head in the underpass gun battle that left Constable Sin Ka-kung severely injured.

Speaking at a news conference, Mr Lee said that, contrary to some reports, Tsui had acted alone in his "premeditated" attack. He also revealed that Tsang died from choking on his own blood rather than directly from the gunshot wound.

Confirming a report in the *South China Morning Post* yesterday, he said the attack was aimed at stealing the two officers' revolvers and ammunition. The purpose was still being investigated by the force's elite team from the Organised Crime and Triad Bureau.

Mr Lee said Tsui did not know the two other officers.

"We believe that the off-duty PC was the suspect and that he was acting alone at the time of the incident," he said. "Our investigation has indicated that the suspect's action was premeditated and his encounter with the two officers was not an accident."

He insisted that it was a very "individual and exceptional" case, adding: "In my 29 years of service, this is the first case which involved a suspect like this."

Mr Lee said there was no evidence that Tsui suffered psychological problems but a criminal psychologist had been invited to join the investigation to give his views on Tsui's mental state at the time of the attack.

He confirmed that the revolver used by Tsui had also been used to kill security guard Zafar Iqbal Khan, 31, during a bank robbery in Tsuen Wan nine months after the murder of Leung. Khan

was shot three times.

Organised Crime and Triad Bureau officers were still investigating whether Tsui was the killer in this case and that of Leung, who was ambushed and shot with his own gun when he answered a bogus noise complaint in Tsuen Wan in March 2001, Mr Lee said.

They were also looking into whether Tsui had connections with an underground soccer gambling syndicate and other illegal activities, as reported by the *Sunday Morning Post*.

Bureau detectives returned to the crime scene at the junction of



Tsang: fired five shots

Austin and Canton roads at about 1.30pm yesterday. Another team searched a hillside near Yu Tung Court, Tung Chung, where Tsui lived with his wife and daughter.

Ten shots were fired – three by Tsui and seven by the two on-duty officers – in the gunfight at about 1.15am on Friday. Tsang fired five shots, all of them hitting Tsui; Constable Sin fired two shots at close range, both missing their target.

Mr Lee refused to reveal any further details of the shooting yesterday, saying there was likely to be an inquest.

He also made no mention of information given to the *Post* by a senior officer that Tsang's pistol was found on him in its holster.

Mr Lee denied reports that a huge amount of cash was seized during the investigation.

He also refused to confirm reports that mirrors inside the tunnel that allow people to see blind spots had been adjusted before the shooting.

Constable Sin, who was shot in the face and leg, remained in a stable condition in Queen Elizabeth Hospital last night.

真相大白 頭中槍還五彈 恒仔殺魔真英雄

「警魔」殺警槍戰案真相大白，警方昨公布警匪生死三分鐘的「空白片段」，原來能成功將「警魔」伏法，是因勇警曾國恒中槍殉職前，垂死「頑抗」，負傷連轟五槍，子彈貫穿徐步高的心肺，將他擊斃，救了同袍「加菲」一命。惟「恒仔」卻因鮮血封喉窒息殉職。警方又證實，徐是有計畫地搶槍，一槍轟斃「恒仔」，兩槍轟傷「加菲」，而「加菲」自衛兩槍均落空，案中並無第四人。

警方公布殺警槍戰案真相，證實本報報道案中不涉第四者。警務處助理處長李家超，昨聯同有組織罪案及三合會調查科(O記)總警司蔡建祥及警司吳炳權，召開記者會公布案件真相，及澄清外界揣測。

警：緝密計畫搶槍彈

李家超指出，經O記連日來偵查，得出的結論是本月十七日(上周五)凌晨，尖沙嘴行人隧道槍戰案，只涉及三人，包括兩名巡邏警員曾國恒與冼家強，以及現役休班警員兇手徐步高。

據證人口供、專家分析及各方面蒐集資料顯示，槍戰案不涉其他人，並無在逃人士，疑兇徐步高犯案目的是針對兩名巡邏警員的佩槍及子彈，事前曾經過緝密計畫。

徐持梁成恩失槍行兇

現時警方的調查目標，針對疑兇犯案時心理狀況，他若再成功奪去兩支警槍及子彈後的真正目的，以及當日他下班後至槍戰案發生的一段時間行蹤。

這宗慘烈槍戰，雙方共駁火十響。根據槍械分析顯示，擊中警員曾國恒的一發子彈，以及擊中警員冼家強的兩發子彈，皆來自疑兇徐步高的手槍，而徐步高身中的五槍，全部發射自曾國恒的佩槍，冼發射的兩槍落空。

李家超指出，徐步高當日的手槍只有三發子彈，他預先埋伏在行人隧道轉角位，當兩名巡警步入隧道走近時，即向兩警連開三槍，全部命中，第一槍擊中曾國恒，第二及第三槍則擊中冼家強。

失血過多封喉致死

曾、冼中槍後負傷拔槍還擊，徐撲向曾企圖搶奪曾的手中佩槍，但曾向他連轟五槍，全部命中，擊中他的胸口，冼則開了兩槍，但是皆未有命中。

徐身中五槍後倒伏地上，冼用手銬將徐的雙手反鎖，而曾將佩槍放回槍袋及以對講機通知上鋒，繼而昏倒血泊中，冼拉動對講機緊急掣，三人其後送抵醫院，兩死一留醫。

隧道血戰只涉三人

曾國恒面部中一槍致命，子彈由下顎射入，李家超指出，曾由於失血過多，血液封了他的呼吸管道致死；疑兇徐步高身中五槍，致死原因是子彈擊中重要器官，包括心臟及肺部。至於冼家強所中的兩槍，分別擊中其面部及小腿。

徐步高使用的左輪手槍，證實是殉職警員梁成恩失槍，這支警槍落入「警魔」手中，前後共導致四名警員(包括疑兇)三死一傷，及一名銀行護衛死亡，徐涉嫌於〇一年三月槍殺梁及奪槍，同年十二月初用梁的失槍打劫荃灣麗城花園恒生銀行槍殺巴基斯坦籍護衛員。

殺警案無第四者

【本報訊】「魔鬼警察」徐步高在尖沙嘴行人隧道殺警案，警方昨日強調徐是獨行殺手，並謂他是經過有計劃的部署，目的是向兩名巡警搶槍，案中涉及的只有他和兩名巡警，現場並無第四者；警方現正追查徐步高的搶槍意圖，及研究他在犯案時的心理狀況。另外，警方同時證實徐步高殺警的手槍，就是○一年警員梁成恩殉職時被搶去的警槍，及在同年恒生銀行劫殺案中用過。記者：簡明恩、溫文學

警務處助理處長（刑事）李家超、有組織罪案及三合會調查科（○記）總警司蔡建祥及警司吳炳權，昨特別召開記者會，講述上周五凌晨尖沙嘴殺警案調查進展，並澄清一些報道和揣測。李家超表示，案發後，警方經過研究證人的口供及專家分析，結論是案件只牽涉現場發現的三人，並沒有第四者，更加沒有在逃人士，相信疑兇是單獨行動。

部署犯案非偶然相遇

李家超說，相信兇徒在犯案前是經過有計劃的部署，雙方並非偶然相遇。但案中的疑點是，案發前有一名神秘人駕駛電單車進入尖沙嘴警署，並在槍房外查看夜更警員的出更表，究竟該名神秘人是不是徐步高，及他是否根據該更表而跟蹤兩名巡警，伺機下手。李家超對此沒有正面回答，只說此案日後可能須要進行死因聆訊，有關細節不宜透露。

他表示，警方案發後在現場檢獲徐步高使用的手槍，證實是○一年三月十四日警員梁成恩在荃灣石圍角邨被殺時搶去的警槍，及同年十二月五日荃灣麗城花園恒生銀行劫案中槍殺巴籍護衛員的手槍。李家超又謂，由於該槍有銹迹，警方第一次化驗不能作最後結果，須要進行第二次化驗。

梁成恩案調查二千警

據稱，在○一年的兩宗槍殺案發生後，警方已懷疑兇徒是警務人員，當時負責調查的○記人員曾先後會見過三千人，其中二千人是警務人員，但不包括徐步高。消息稱，警方當時懷疑兇徒是慣用左手開槍的，所以亦只針對使用左手的警務人員，但卻沒有料到徐步高是「雙槍將」。

另一方面，一直有消息指徐可能與梁成恩，及上周五遭槍擊一死一傷的警員曾國恒和冼家強是相識的。李家超表示，調查至今沒有任何證據顯示他們是認識的。

對於有消息指徐行兇動機涉及賭波集團或私人恩怨，李家超稱，根據現時的調查顯示，兇手行兇動機只是針對兩名巡邏警員的佩槍和子彈，至於他搶槍的目的是甚麼，則仍在調查中。

未搜獲恒生劫案贓款

至於徐步高在犯案時心理狀況，警方表示已安排刑事部一名熟悉犯罪心理學的專家，到○

記協助提供意見。不過，李補充說，沒有資料顯示徐步高有心理問題的紀錄。

另外，警方又否認在上周五案發後，警方曾在徐步高駐守警署或他的家中，搜出任何懷疑與○一年恒生銀行劫案有關的贓款。至於在槍戰案發生後，警方在現場附近扣查的一輛電單車和一輛客貨車與案件的關係。李家超指出，該電單車是徐步高當日使用過的；客貨車則是一輛報失車輛，他只說是案中的重要證物。

同時，李家超又說，警方在案發後曾會見過徐步高的同隊警員，原因是希望了解徐步高更多資料；另外，徐步高部份同袍亦可能在此事中需要心理輔導。

警聲稱破案 疑點一大籬 死因庭作盾

徐步高 一死攬三罪



尖 沙咀警殺警轟天大案發生已一周，警方兩名高層昨相繼公布案件的最新進展，並斷言若「雙面狂魔」徐步高仍然生存，警方掌握的證據已足以檢控他殺警。雖然警方已咬定徐步高是五年前槍殺警員梁成恩、麗城花園恒生分行劫殺案及槍殺警員曾國恒共三宗大案的真兇，但仍未交代證據何在，並繼續以

警務處處長李明達昨出席減罪活動時，仍一口咬定徐步高是殺人兇手，他指警方已有足夠證據顯示槍擊案中的疑兇休班警員徐步高，涉及梁成恩案及恒生劫殺案。但他一再以案件稍後會召開死因庭為由，拒絕進一步披露內情，包括O記是否在徐的電腦發現董建華的保安措施等。至於案件是否牽涉「第四者」，李明達昨不予正面回應。本報昨揭露徐步高欲刺殺董建華，李明達面有難色地指案件仍在調查中及需交由死因庭處理，不適宜公開討論案情，他不會評論揣測性報道。

「若生還會起訴佢」

而警務處助理處長（刑事）李家超昨在澳門出席粵港澳三地警方刑偵主管會議後召開記者會，他表示：「我可以好肯定咁話畀你（記者）聽，調查到呢個階段，警方已有足夠證據，如果疑兇（徐步高）仲係生還嘅話，我哋會起訴佢，關於梁成恩劫（槍）殺案、恒生銀行劫殺案，以及尖沙咀槍擊案，佢謀殺警員同埋傷害警員，呢三件案我哋係有足夠證據去起訴佢（指徐步高）。」

李家超續稱，警方現時仍然追尋部

分證物，包括與案有關的贓款、梁成恩當時失去的快速上彈器及記事冊等。他又祭起「死因庭聆訊」作擋箭牌，指希望傳媒及公眾的揣測不會影響警方的調查工作，特別是死因庭日後會傳召各方人士，他們均有權聘請律師，就案件進行查閱、盤問及挑戰，以保障他們的法律權利。

300萬懸紅仍生效

李明達透露，有組織罪案及三合會調查科（俗稱O記）曾接觸過正在康復的受傷警員冼家強，並得到不少有用的資料。警隊福利部亦已聯絡殉職警員曾國恒的家屬，曾國恒會以警隊最高規格下葬浩園。而福利部亦有接觸徐步高家屬，提供援助及心理輔導。他又指，在複雜的社會環境下，巡邏警員必要面對相當程度的風險，警隊會研究考慮所有措施以加強對警員的保護。

五年前負責調查梁成恩案的O記總警司、現任警務處人事處處長曾偉雄昨對梁成恩案終能破案感到十分唏噓，因警員曾國恒亦告殉職，令他十分難過，他又謂，今次案件可謂前所未有，一名殉職警員連破三宗兇殺案。

至於梁成恩案及恒生劫殺案合共的三百萬元懸紅，李明達指懸紅至今仍然有效。而恒生銀行副董事長兼行政總監柯清輝表示，恒生劫殺案的一百萬元懸紅，將由警方決定如何發放。

Pressure grows for inquiry into police killings

Pressure is mounting for an independent inquiry into the shoot-out between three police officers in the heart of Hong Kong's tourist district as more details emerge that cast doubt on the official version of events.

Police have also confirmed to the *Sunday Morning Post* that they have located a motorbike that sources say was seen being ridden away from the scene of the shoot-out in which Constable Tsang Kwok-hang died and Constable Sin Ka-keung was seriously injured after apparently being shot by off-duty officer Tsui Po-ko, who was also killed.

New details obtained from separate sources also increase the likelihood that Tsui had long-standing connections to a soccer betting syndicate and was in the Tsim Sha Tsui underpass for a pre-arranged meeting early in the hours of March 17.

The *Post* has also learned that detectives are probing three bank accounts in Tsui's name which hold a "substantial seven figure sum" and that a van police seized near the scene - for which Tsui held the keys - had been stolen. He was also the sole owner of two flats in Hong Kong, according to a source.

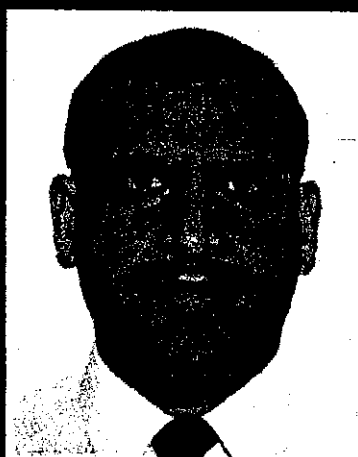
It is also understood that one reason police returned to the scene on Friday was to search for more bullet casings, suggesting more than the three people may have been involved in the shoot-out.

The push for an inquiry comes amid growing public concern that the official explanation does not tell the full story of the gun battle.

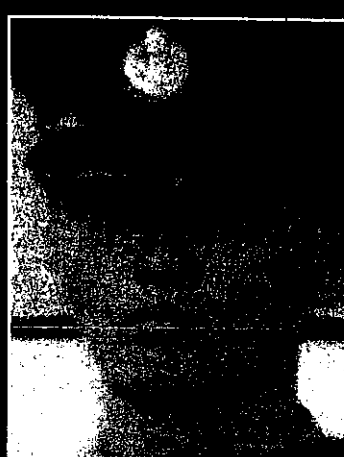
Last night the chairman of the Legislative Council's security panel, James To Kun-sun, said he was considering calling a meeting of the panel this week to probe the extent of soccer betting within the force and allegations police had failed to adequately investigate the activity.

Police say that if Constable Tsui Po-ko (right) were alive they would have enough evidence to charge him in relation to the murder of these three men. But was he acting alone?

Mr To said he initially favoured having a coroner oversee the investigation. But following the *Post*'s discovery of the problem going back at least five years, he had "serious doubts" about the police investigation and restricting it to a coroner's inquest. "A coroner is only allowed to investigate murders and this is not enough if there are wider implications from the shootings."

Mr To said the panel would explore whether it was necessary to have an independent inquiry into

the case. "It's the security panel's duty to monitor the police and these allegations of soccer gambling have caused a lot of concern."

The lawmaker was also concerned about information obtained by the *Post* that Tsui may not have "ambushed" the two officers but was at a pre-arranged meeting.

Assistant Commissioner John Lee Ka-chiu has blamed the deaths of the officers on Tsui and said there was enough evidence to prosecute him in connection with the deaths in 2001 of Constable Leung Shing-yan and security guard Zafar Iqbal Khan. The men were murdered with Leung's stolen gun, which was found next to Tsui's body, police say.

Asked whether there was a connection between the Tsim Sha Tsui shootings and soccer betting, police said they were investigating all avenues. They declined to answer questions about whether an internal investigation into police

soccer gambling in 2000/2001 was halted.

Lawmaker Margaret Ng Ngoi-yee has urged Chief Executive Donald Tsang Yam-kuen to order an independent inquiry.

She said police should also "automatically" want an independent panel to ease growing public concerns and show they had nothing to hide. "This is the sort of matter, where police officers are investigating police officers, where there is grounds for an inquiry. We don't know what is going to be raised by the ongoing inquiries, but it is bound to become more complicated, and many of the questions will not be answered publicly."

Mr To also said the coroner's office should become involved in overseeing the investigation immediately. "There is plenty of speculation going on in the public, and they will not be satisfied with the outcome of any investigation if only the police investigate."

立會擬獨立查魔警案

議員關注死因庭會否研訊賭波

【本報訊】外界質疑魔警徐步高槍擊案與非法賭波集團有關，警務處處長李明達表示，到目前為止，仍未有證據證明案件與此有關，警方準備盡快把案件交由死因庭處理。不過，立法會保安事務委員會主席涂謹申認為，坊間甚多傳聞指徐步高涉及非法賭博，他將去信保安局了解死因庭會否調查，以及促請政府或立法會獨立調查案件。

涂謹申昨與立法會法律顧問研究後指出，市民希望知道徐步高案件的真相，但案件仍然有很多疑點及傳聞，例如是否涉及第四者？是否與非法賭波集團有關？他已聽了不少，有的更是相當駭人，以上疑點警方都沒有明確否認，但若只有警方內部調查，市民也會質疑結果的可信性，認為獨立調查更可信；事實上《死因裁判官條例》也賦予死因裁判官權力，可以詳細調查徐步高的死因、如何死亡等。

李明達稱案件與賭博無關

涂謹申引述《死因裁判官條例》十五條稱，若有人在警務人員履行其職責過程中死亡，死因裁判官可要求警務處處長確保，該宗死亡的調查是獨立和公正無私進行。第九條及附表一也規定，死因裁判官可以調查，因罪行或懷疑罪行導致的死亡個案，調查死者是如何、何時和何處死亡。

涂謹申指出，死因庭可要求警方，找外間的機構協助調查，例如找司法機關、甚至找美國聯邦調查局做彈道測試求證；死因庭可以選擇做研訊、調查，研訊的程序一般較簡單，調查則較深入，徐步高的情況完全符合死因庭調查的條件，但若死因庭選擇不做較詳細的調查，他會考慮

促請政府獨立調查事件，或由立法會成立獨立調查委員會調查。

李明達昨天出席一個公開場合後也談及案件，李強調目前為止沒有證據證明，案件與非法賭博有關，由於警方準備交界死因庭處理，所以目前不能講具體資料。至於涂謹申建議立法會跟進事件，李明達不評論，只表示這要由涂謹申決定。

Tsim Sha Tsui police killings – is this what really happened?

Last week the *Sunday Morning Post* made both a written and verbal request for a formal interview with Assistant Police Commissioner John Lee Ka-chiu – or any other suitable officer – to address unanswered questions and clear up the imbroglio and rumours surrounding the shoot-out. This request was declined. Instead, we sent the force a list of written questions – about the incident and events over the past five years – compiled after a *Post* investigation. The police gave answers or partial answers to nine. A spokesman gave this reason for not answering most of the questions: "You will appreciate that, as this case will likely be the subject of a death inquest at a later stage, the information that can be released is therefore limited."

Q The force has confirmed that the revolver retrieved from Tsui Po-ko in the underpass was that of shot Constable Leung Shing-yan. Can you also confirm that each and every round fired during the exchange which hit both Constable Tsang Kwok-hang and Constable Sin Ka-keung came from that gun? Also, was Tsui's 12-round clip empty?

A ballistic examination has indicated the bullets which killed the patrolling police constable and injured another patrolling constable came from the gun used by the suspect. The same revolver has been confirmed to be the police revolver stolen from Leung Shing-yan, who was murdered on March 14, 2001, in Shek Wai Kok. Twelve bullets were stolen together with the police revolver from the late Leung. Police investigations indicated that six shots were fired in the Leung case, and three were fired in the robbery case involving the Hang Seng Bank. With regard to the shooting case in Tsim Sha Tsui, the suspect fired three shots.

Can you confirm that investigators have seized a stolen van that was parked near the scene in Tsim Sha Tsui, and that investigators are looking into a report of a motorcyclist riding away from the scene in the immediate aftermath of the shootings?

Police have located a light goods vehicle in Kwun Chung Street, Yau Ma Tei, and a motorcycle which was believed to have been used by the suspect prior to the incident. They are important exhibits in the police investigation.

Did either Constable Tsang or Constable Sin have any cash on them at the time of the shooting. If so, how much?

No answer.

Can you confirm that Police Commissioner Dick Lee Ming-kwai has visited Constable Sin in hospital on at least two occasions since he was shot in the underpass, and that despite Constable Sin's injuries rendering him unable to speak, he has been able to communicate by other means?

Key questions: what force will and won't say

The commissioner of police as well as other senior police officers have visited Constable Sin several times since he sustained serious injuries in the incident.

Can you confirm that Tsui is known to the police to have been right-handed?

No answer.

Can you also confirm that Tsui met the requirements on more than one occasion to join the Special Duties Unit, but was rejected after personality tests revealed that he was unsuitable for such a posting?

No answer.

Can you confirm that investigators are looking into three separate bank accounts, all registered in Tsui's name, at least one of which is an HSBC account, and that a sum of money in the seven-figure range has been found in the three accounts?

No answer.

Can you confirm that one avenue of investigation is to find out if there are any links between these bank accounts and constables Tsang and Sin?

No answer.

On or around the time of the shootings, can you confirm that an anti-prostitution and -vice operation codenamed Operation Windpipe, involving Kowloon West regional crime unit and other units, was ongoing in Tsim Sha Tsui?

Police mounted an anti-crime operation codenamed Operation Windpipe in the Kowloon West Region, including Mongkok, Yau Tsim, Shamshuipo and Kowloon City, between March 15 and 17.

Can you confirm that, in fact – contrary to some media reports – no cash was found in Tsui's locker, only one wig. And that, in fact, there was no "Tsui Po-ko diary" or "hit list" of tycoons, including Tung Chee-hwa?

No comment.

We have properly sourced information that Tsui was actively involved in a soccer betting syndicate, which has been operating for some time and involved other police officers and substantial amounts of money. Can you confirm or deny that the investigation is looking into this?

Police would look into all aspects concerning the background of the suspect. However, no details could be provided.

We also have properly sourced information that this was no "ambush", as such, but was in fact a pre-arranged meeting between consta-

bles Tsui, Tsang and Sin. Can you confirm or deny this? Also, can you confirm or deny that one avenue of investigation is that Tsui may have been, in the local vernacular, "done in for a debt"?

No answer.

Can you confirm that it was a breach of police orders for Leung to have gone to investigate a noise complaint in Lei Muk Shue by himself? Can you also confirm that the person who shot him was left-handed? There is nothing whatsoever to suggest that the late constable had done anything in breach of police orders while he was investigating the noise complaint on March 14, 2001.

Can you confirm that in 2000 or 2001, an investigation carried out by the Criminal Intelligence Bureau – which began by looking at soccer betting out of Ngau Tau Kok police station – was subsequently dropped after it exposed a much wider problem of soccer gambling within the force?

No answer.

Can you also confirm that the police have in their possession surveillance-video footage of Hong Kong police officers conducting soccer-betting-related transactions or meetings in Macau, and that much of this illicit business is carried out in Macau?

No answer.

At present, police officers are required to fill out a form recording any trip they make to Macau. Can you confirm that after April 1 this year, they will no longer be required to do so? How will the system change?

The notification requirement for private visits to Macau will be suspended with effect from April 1, 2006.

When will the funeral of Tsui be held, and has his body been released to his family?

No answer

Can you also confirm or deny that Tsui was either the sole proprietor or owner of two flats in Hong Kong?

No answer.

Have any senior police officers visited or been in contact with Tsui's widow to explain what impact her husband's death will have on her pension rights?

Officers from the Police Welfare Branch have been in contact with Tsui's family and will provide assistance wherever appropriate and necessary.

議員促獨立調查免各方揣測 一哥指「警魔」無涉賭波黨

尖沙嘴殺警搶槍案至今已十三日，警方仍追查「警魔」徐步高背景及財務狀況資料。警務處處長李明達昨表示，警方會盡快完成調查報告，呈交死因庭處理。立法會議員涂謹申則促請死因裁判官對此案進行獨立調查，以免社會諸多揣測。

涉嫌殺警搶槍的徐步高，被傳生前與賭波集團有關，昨出席一個保安會議的警隊「一哥」李明達指出，沒有證據顯示案件與賭波集團有關，警方會盡快把案件交由死因庭審理，由於將呈死因庭研究，故不宜透露太多。

疑徐用家人戶口行事

警方消息稱，負責調查尖沙嘴殺警搶槍案的「O記」探隊，已完成初步的調查工作，惟仍欠部分關於徐步高的財政資料，整個調查報告料下月初完成後才呈交死因庭。消息又稱，曾任職股票經紀的徐步高，一直在力寶證券行擁有一個投資戶口，而直到他死前數個月，仍有人透過該戶口進行交易。

另外，徐步高生前亦購買有人壽保險，保金超過一百萬元，警方相信徐的妻子及家人，對於徐步高在外一些事並不知情，當中不排除他瞞着家人，借用他們的戶口為非作歹，故亦會向其家人的財政及戶口結存狀況，作出調查。

立法會保安事務委員會主席涂謹申表示，外間對徐步高殺警案太多存疑，弄得謠言滿天，為了令調查結果公正，涂謹申昨已去信保安局局長李少光，了解該案的調查進度。

涂謹申說，根據死因裁判官條例，凡因罪行或懷疑罪行所導致的死亡，須提交死亡報告，且警務人員在履行職責過程中死亡，死因裁判官有權就案件作出研訊及調查，惟研訊的範圍較狹窄，多集中在死者身分、何時死、在那兒死作研討，倘死因裁判官對個案作調查，可就案件的原因及與該宗死亡個案有關情況作調查，則較全面，故涂謹申去信希望得悉死因裁判官至現時為止，有否就是次殺警案作調查或決定何時研訊。

警曾調查內部賭波黨

今次事件眾說紛紜，涂謹申綜合各方謠言，認為影響至深的是賭波問題，他非常關注賭波問題充斥警務人員中，既然死因裁判官有權要求進行獨立調查，委派警務人員以外人士協助調查事件，故涂認為採獨立調查為上策。

消息稱，警方刑事情報科確實曾調查警隊內一個賭波集團，當中有人專門收受同袍波纜投注，警方更曾將一批警務人員列為調查對象。不過，警務處處長李明達昨表示，沒有證據顯示徐步高案與賭波集團有關。

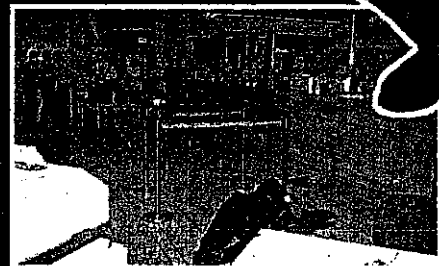

【本報訊】立法會保安事務委員會將於周五召開特別會議，跟進尖沙咀殺警案最新進展，並要求警方交代案中的多個疑點。該會主席涂謹申不排除立法會主動介入了解該事件。

要求警方交代案中疑點

涂謹申表示，目前仍未知委員會各委員提問的內容，但相信除了要求警方交代調查的最新進展外，亦會就休班警員徐步高的背景及在案中的角色提出質詢，當中包括警方為何在梁成恩槍殺案發生五年以來，從沒有發現徐步高與多宗嚴重罪案有關；警方憑甚麼證據相信今

次殺警案中不涉及第四者；警方指徐步高案件並不涉及賭波集團是基於哪些證據等。

涂謹申指出，由於事件受到社會關注，故認為委員會有必要跟進，委員會召開會議前已徵詢過立法會法律顧問的意見，認為此舉並不會影響警方和日後死因庭對案件展開的調查。

至於立法會會否成立委員會介入調查，傳召相關官員出席會議，涂謹申表示現階段不能排除這個可能性，但日後是否展開調查則由議員集體決定，同時須先得到保安事務委員會通過動議，再交例會討論，經一切通過後才能付諸實行。

徐步高如何懂左右手開槍？

議員促交代殺警案8疑團

警務處助理處長李家超曾就事件兩度會見記者，力陳徐步高與梁成恩被殺案，以及麗城花園恒生銀行劫殺案有關，但有關案件案發經過及徐的犯案動機等疑點，警方至今仍未交代。

立法會保安事務委員會主席涂謹申表示，他上周曾諮詢過立法會法律顧問意見，認為召開特別會議不會妨礙死因裁判庭研訊尖沙嘴槍擊案，他直言，這宗案件案情複雜及嚴重，案中仍有不少疑點未解開，亦有不少傳聞，包括事件是否涉及賭波問題；徐步高是否唯一疑兇；徐被指企圖搶奪兩支警槍有何目的等。

「佢喺邊度有機會練習」

涂謹申說：「警方有乜證據證明到徐步高可以識左右手揸槍，因而證明話佢係殺梁成恩同巴籍護衛嘅兇手？如果徐步高識左右手揸槍，佢又喺邊度有機會練習？除咗呢點外，警方仲有乜嘢其他證據證明徐步高係兇手？」

他稱，該委員會已去信要求警方交代有關調查進展，以及警方掌握的證據等資料，「我哋仲要求警方就否認坊間嘅有關報道，例如話單案涉及警隊內

部賭波，警方話無關，咁佢哋要提出證據證明點解會有呢個結論。」

涂謹申又已去信保安局局長李少光，了解死因庭會否展開詳細調查，而不單是一般的研訊。據知，政府已去信法院作進一步了解。而死因庭若不展開詳細調查，立法會則考慮設立專責委員會調查事件。

公民黨立法會議員湯家驊亦指出，由於事件仍有很多疑點，疑兇又為警務人員，是一宗非常重要的案件，而且死因裁判庭只會集中研究案中死者的死因，「死因庭唔會特別研究埋其他案中疑點同警隊內部問題，好似警方同坊間就案情所講嘅版本唔同，我覺得立法會必須跟進警方係咪仲有嘢未公開。」

傳聞太多 望釋公眾疑慮

民建聯立法會議員劉江華坦言，案件涉及警隊內有害群之馬，而且有太多傳聞，他期望警方能藉今次會議詳細交代案件的調查進展，以釋公眾疑慮。

至於會否支持立法會設專責委員會獨立調查事件，劉江華指，目前言之尚早，一切視乎警方屆時的回覆才作決定。

殉職警員曾國恒明舉殯

【本報訊】在尖沙嘴殺警案中英勇殉職的警員曾國恒，其家人今晚在紅磡世界殯儀館為他設靈，明日舉殯。喪禮會以警隊最高榮譽禮儀式舉行，遺體稍後安葬於和合石浩園。與五年前殉職的警員梁成恩長眠為伴。

據悉，曾國恒的喪禮將分為兩部份，包括「

宗教儀式及警隊禮禮，喪禮完畢後，會在地庫舉行安葬儀式。至於梁成恩的遺體，據悉亦會於稍後時間出殯，但其家人未向外界透露喪禮安排。

昨日，仍有市民在殺警案現場拜祭「恒仔」，其中一名父親帶著即將在警察訓練學校

畢業的兒子前來，父親表示，希望兒子能像曾國恒一樣成為一名好警察。

另外，關注私隱權利民間聯席約十名成員昨日發起遊行，途經尖沙嘴警署及柯士甸道行人路遺案現場，請願人士在立法會議員「長毛」梁國雄帶領下，手持字個寫上「投訴警察課千古」的神主牌，沿途高呼「自己人查自己人」、「搵鬼信」等口號，抗議警監會早前監
