RE: Views regarding the Proposed Amendments to the Prevention of Cruelty to Animals Ordinance (Cap. 169) [Ref. CB(2) 1663/05-06(07)]

With reference to your bureau's intending to amend the Prevention of Cruelty to Animals Ordinance (Cap. 169) for the purpose of raising the existing penalty on abusing animals, I would like to express my sincere appreciation.

As 'Animals are important companions to people and they should be respected', please also consider having an amendment to the penalty level of the Dogs and Cats Ordinance (Cap. 167) and the Dogs and Cats Regulations (Cap. 167A) to effectively stop the acts of human's EATING 'our companions'.

The level of fines in the Dogs and Cats Regulations (Cap. 167A) is as obsolete as that in the Prevention of Cruelty to Animals Ordinance (Cap. 169) and it can no longer reflect the seriousness of cruelty to domestic pets as well. In accordance with the laws, 'slaughter of dog or cat for food is prohibited and any person who contravenes such regulations shall be liable to a fine of \$5000 and to imprisonment for 6 months' (rr. 22 - 23, Cap. 167A). This is the same as the current level of penalty under section 3 of the Prevention of Cruelty to Animals Ordinance (Cap. 169).

The offences under the above-mentioned enactments should be treated with equal importance as the nature of these crimes is indeed the same – animals' suffering from humans' evil behaviour.

To my knowledge, from the news, a meeting is to be held by the Panel on Food Safety and Environmental Hygiene of the Legislative Council on Tuesday, 11th April 2006, when the proposed amendments to the ordinance are to be discussed. Please have my suggestion seriously considered and, if possible or appropriate, discuss such a matter with those Honourable LegCo Members. Thank you very much for your attention.
