Motion of Thanks

Hon Miriam LAU moved the following motion and addressed the Council:

That this Council thanks the Chief Executive for his address.

Question on the motion proposed. The President stated that Hon LEE Wing-tat and Dr Hon Fernando CHEUNG would move amendments to the motion and that Hon TAM Heung-man would also move an amendment to Hon LEE Wing-tat's amendment. In accordance with the Rules of Procedure, the motion, the two amendments and the amendment to the amendment would be debated together in a joint debate.

The President announced the commencement of the first debate session, which covered the following policy areas: administration of justice and legal services, constitutional affairs, public service and security.

Nine Members and Dr Hon YEUNG Sum spoke.

While Dr Hon YEUNG Sum was speaking, the President left the chair at 1:32 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another four Members and Hon TAM Yiu-chung spoke.

At 2:27 pm, while Hon TAM Yiu-chung was speaking, the President resumed the chair.

22 further Members spoke.

At 7:15 pm, the President suspended the meeting for ten minutes.

The Council resumed at 7:25 pm.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

The Chief Secretary for Administration spoke. While he was speaking, the President left the chair at 7:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

The Secretary for Constitutional Affairs and the Secretary for the Civil Service spoke.

At 8:04 pm, while the Secretary for the Civil Service was speaking, the President resumed the chair.

The Secretary for Security and the Secretary for Justice spoke.

The President announced the end of the first debate session and suspended the meeting at 8:34 pm.

While Hon TAM Heung-man was speaking, the President left the chair at 12:38 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another two Members and Dr Hon Philip WONG spoke.

At 1:30 pm, while Dr Hon Philip WONG was speaking, the President resumed the chair.

12 further Members spoke.

At 3:51 pm, the President suspended the meeting for ten minutes.

The Council resumed at 4:01 pm.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

The Financial Secretary, the Secretary for Financial Services and the Treasury, the Secretary for Commerce, Industry and Technology, the Secretary for Constitutional Affairs and the Secretary for Economic Development and Labour spoke.

The President announced the end of the second debate session and the commencement of the third debate session, which covered the following policy areas: education, home affairs and manpower planning.

Five Members spoke.

Hon Tommy CHEUNG declared his interest as an appointed Member of Eastern District Council and spoke.

Another three Members and Dr Hon Joseph LEE Kwok-long spoke.

While Dr Hon Joseph LEE Kwok-long was speaking, the President left the chair at 6:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another five Members spoke.

At 6:59 pm, the President's Deputy suspended the meeting for ten minutes.

The Council resumed at 7:09 pm and the President resumed the chair.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

The Secretary for Education and Manpower and the Secretary for Home Affairs spoke.

The President announced the end of the third debate session and the commencement of the fourth debate session, which covered the following policy areas: housing, planning, lands and works, environmental affairs and transport.

14 Members spoke.

The President suspended the meeting at 9:27 pm.

Noting the absence of a quorum, the President directed the Clerk to summon Members to the meeting. A quorum was then present.

The Secretary for Housing, Planning and Lands and the Secretary for the Environment, Transport and Works spoke.

The President announced the end of the fourth debate session and the commencement of the fifth debate session, which covered the following policy areas: food safety and environmental hygiene, health services and welfare services.

Two Members and Hon Andrew CHENG spoke.

While Hon Andrew CHENG was speaking, the President left the chair at 12:30 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Another four Members and Hon WONG Yung-kan spoke.

At 1:47 pm, while Hon WONG Yung-kan was speaking, the President resumed the chair.

17 more Members spoke.

At 4:16 pm, the President suspended the meeting for ten minutes.

The Council resumed at 4:26 pm.

The Financial Secretary and the Secretary for Health, Welfare and Food spoke.

The President announced the end of the fifth debate session.

Hon Miriam LAU spoke on the amendments.

Hon LEE Wing-tat moved the following amendment to Hon Miriam LAU's motion:

To add "and, at the same time, urges the Chief Executive and the Government to expeditiously propose a timetable for the election of the Chief Executive and all members of the Legislative Council by universal suffrage, and to put forward concrete proposals on the relevant democratization processes including the abolition of the appointed and ex-officio seats in district councils, cancelling corporate votes in functional constituencies of the Legislative Council as well as expanding the electorate base and democratic elements in the Election Committee, so as to respond to the public's strong aspirations for democratic elections by universal suffrage and the establishment of an accountable government" after "his address".

Question on Hon LEE Wing-tat's amendment to Hon Miriam LAU's motion proposed.

Hon TAM Heung-man moved the following amendment to Hon LEE Wing-tat's amendment:

To delete "and, at the same time" after "the Chief Executive for his address"; to add "but as the proposed methods regarding constitutional development set out in the Fifth Report of the Constitutional Development Task Force, which the Chief Executive called on the community and this Council to support, fail to take democracy forward to meet the public's aspirations for elections by universal suffrage, this Council will not support them and" before "urges the Chief Executive"; and to add "and a roadmap" after "propose a timetable".

Question on Hon TAM Heung-man's amendment to Hon LEE Wing-tat's amendment proposed and put.

Hon Emily LAU claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, seven were in favour of the amendment, 19 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 15 were in favour of the amendment and 14 against it. (Voting record in Appendix I.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion or amendments thereto on "Motion of Thanks", the

Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed.

A Member spoke on the motion.

Question on the motion put and agreed to.

Question on Hon LEE Wing-tat's amendment to Hon Miriam LAU's motion put.

Hon SIN Chung-kai claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, seven were in favour of the amendment, 19 against it and two abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 30 were present, 14 were in favour of the amendment, 14 against it and one abstained. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Dr Hon Fernando CHEUNG moved the following amendment to Hon Miriam LAU's motion:

To add ", but as the address is inadequate regarding the effort to help the poor and fails to respond to the aspirations of the public, this Council expresses deep regret and urges the Chief Executive to expeditiously formulate a comprehensive policy on poverty alleviation so as to narrow the gap between the rich and the poor" after "his address".

Question on Dr Hon Fernando CHEUNG's amendment to Hon Miriam LAU's motion proposed and put.

Dr Hon Fernando CHEUNG claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, five were in favour of the amendment, 22 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 30 were present, 16 were in favour of the amendment, 12 against it and one abstained. (Voting record in Appendix III.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

Hon Miriam LAU replied.

Question on Hon Miriam LAU's motion put.

Hon Emily LAU claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 28 were present, 20 were in favour of the motion, seven against it and one abstained; while among the Members returned by geographical constituencies through direct elections and by the Election Committee, 30 were present, 11 were in favour of the motion and 18 against it. (Voting record in Appendix IV.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the motion was negatived.
