The Secretary for Health, Welfare and Food moved the following motion and addressed the Council:

Resolved that the following Regulations, made by the Pharmacy and Poisons Board on 19 January 2006, be approved -

- (a) the Pharmacy and Poisons (Amendment) Regulation 2006; and
- (b) the Poisons List (Amendment) Regulation 2006.

Question on the motion proposed, put and agreed to.

## Members' Motions

### Implementing the recommendations in the Report on Working Poverty by the Subcommittee to Study the Subject of Combating Poverty

Hon Frederick FUNG moved the following motion and addressed the Council:

That this Council endorses the Report on Working Poverty by the Subcommittee to Study the Subject of Combating Poverty, and urges the Government to implement the recommendations therein.

While Hon Frederick FUNG was addressing the Council, the President left the chair at 1:31 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on the motion proposed.

Five Members spoke on the motion.

After declaring that she was a member of Subcommittee to Study the Subject of Combating Poverty and a member of the Commission on Poverty, Hon LI Fung-ying spoke on the motion.

Another Member and Dr Hon Joseph LEE Kok-long spoke on the motion.

At 2:34 pm, while Dr Hon Joseph LEE Kok-long was speaking, the President resumed the chair.

Another six Members spoke on the motion.

After declaring that she was a member of Subcommittee to Study the Subject of Combating Poverty, Hon CHAN Yuen-han spoke on the motion.

Three more Members and the Financial Secretary spoke on the motion.

Hon Frederick FUNG replied.

Question on the motion put and agreed to.

### **Opening up the electricity market**

Hon Albert CHAN moved the following motion and addressed the Council:

That, as the electricity market in Hong Kong is currently monopolized by two power companies, prejudicing consumers' interests, this Council demands that the Government implement the following measures to ensure that Hong Kong's electricity market is free from monopoly, so that the people of Hong Kong can enjoy reasonable electricity supply services:

- (a) lowering the permitted return allowed to the power companies in respect of their electricity-related operations for each year from the current 13.5% of their average net fixed assets to 7% or below;
- (b) strengthening the regulation of power plants to ensure that their operations and emissions comply with the relevant environmental protection standards, and formulating practicable measures to ensure that the power companies actively develop renewable energy;
- (c) opening up the electricity market in the coming 10 years, so as to introduce competition and break the current monopoly of Hong Kong's electricity market by the two companies; and
- (d) requesting the CLP Power Hong Kong Limited to offer rebates to its customers by the year 2008 using funds from its Development Fund.

Question on Hon Albert CHAN's motion proposed.

The President stated that Hon Andrew LEUNG Kwan-yuen, Hon TAM Heung-man and Hon KWONG Chi-kin would move amendments to the motion. In accordance with the Rules of Procedure, the motion and the three amendments would be debated together in a joint debate.

Hon Andrew LEUNG Kwan-yuen, Hon TAM Heung-man, Hon KWONG Chi-kin and 20 Members spoke on the motion and the amendments.

Hon Albert CHAN spoke on the amendments.

The Secretary for Economic Development and Labour spoke on the motion and the amendments.

Hon Andrew LEUNG Kwan-yuen moved the following amendment to Hon Albert CHAN's motion:

To delete ", as" after "That" and substitute with "this Council urges the Government to earnestly improve the current phenomenon of natural monopoly in"; to delete "is currently monopolized by two power companies" after "electricity market in Hong Kong"; to add "so as to avoid" before "prejudicing consumers' interests,"; to delete "this Council" after "prejudicing consumers' interests," and substitute with "and"; to delete "reasonable" after "Hong Kong can enjoy" and substitute with "reasonably-charged, safe and stable"; to add "re-setting electricity tariffs at a reasonable level by" after "(a)"; to delete "emissions" after "their operations and" and substitute with "the pollutants emitted"; to add "as well as providing proper incentives" after "formulating practicable measures"; to add "setting a timetable for" after "(c)"; to add "in Hong Kong and aiming for its implementation" after "opening up the electricity market"; to add "natural" after "break the current"; to delete "and" after "by the two companies,"; to add "in proportion to their electricity consumption" after "offer rebates to its customers"; and to add "; and (e) actively studying the full implementation of power interconnection" after "using funds from its Development Fund".

Question on Hon Andrew LEUNG Kwan-yuen's amendment to Hon Albert CHAN's motion proposed and put.

Hon James TIEN claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 17 were in favour of the amendment, four against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 28 were present, 26 were in favour of the amendment and one abstained. (Voting record in Appendix I.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion or amendments thereto on "Opening up the electricity market", the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

The President stated that as Hon Andrew LEUNG Kwan-yuen's amendment had been agreed, she granted leave for Hon TAM Heung-man to revise the terms of her amendment and explain them to the Council.

Hon TAM Heung-man moved the following further amendment to Hon Albert CHAN's motion as amended by Hon Andrew LEUNG Kwan-yuen and explained the revised terms of her amendment to the Council:

To delete "and" after "its Development Fund;"; and to add ", expeditiously discussing with the Guangdong Provincial Government the implementation of interconnection, and opening up the transmission network to new electricity suppliers; (f) formulating policy incentives to ensure that the power companies progressively relinquish coal-fired power generation, and actively develop emissions reduction facilities; and (g) conducting studies on the long-term development of those industries engaged in the unbundling of generation, transmission and distribution of electricity" after "full implementation of power interconnection".

Question on Hon TAM Heung-man's amendment to Hon Albert CHAN's motion as amended by Hon Andrew LEUNG Kwan-yuen proposed and put.

Hon Mrs Selina CHOW claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, one was in favour of the amendment, 20 against it and one abstained; while among the Members returned by geographical constituencies through direct elections, 28 were present, three were in favour of the amendment, 23 against it and one abstained. (Voting record in Appendix II.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The President stated that as Hon Andrew LEUNG Kwan-yuen's amendment had been agreed, she granted leave for Hon KWONG Chi-kin to revise the terms of his amendment and explain them to the Council.

Hon KWONG Chi-kin moved the following further amendment to Hon Albert CHAN's motion as amended by Hon Andrew LEUNG Kwan-yuen and explained the revised terms of his amendment to the Council:

To delete "and" after "its Development Fund;"; and to add "; and (f) requesting that the two power companies shall ensure the stability of their workforce, and recruit their technical staff at all levels in a planned manner and provide them with continuing training, so as to secure a reliable and stable supply of electricity" after "implementation of power interconnection".

Question on Hon KWONG Chi-kin's amendment to Hon Albert CHAN's motion as amended by Hon Andrew LEUNG Kwan-yuen proposed, put and agreed to.

Hon Albert CHAN replied.

Question on Hon Albert CHAN's motion as amended by Hon Andrew LEUNG Kwan-yuen and Hon KWONG Chi-kin put.

Hon Albert CHAN claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 16 were in favour of the motion and five against it; while among the Members returned by geographical constituencies through direct elections, 29 were present and 28 were in favour of the motion. (Voting record in Appendix III.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion as amended by Hon Andrew LEUNG Kwan-yuen and Hon KWONG Chi-kin was carried.

### **Reducing the salaries tax**

Hon SIN Chung-kai moved the following motion and addressed the Council:

That, in view of the continuous recovery of Hong Kong's economy and the improved government finances, this Council urges the Government to make appropriate use of its resources to provide the grass-roots people with adequate services, and to reduce the salaries tax so as to alleviate the tax burden on the middle class and the grass-roots people, thereby stimulating consumer spending and creating jobs.

While Hon SIN Chung-kai was addressing the Council, the President left the chair at 7:21 pm temporarily and the President's Deputy, Hon Miriam LAU, took the chair.

Question on Hon SIN Chung-kai's motion proposed.

The President's Deputy stated that Hon James TIEN, Hon CHAN Kam-lam, Hon WONG Kwok-hing, Dr Hon Fernando CHEUNG and Hon TAM Heung-man would move amendments to the motion and that Hon James TO would also move an amendment to Hon CHAN Kam-lam's amendment. In accordance with the Rules of Procedure, the motion, the five amendments and the amendment to the amendment would be debated together in a joint debate.

Hon James TIEN and Hon CHAN Kam-lam spoke on the motion and the amendments.

At 7:47 pm, while Hon CHAN Kam-lam was speaking, the President resumed the chair.

Hon WONG Kwok-hing, Dr Hon Fernando CHEUNG, Hon TAM Heung-man, Hon James TO and 19 other Members spoke on the motion and the amendments.

Hon SIN Chung-kai spoke on the amendments.

The Secretary for Financial Services and the Treasury spoke on the motion and the amendments.

Hon James TIEN moved the following amendment to Hon SIN Chung-kai's motion:

To delete "in view of" after "That," and substitute with "as the Treasury of the Government has benefited from"; to delete "and the improved government finances" after "Hong Kong's economy" and substitute with ", which has improved the Government's financial position and will likely advance the elimination of the fiscal deficit"; to add "rates of" after "and to reduce the"; and to add "by reverting them to at least the 2002-03 level," after "salaries tax".

Question on Hon James TIEN's amendment to Hon SIN Chung-kai's motion proposed and put.

Hon James TIEN claimed a division. The President then ordered the Council to divide under Rule 47(1) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 21 were present, 14 were in favour of the amendment, four against it and three abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 13 were in favour of the amendment, five against it and five abstained. (Voting record in Appendix IV.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the amendment was agreed.

Hon Miriam LAU rose to move the following motion without notice:

That in the event of further divisions in relation to the motion or amendments thereto on "Reducing the salaries tax", the Council do proceed to each of such divisions after the division bell has been rung for one minute.

Question on the motion proposed, put and agreed to.

The President stated that as Hon James TIEN's amendment had been agreed, she granted leave for Hon CHAN Kam-lam to revise the terms of his amendment and explain them to the Council.

Hon CHAN Kam-lam moved the following further amendment to Hon SIN Chung-kai's motion as amended by Hon James TIEN and explained the revised terms of his amendment to the Council:

To add "; to revert the personal allowances and the marginal tax bands to the 2002-03 level; to raise the child allowance and the allowances for dependent parent/grandparent; to further increase the entitlement period and the amount of home loan interest deduction; and to introduce tax deduction for voluntary contributions to the Mandatory Provident Fund" after "2002-03 level".

Question on Hon CHAN Kam-lam's amendment to Hon SIN Chung-kai's motion as amended by Hon James TIEN proposed.

Hon James TO moved the following amendment to Hon CHAN Kam-lam's amendment:

To delete "introducing tax deduction for" after "(d)" and substitute with "studying allowing"; and to add "to be tax deductible up to a ceiling" after "Mandatory Provident Fund".

Question on Hon James TO's amendment to Hon CHAN Kam-lam's amendment proposed, put and agreed to.

Question on Hon CHAN Kam-lam's amendment, as amended by Hon James TO, to Hon SIN Chung-kai's motion which had been amended by Hon James TIEN, put and agreed to.

The President stated that Hon WONG Kwok-hing had indicated that he would withdraw his amendment if Hon CHAN Kam-lam's amendment was agreed. Hon WONG Kwok-hing had therefore withdrawn his amendment.

The President stated that as the amendments moved by Hon James TIEN, Hon CHAN Kam-lam and Hon James TO had been agreed, she granted leave for Dr Hon Fernando CHEUNG to revise the terms of his amendment and explain them to the Council.

Dr Hon Fernando CHEUNG moved the following further amendment to Hon SIN Chung-kai's motion as amended by Hon James TIEN, Hon CHAN Kam-lam and Hon James TO and explained the revised terms of his amendment to the Council:

To add "; the services provided by the Government to the grass-roots people should include: (a) increasing the medical waivers for the elderly, the vulnerable, the disabled, the chronically ill and the poor families; (b) reverting the Comprehensive Social Security Assistance rates for the elderly, the vulnerable, the disabled and the children to the levels prior to their reduction in 2003; (c) reverting the rates of Disability Allowance to the levels prior to their reduction in 2003; (d) freezing the charges for all livelihood-related items, including medical and educational fees; (e) increasing the financial commitments for medical services, education and social welfare; and (f) increasing the financial commitments for leisure and cultural facilities in new towns, e.g. libraries, swimming pools, sports centres and sportsgrounds" after "creating jobs".

Question on Dr Hon Fernando CHEUNG's amendment to Hon SIN Chung-kai's motion as amended by Hon James TIEN, Hon CHAN Kam-lam and Hon James TO proposed and put.

Hon Albert CHAN claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, eight were in favour of the amendment, 12 against it and two abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 18 were in favour of the amendment and five against it. (Voting record in Appendix V.) Since the question was not agreed by a majority of each of the two groups of Members present, she declared that the amendment was negatived.

The President stated that Hon TAM Heung-man had indicated that she would withdraw her amendment if any of the amendments to the motion was agreed. Hon TAM Heung-man had therefore withdrawn her amendment.

Hon SIN Chung-kai replied.

Question on Hon SIN Chung-kai's motion as amended by Hon James TIEN, Hon CHAN Kam-lam and Hon James TO put.

Hon Emily LAU claimed a division. The President then ordered the Council to divide under Rule 49(5) of the Rules of Procedure.

The President announced that among the Members returned by functional constituencies, 22 were present, 14 were in favour of the motion, four against it and four abstained; while among the Members returned by geographical constituencies through direct elections, 24 were present, 13 were in favour of the motion, five against it and five abstained. (Voting record in Appendix VI.) Since the question was agreed by a majority of each of the two groups of Members present, she declared that the motion as amended by Hon James TIEN, Hon CHAN Kam-lam and Hon James TO was carried.
