Project code	Project description	Recommendation
688CL PWSC(2005-06)40 (Head 705)	Site formation for primary school at Inverness Road, Kowloon City	To recommend to Finance Committee the upgrading of 688CL to Category A at an estimated cost of \$42.2 million in money-of-the-day prices to carry out the site formation and associated infrastructure works for the primary school development at Inverness Road, Kowloon City.
112CD PWSC(2005-06)41 (Head 704)	Drainage improvement in Northern New Territories – package A	To recommend to Finance Committee – (a) the upgrading of part of 112CD , as 145CD , entitled “Upgrading of stormwater drains in Sheung Shui and Fanling”, to Category A at an estimated cost of \$92.2 million in money-of-the-day prices; and (b) the retention of the remainder of 112CD in Category B.
330WF PWSC(2005-06)42 (Head 709)	Remedial works for the rip-rap at the main dam of Plover Cove Reservoir	To recommend to Finance Committee the upgrading of 330WF to Category A at an estimated cost of \$51.4 million in money-of-the-day prices for carrying out remedial works to the main dam of Plover Cove Reservoir.
37EC PWSC(2005-06)43 (Head 708)	A private independent school (secondary-cum-primary) in Area N4b, Discovery Bay	To recommend to Finance Committee the upgrading of 37EC to Category A at an estimated cost of \$137.0 million in money-of-the-day prices for the construction of a private independent school comprising a 30-classroom secondary section and an 18-classroom primary section in Area N4b, Discovery Bay.

29LJ PWSC(2005-06)44 (Head 703)	Relocation of Labour Tribunal to the South Kowloon Law Courts Building	To recommend to the Finance Committee the upgrading of 29LJ to Category A at an estimated cost of \$67.1 million in money-of-the-day prices for the relocation of the Labour Tribunal to the South Kowloon Law Courts Building at Yaumatei.
