Supplementary Appropriation (2005-06) Bill

I refer to the attached letter from the Clerk to the Bills Committee of the captioned Bill advising us that the matter will be referred to the House Committee for consideration at its meeting on 7 July 2006.

In case the House Committee agrees at the meeting that the Bills Committee will not be formed and that the Second Reading debate on the Bill could be resumed, it is our intention to seek the President's approval to waive the 12 clear days' notice requirement so that the Bill could resume the Second Reading debate at the last scheduled meeting of this legislative session on 12 July. We hope the House Committee could support this proposal as the Bill is non-controversial and it is preferable to complete the legislative process within this session.
