(1) The appeal board may, by notice under the signature of the chairman-

- (a) order a person to attend before the board and give evidence;
- (b) order a person to produce documents;
- (c) authorize a person to inspect an electrical installation; or
- (d) authorize a person to inspect an electrical product and for that purpose authorize entry to premises, other than domestic premises, where an electrical product is exhibited or kept for the purpose of sale or hire.

(2) The appeal board may-

- (a) confirm or revoke the decision or action of the Director or decision of the disciplinary tribunal;
- (b) make any decision that the Director or disciplinary tribunal could have made;
- (c) order the Director to take any action within his powers, including an order to return an electrical product seized under section 25(2); or (Amended 12 of 1997 s. 8)
- (d) in an appeal from a decision of the Director to impose a fine or reprimand under section 36(1), do anything that the disciplinary tribunal may do under section 41 (2).

(3) The appeal board may make any order it thinks fit with regard to the payment of costs of the proceedings under this section and the costs of the Director or of any person in respect of whom the proceedings are brought.

(4) The appeal board shall notify the appellant and the Director of its decision and the reasons for it.

(5) A fine imposed under this section and costs awarded or imposed under this section are recoverable as a civil debt.

and a person who fails or refuses to comply with an order of the Appeal Board made under this subsection commits an offence.

(2) The Appeal Board may-

- (a) confirm or revoke the decision or action of the Commissioner;
- (b) make any decision that the Commissioner could have made; or
- (c) order the Commissioner to take any action within his powers.

(3) The Appeal Board may make any order it thinks fit with regard to the payment of costs of proceedings under this section and the costs of the Commissioner or of any person in respect of whom the proceedings are brought.

(4) The Appeal Board shall notify the appellant and the Commissioner of its decision and the reasons for it.

(5) Costs awarded or imposed under this section are recoverable as a civil debt.

(1) The appeal board shall conduct a hearing into the grounds for the Director's decision to which the appeal before it relates.

(2) Where a member of the appeal board is in any way directly or indirectly interested in any appeal-

- (a) he shall disclose the nature of his interest at a meeting of the appeal board;
- (b) the disclosure shall be recorded in the minutes of the appeal board; and
- (c) he shall not, without the permission of the chairman of the appeal board, take any part in any deliberation or determination of the appeal board in respect of that appeal.

(3) Where the chairman of an appeal board does not permit a member of the appeal board who has made a disclosure under subsection (2) to take any part in any deliberation or determination of the appeal board in respect of the appeal to which that disclosure relates, the member shall not be counted for the purpose of forming a quorum of the appeal board at any hearing of that appeal.

(4) For the purposes of subsection (1), the appeal board hearing an appeal shall have all the powers of the Director in respect of the decision of the Director against which the appeal is made, and shall determine the appeal by an order in writing-

- (a) confirming or revoking;
- (b) varying in such manner as it thinks fit; or
- (c) substituting its own decision for,

such decision.

(5) The Director shall do all such things as are necessary to give effect to an order under subsection (4).

(6) The appeal board may in an order under subsection (4) give such directions as it thinks fit with respect to the costs of the hearing of the appeal to which the order relates and the costs of the Director or of the appellant.

(7) Any costs awarded or imposed by virtue of any directions referred to in subsection (6) are recoverable as a civil debt.
