To

Amend the City University of Hong Kong Ordinance.

Enacted by the Legislative Council.

**1. Short title and commencement**

(1) This Ordinance may be cited as the City University of Hong Kong (Amendment) Ordinance 2006.

(2) This Ordinance shall come into operation on <sup>1</sup>January 2007.

2. Interpretation

In this Ordinance, unless the context otherwise requires—

- "Chancellor" (監督) means the Chancellor of the University established by section 4 and includes a person acting as the Chancellor;
- "Convocation" (評議會) means the Convocation of the University established by section 17B;
- "Council" (校董會) means the Council of the University established by section 9;
- "Court" (顧問委員會) means the Court of the University established by section 8A;
- "Deputy President" (常務副校長) means the Deputy President of the University appointed under section 14 and includes a person acting as the Deputy President; (*Added 23 of 2002 s. 68*)
- "faculty" (學院) means a faculty of the University established under section 17A and includes an equivalent body established under that section;
- "President" (校長) means the President of the University appointed under section 14 and includes a person acting as the President; (*Added 23 of 2002 s. 68*)
- "Pro-Chancellor" (副監督) means the Pro-Chancellor of the University appointed under section 4(4) and includes a person acting as the Pro-Chancellor;
- "Senate" (教務會) means the Senate of the University established by section 17;
- "statutes" (規程) means the statutes of the University made by the Council under section 21A;
- "University" (大學) means the City University of Hong Kong established by section 3;
- ~~"Vice-President" (副校長) means the Vice-President of the University appointed under section 14(1)(c) and includes a person acting as a Vice-President.~~

## 10. Membership of the Council

(1) The Council shall consist of the following members—

- (a) the President; (*Amended 23 of 2002 s. 72*)  
 (b) the Deputy President; (*Amended 23 of 2002 s. 72*)  
 (c) ~~not more than 4 Vice Presidents nominated by the President and appointed by the Council;~~ (*Replaced 23 of 2002 s. 72*)  
 (d) not more than 5 Deans of faculties or such office holders in an equivalent body of the University nominated by the Senate and appointed by the Council; (*Replaced 23 of 2002 s. 72*)  
 (e) ~~not more than 3 public officers appointed by the Chief Executive;~~  
 (f) ~~not more than 18 members who are not public officers or employees of the University of whom—~~  
 (i) not less than 10 have experience in commerce or industry in Hong Kong;  
 (ii) not more than 9 are appointed by the Chief Executive on the recommendation of the Council;  
 (iii) ~~9 are appointed by the Chief Executive;~~  
 (g) an academic member of the Senate nominated by the Senate and appointed by the Council; (*Amended 23 of 2002 s. 72*)  
 (h) ~~2 members of staff elected from among their number and appointed by the Council;~~ (*Amended 23 of 2002 s. 72*)  
 (i) ~~the Chairman of the Convocation; and~~  
 (j) ~~the President of the Students' Union.~~ (*Replaced 92 of 1994 s. 14*)
- (2) (a) The Chief Executive shall appoint from the members appointed under subsection (1)(f)— (*Amended L.N. 395 of 1983; 92 of 1994 s. 14*)  
 (i) 1 member as Chairman;  
 (ii) 1 member as Deputy Chairman; and  
 (iii) 1 member as Treasurer.  
 (b) The Deputy Chairman shall act as Chairman if the Chairman is absent from Hong Kong or is, for any other reason, unable to act as Chairman.  
 (c) If for any period both the Chairman and the Deputy Chairman are unable by reason of absence from Hong Kong or incapacity to perform the functions of their respective offices, or if for any period both of those offices are vacant, the members may appoint one of the members appointed under subsection (1)(f) to act as Chairman during that period.  (i) not more than 8 are appointed by the Chief Executive on the recommendation of the Council; and  
 (ii) 7 are appointed by the Chief Executive;
- \* (h) 1 member of staff elected from among their number and appointed by the Council; and
- (j) 1 student elected from among students and appointed by the Council.

- (h) 2 members of staff elected from among their number and appointed by the Council; (*Amended 23 of 2002 s. 72*)  
 (i) the Chairman of the Convocation; and  
 (j) the President of the Students' Union. (*Replaced 92 of 1994 s. 14*)

~~(3) A member of the Council appointed under subsection (1)(e) shall hold office at the discretion of the Chief Executive. (Replaced 23 of 2002 s. 72)~~

(3A) A member of the Council appointed under subsection (1)(f)—  
(a) shall be appointed for a period of 3 years or such lesser period as the Chief Executive may in any particular case appoint, but may from time to time be reappointed;  
(b) may at any time by notice in writing to the Chief Executive resign from the Council. (Added 23 of 2002 s. 72)

~~(4) (3B) A member appointed by the Council under subsection (1)(g) or~~

(h)—  
(a) shall be appointed for a period of 3 years or such lesser period as the Council may in any particular case appoint, but may from time to time be reappointed;  
(b) shall cease to be a member of the Council—  
(i) when he ceases to meet the criteria of eligibility for nomination by the body that nominated him; or  
(ii) when he ceases to be a member of the body that elected him;  
(c) may at any time by notice in writing to the Chairman of the Council resign from the Council. (Added 23 of 2002 s. 72)

(4) Upon the expiry of the appointment of any member, other than an ex officio member, whether by effluxion of time or as a result of resignation or otherwise, the procedure for a new appointment, or reappointment, as the case may be, shall be as if the position thus vacated were being filled for the first time.

(5) The provisions of this section are without prejudice to section 42 of the Interpretation and General Clauses Ordinance (Cap. 1). (Added 23 of 2002 s. 72)
