Discussion of the Administration's response to issues raised by deputations /individuals at the meeting on 3 March 2007 [LC Paper No. CB(2)1594/06-07(01)]

2. The Bills Committee completed discussion on "Application to new arrivals from the Mainland" and item (a) under "Criteria for determining "justifiability".

3. Members agreed that the Bills Committee would further discuss -

- (a) issues relating to application of the Bill to new arrivals from the Mainland when detailed response was provided by the Administration; and
- (b) the definition of "race" in Clause 8 during the clause-by-clause examination of the Bill.

4. The Administration was requested -

- (a) to provide the number of cases during the past one year in which the Director of Social Welfare had exercised discretion to waive the residence requirement for the provision of Comprehensive Social Security Assistance;
- (b) to provide information on the public education programmes launched in the past five years to eliminate discriminatory attitude towards new arrivals from the Mainland (including the resources allocated for such programmes) and on the assessment of the effectiveness of such programmes;
- (c) to arrange for the display of the relevant Announcement of Public Interest at the next meeting scheduled for Tuesday, 15 May 2007;
- (d) to explain why the Administration considered that inclusion of new arrivals from the Mainland within the scope of the Bill might adversely affect their integration into Hong Kong whereas granting protection to ethnic minorities by this Bill would not have the same effect; and
- (e) to explain in concrete terms the criteria which should be considered by the public in assessing whether the test of

"justifiability" under Clause 4 would be met and provide the relevant guidelines to be issued to the public after enactment of the Bill.

5. As regards paragraph 4(d), the Chairman requested the Legislative Council Secretariat to gather information on any research findings on whether designating new arrivals from the Mainland as a protected category would or would not marginalise and segregate them from the society.

6. Mr WONG Ting-kwong requested to put on record that it was indisputable that any discrimination against new arrivals from the Mainland was wrong and every effort should be made to render assistance to them. The issue was whether these new arrivals should be included within the scope of the Bill and this view should not be regarded as discrimination against new arrivals from the Mainland.

7. There being no other business, the meeting ended at 10:30 am.

The Administration considered that discrimination encountered by them should be addressed by public education instead of legislation.</p>
