 - (a) to consider amending clause 27 of the Bill to require the Commissioner of Police to provide information or materials relating to a complaint to the Independent Police Complaints Council (IPCC), subject to safeguards against the disclosure of certain information by IPCC; and
 - (b) to consider the suggestion of taking on board all IPCC's proposals to the Bill, unless there were very strong grounds for not doing so.
